Subject: Directions of the Central Government for auction of coal mines under the Coal Mines (Special Provisions) Act, 2015.

The undersigned is directed to say that Rule 8 (2) (a) (i) & Rule 8 (2) (b) of the Coal Mines (Special Provisions) Rules, 2014 provides that the Central Government shall issue an order to the Nominated Authority regarding the manner of allocation of the Schedule I coal mine through public auction under Section 4 or Allotment under Section 5 and the specified end use in case of any Schedule II or Schedule III coal mine of the Coal Mines (Special Provisions) Act, 2015.

2. Accordingly, in pursuance to the above said Act, Rules and with the approval of the competent authority, a list of 13 Schedule II and Schedule III coal mines/blocks is forwarded herewith for conduct of e-auction by the Nominated Authority for the specified end use as per the **Annexure**. The auction process may starts tentatively **from 15.09.2017**.
