### Minutes of the Meeting

A meeting was convened on 04.03.2022 under chairmanship of AS&MN with State Governments of Coal bearing states in which coal mines have been allocated by the Nominated Authority to review the status of payment of royalty and revenue share. State Government representatives of Madhya Pradesh, Telangana, Maharashtra, Jharkhand and Chhattisgarh were present. Director (NA) welcomed all the participants.

2.A brief presentation was made on the amount of Monthly Payment received in current Financial year (2021-22 till Feb 2022) and aggregate monthly payments since production of coal blocks. Inputs were invited from individual states to comment on the data presented.

- 3.Representative of State Governments (Jharkahnd, Chhattisgarh, Maharashtra, Telangana & Madhya Pradesh) informed that the payments are being made at district level and they will collect the details from different districts and will compile the data for the whole State. Presently they have noted down the details from presentation and they will verify this at their end and will submit a detailed response specifying the amount received on account of monthly premium to Nominated Authority on Monday, i.e. 07.03.2021. Further, they desired a copy of presentation to be shared with them.
- 3.AS(MN)/NA assured that the presentation will be shared with State and advised State Government officials to send the mine wise and month wise details of the monthly premium received by them to the office of NA at the earliest so that it can be reconciled with the details available with the office of NA.
- 4. AS also desired NA office to collect the data on regular basis and reconcile concurrently with all the states. Companies which are not paying or short fall in payments should be show casused for taking action by the state governments.
