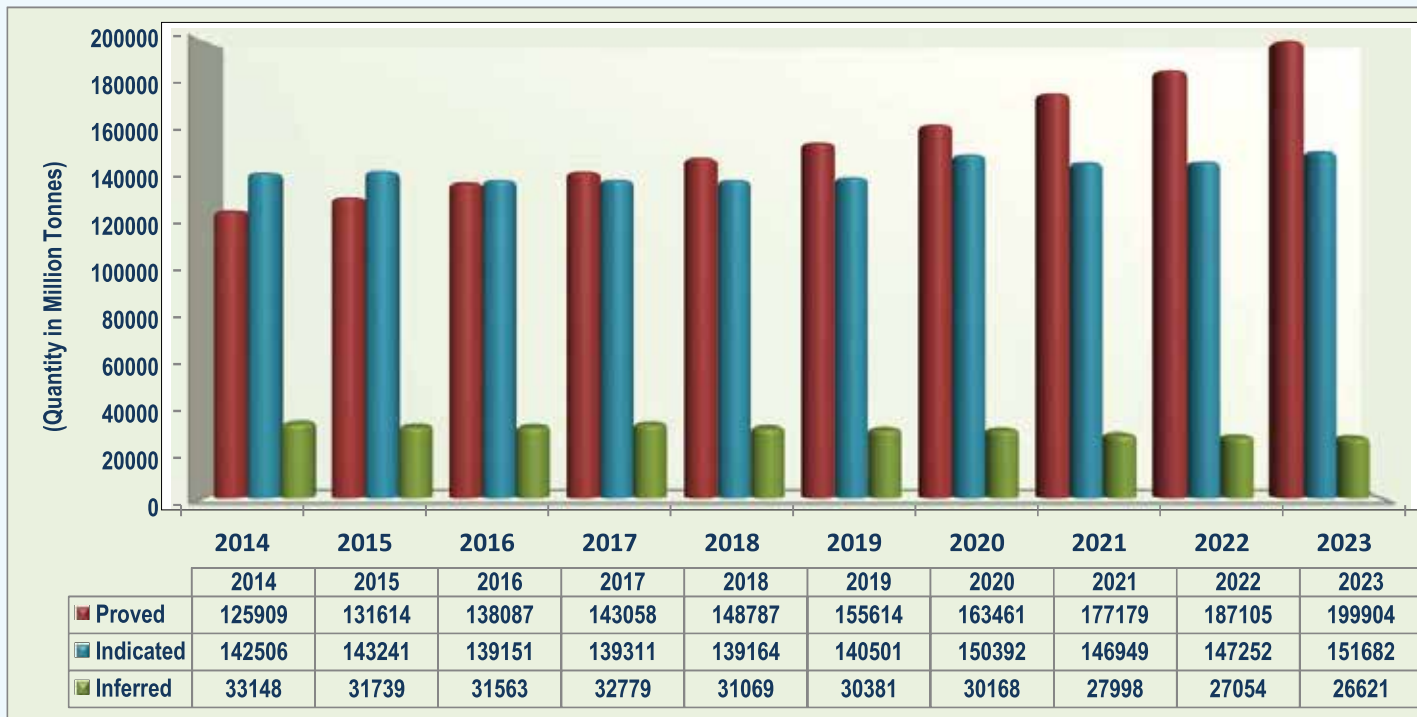

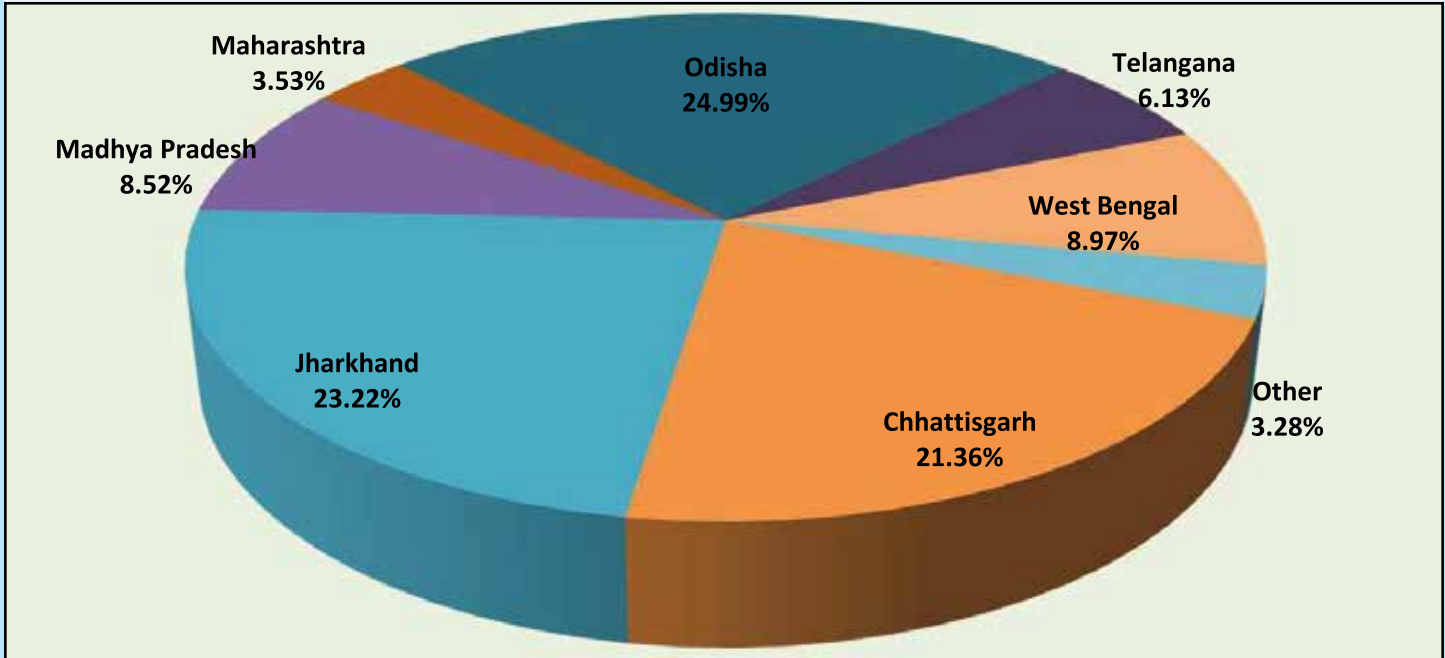

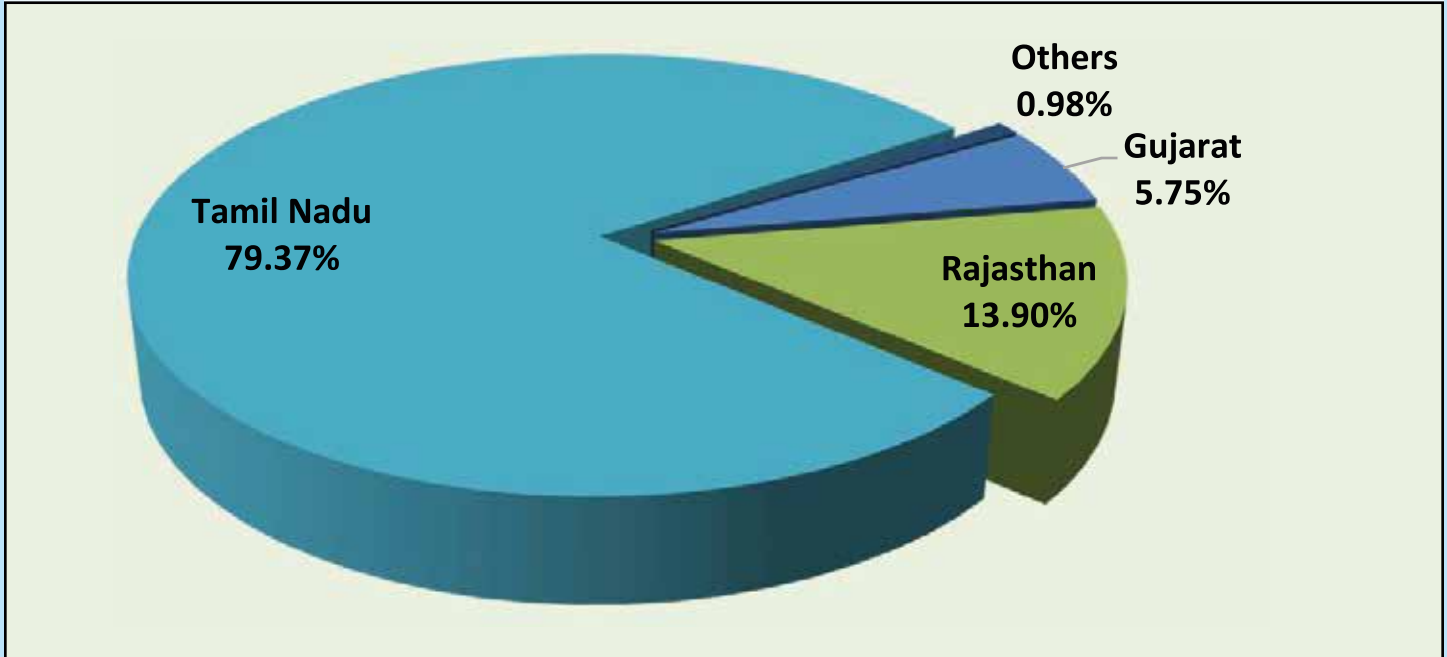

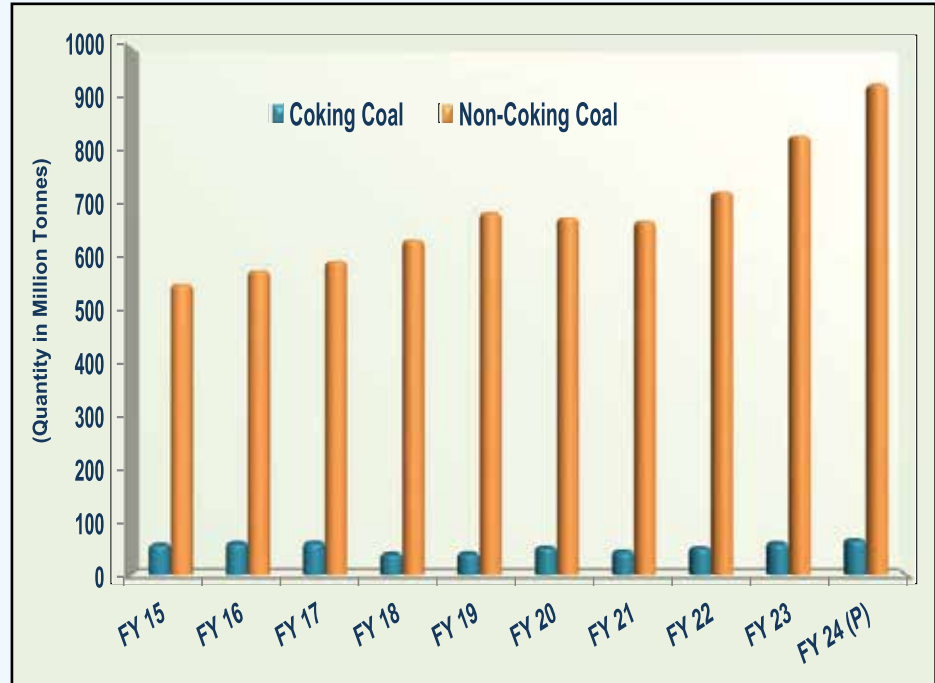

Chart 4: State Wise Coal Production during Last Ten Years

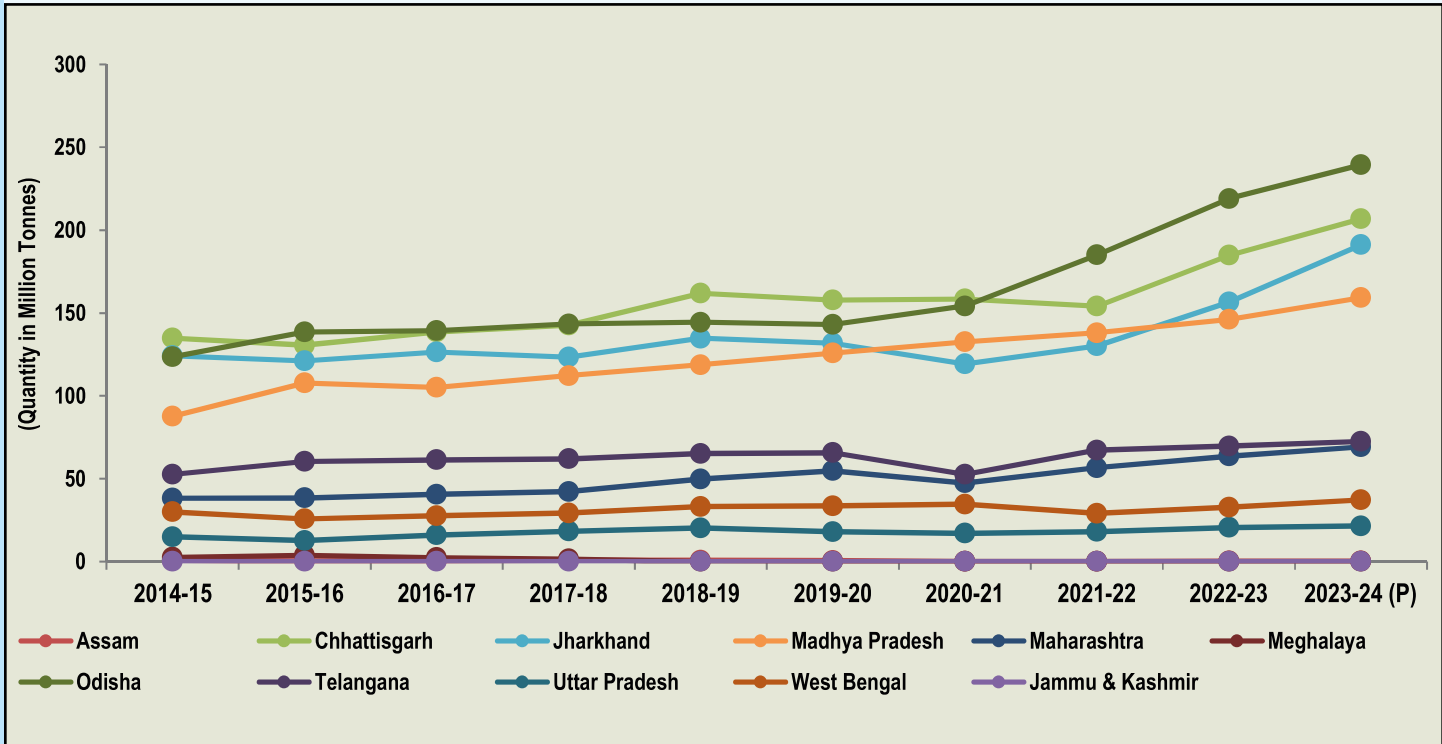

Chart 5: Month and State Wise Coal Production in FY 2024-25

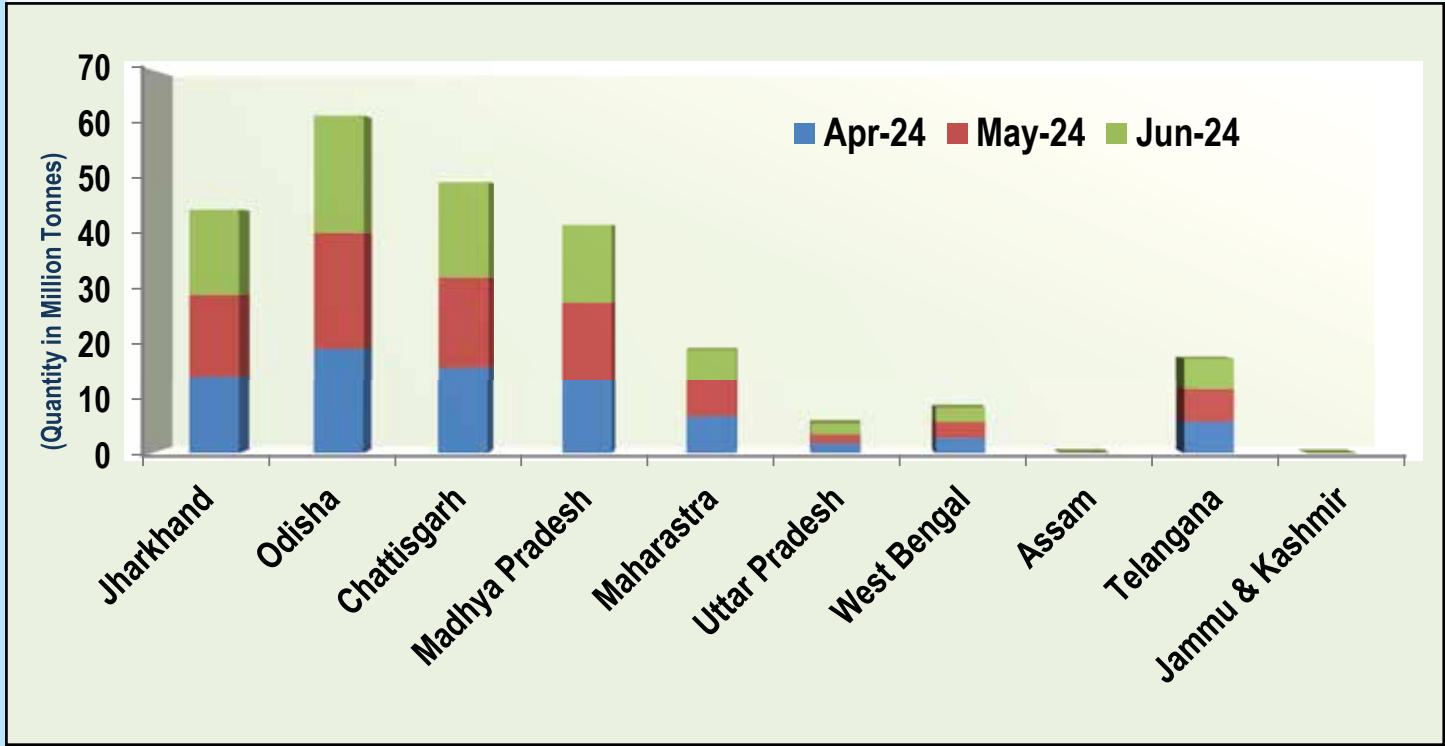
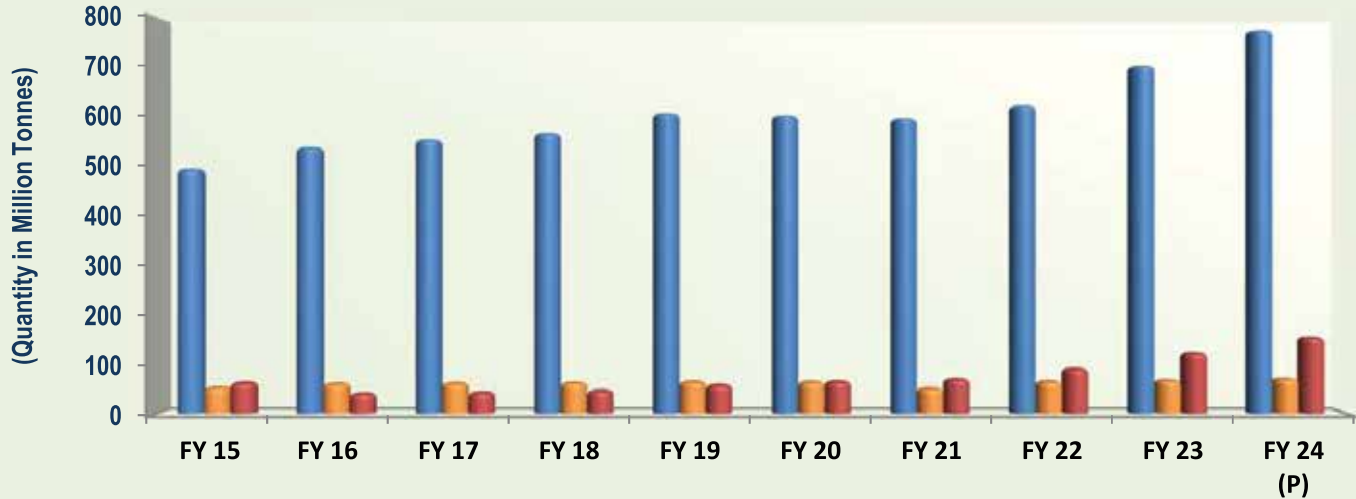


Chart 6: Coal Production of CIL, SCCL, and Other Companies during FY 2014-15 to FY 2023-24

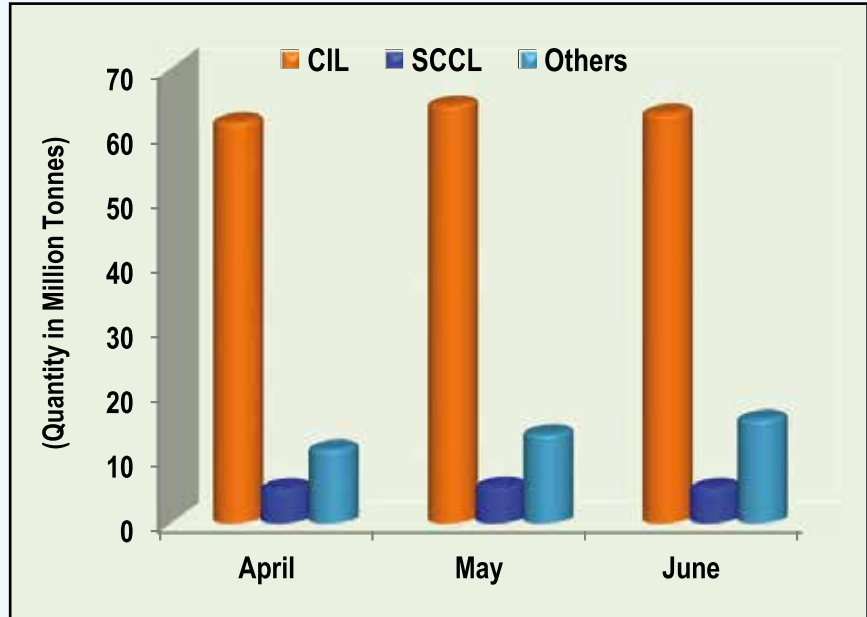

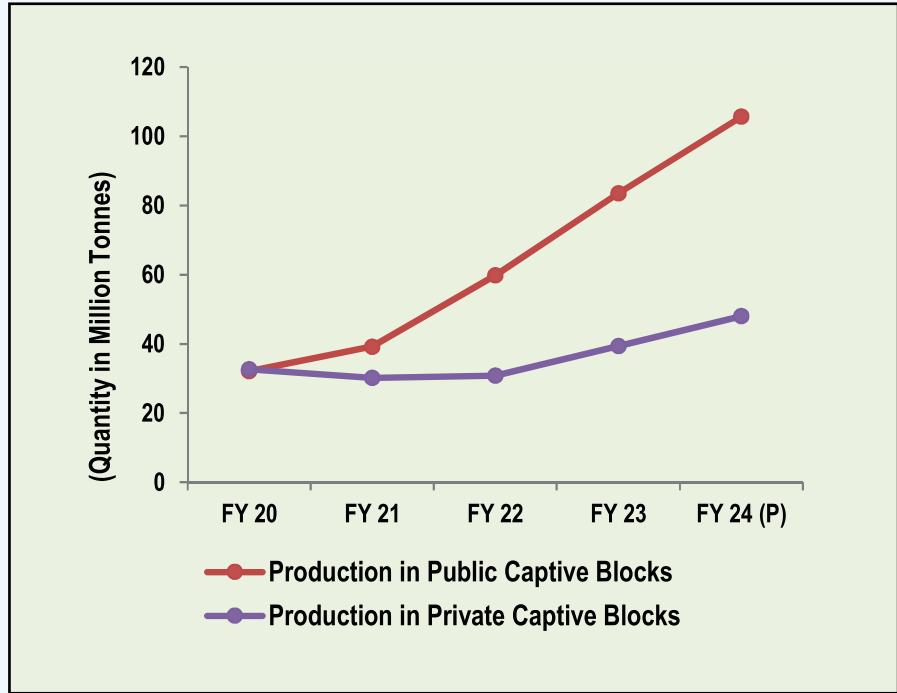

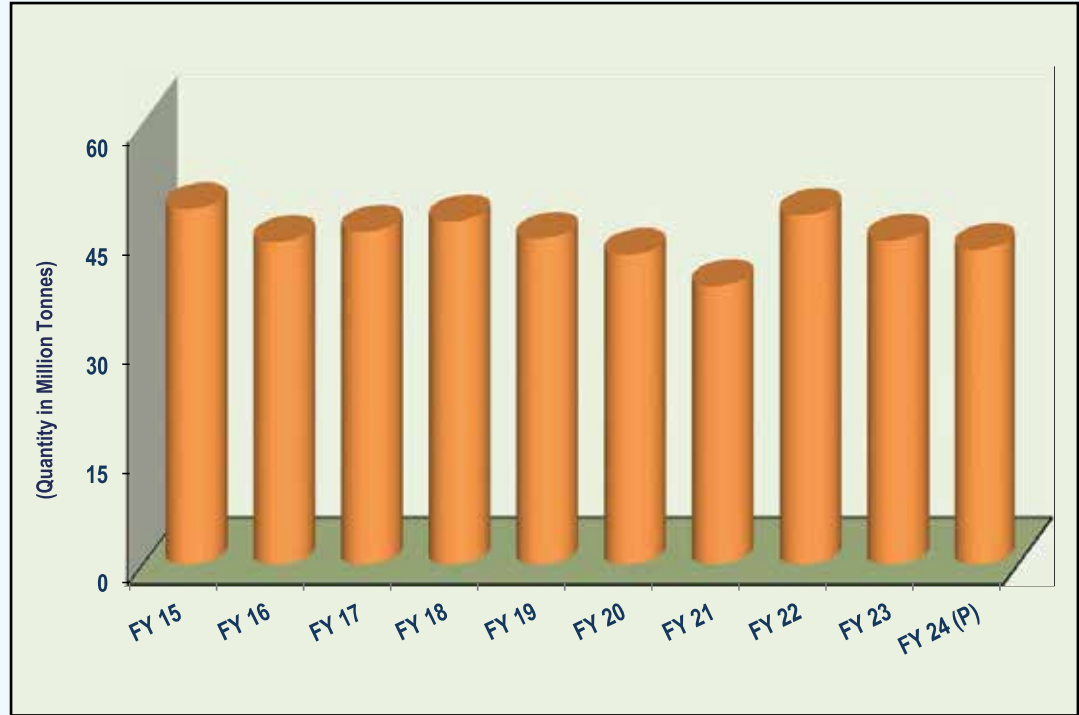

Chart 7: State Wise Lignite Production during Last Ten Years

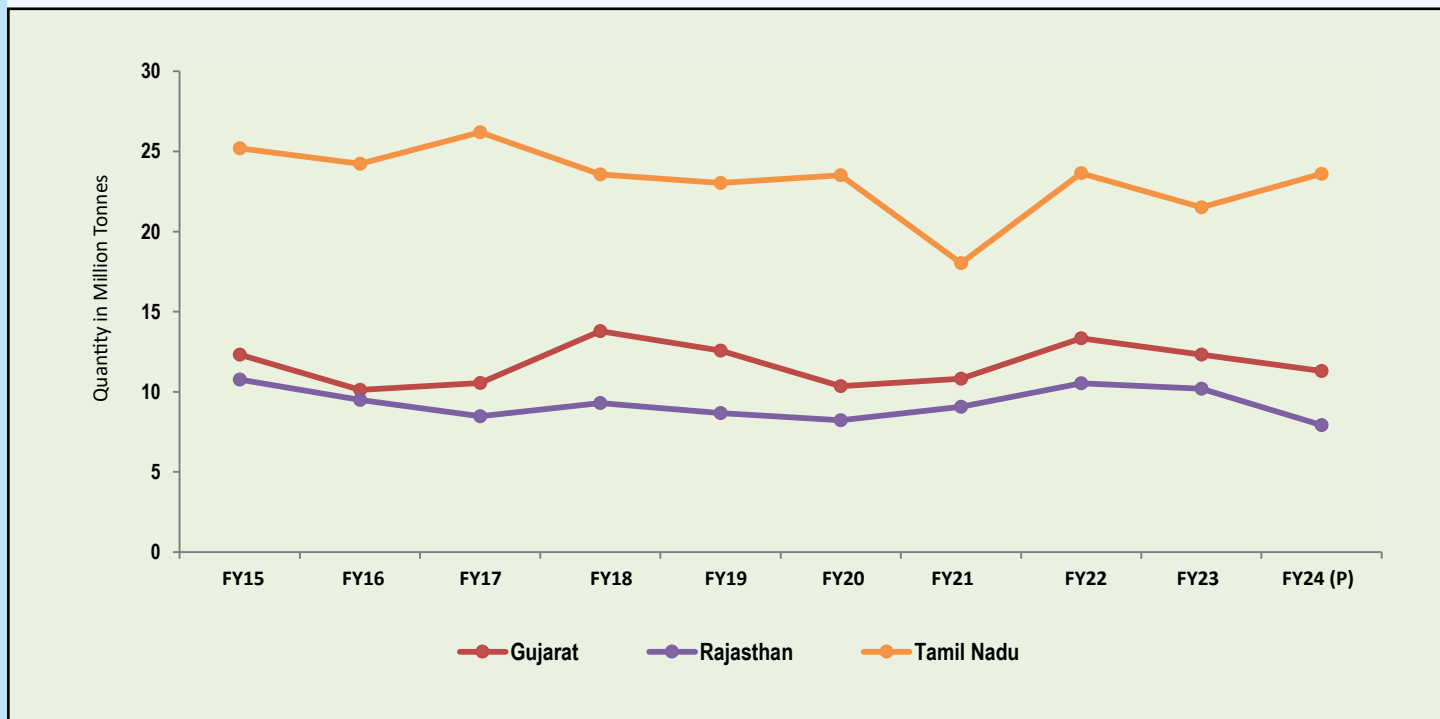
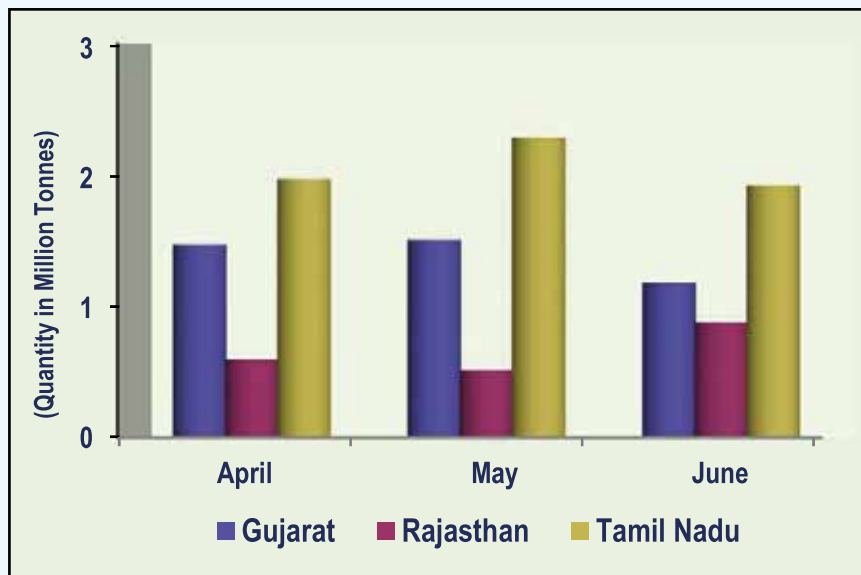

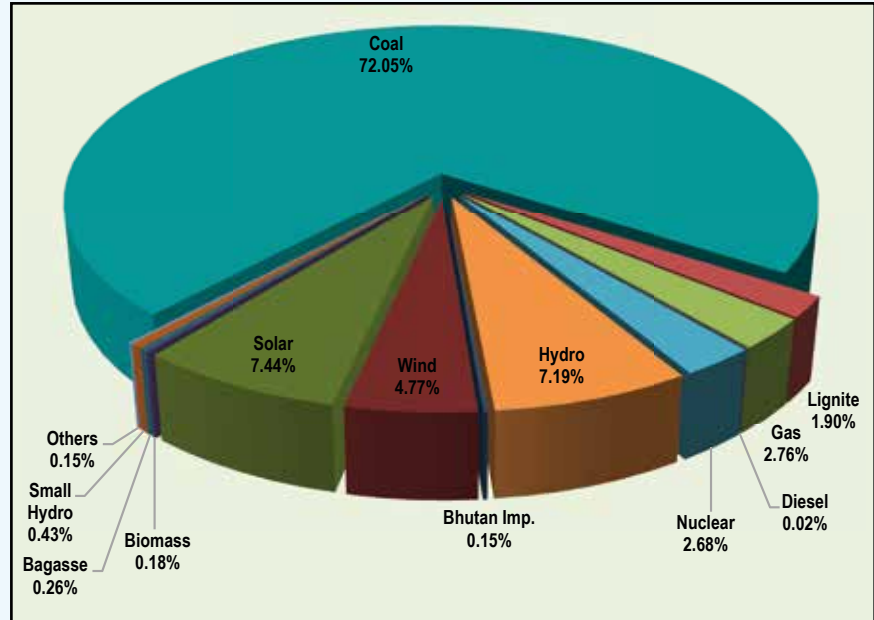

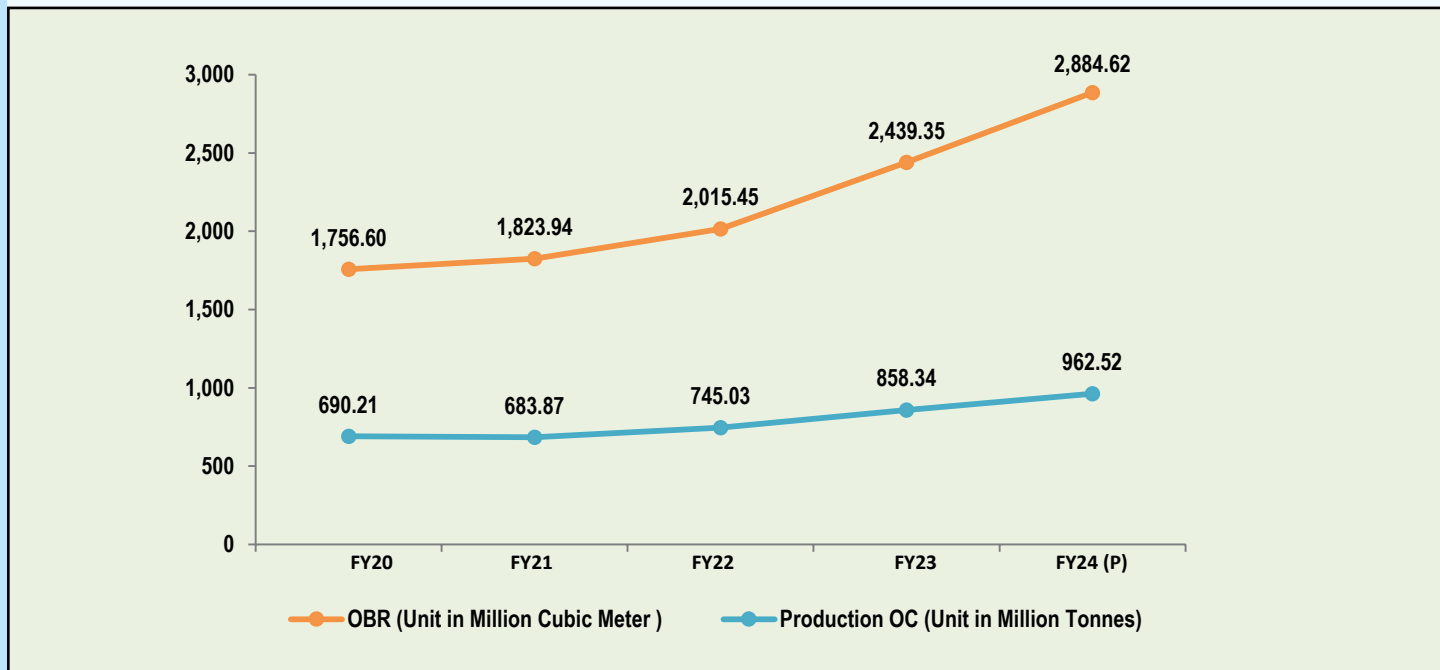

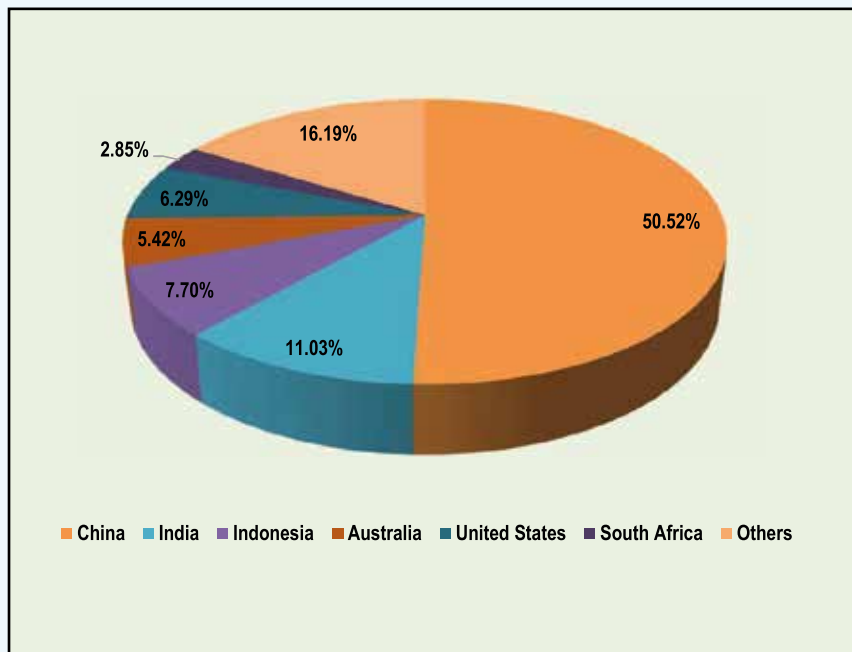

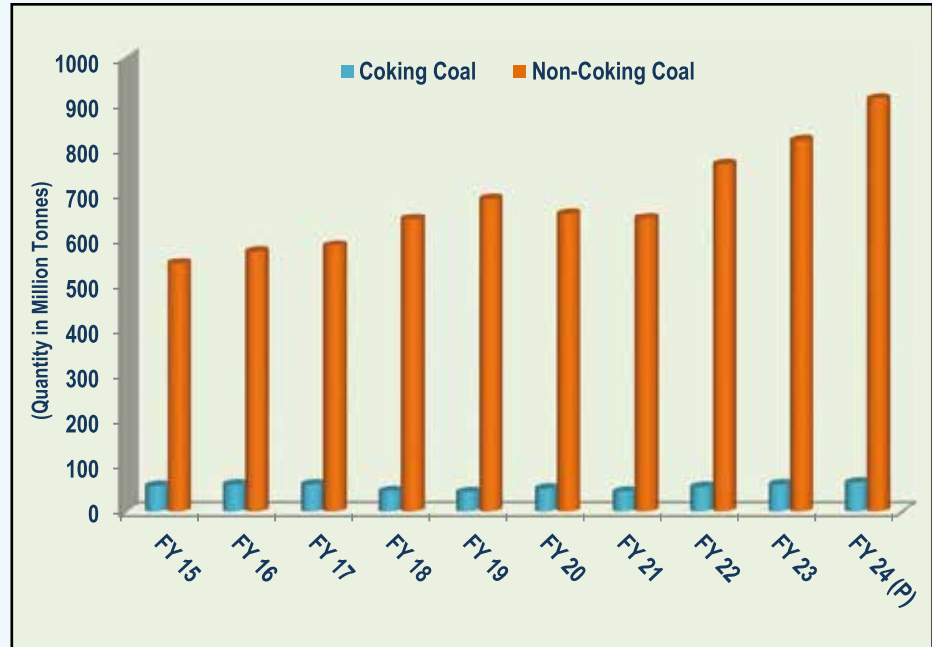
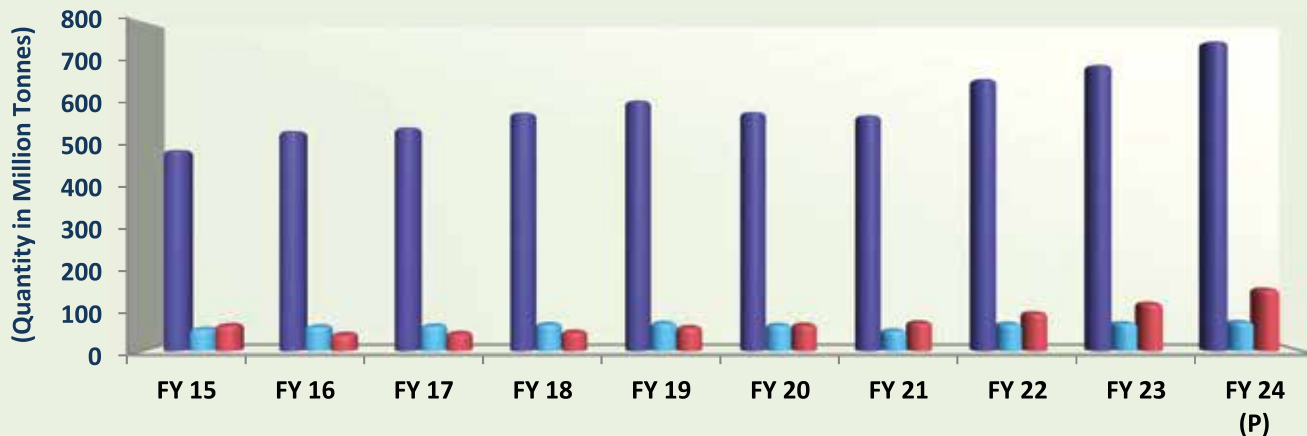


Chart 9: Coal Despatch of CIL, SCCL, and Others during FY 2014-15 to FY 2023-24

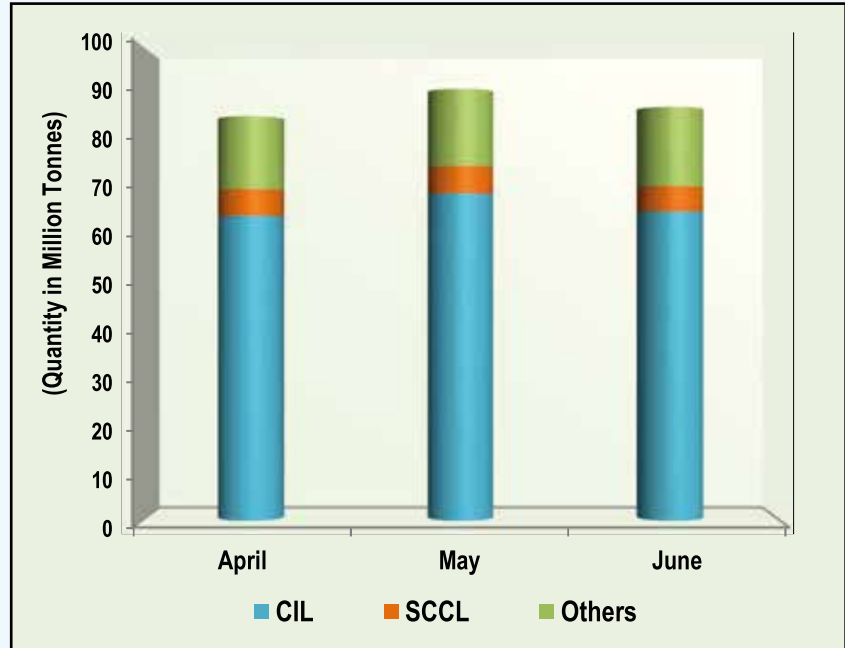

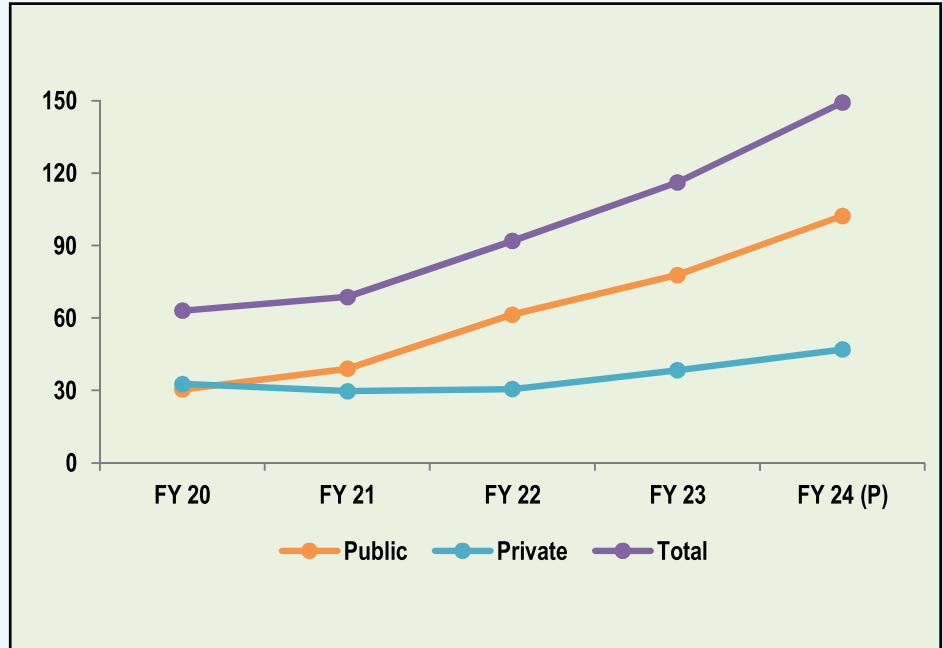

Chart 10: Year Wise Despatch of Coal to Different Priority Sectors from FY 2014-15 to FY 2023-24

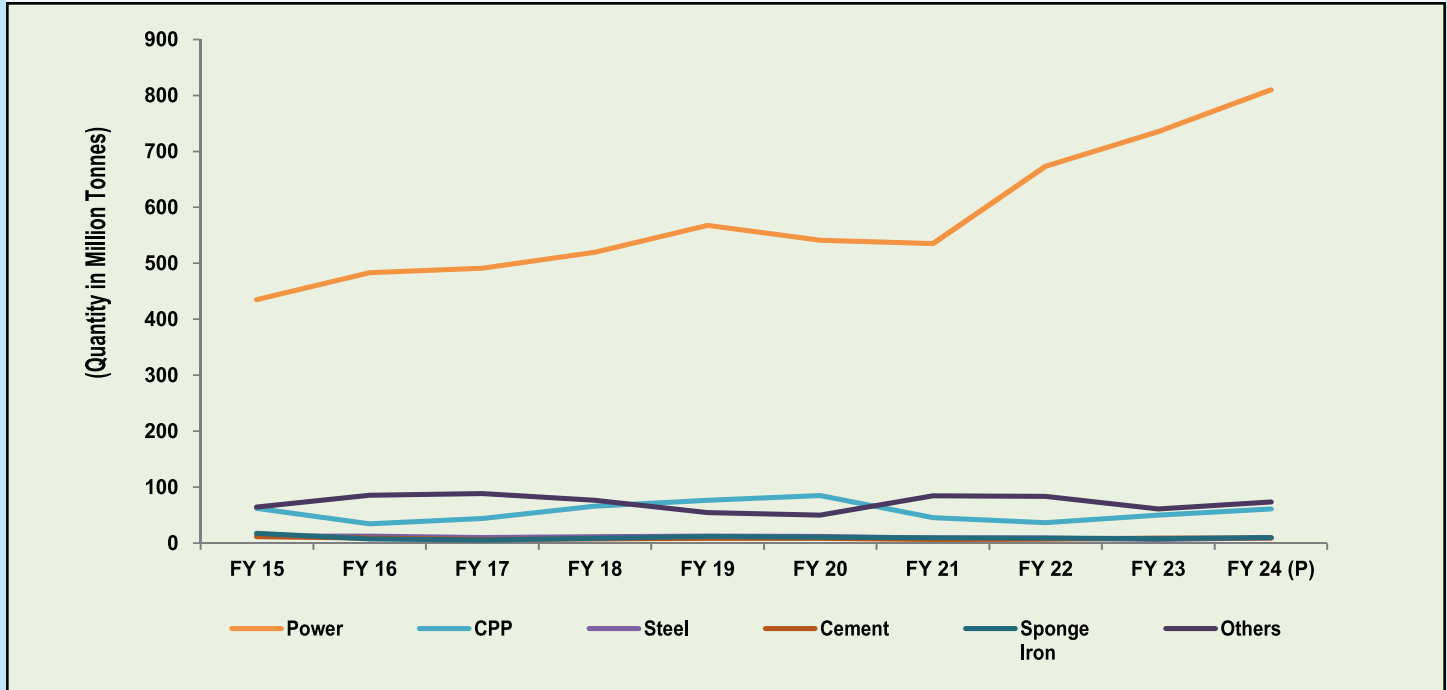

Chart 11: CIL's Mode Wise Despatch of Coal during Last Five Years

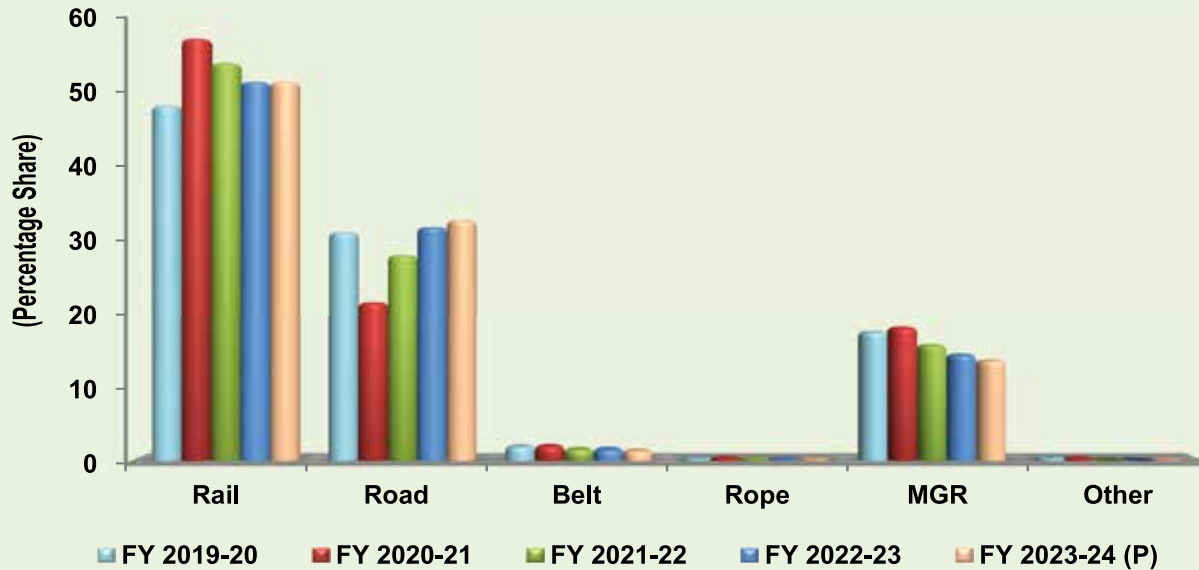

Chart 12: SCCL's Mode Wise Despatch of Coal during Last Five Years

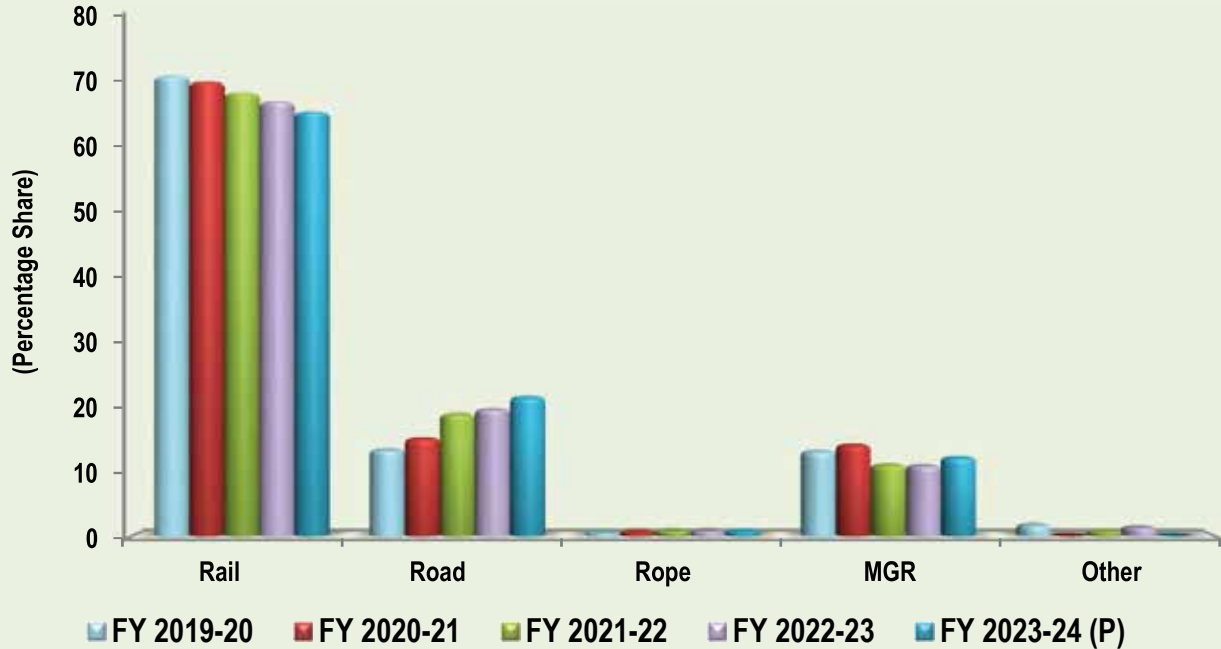

Chart 13: Other Companies' Mode Wise Despatch of Coal during Last Five Years

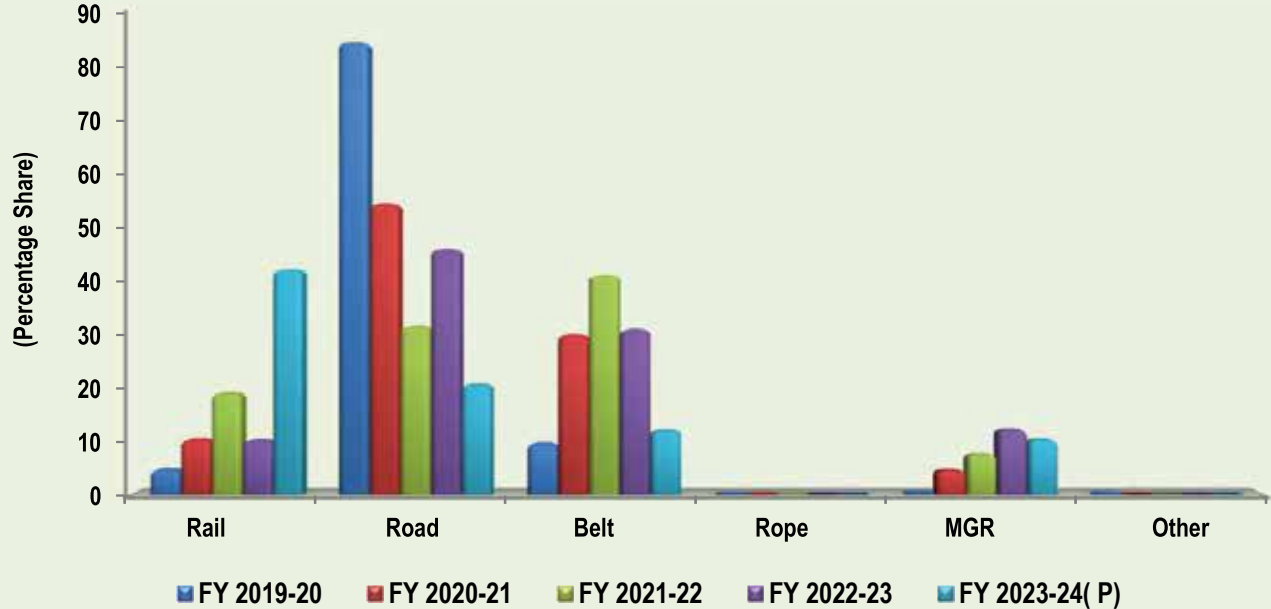
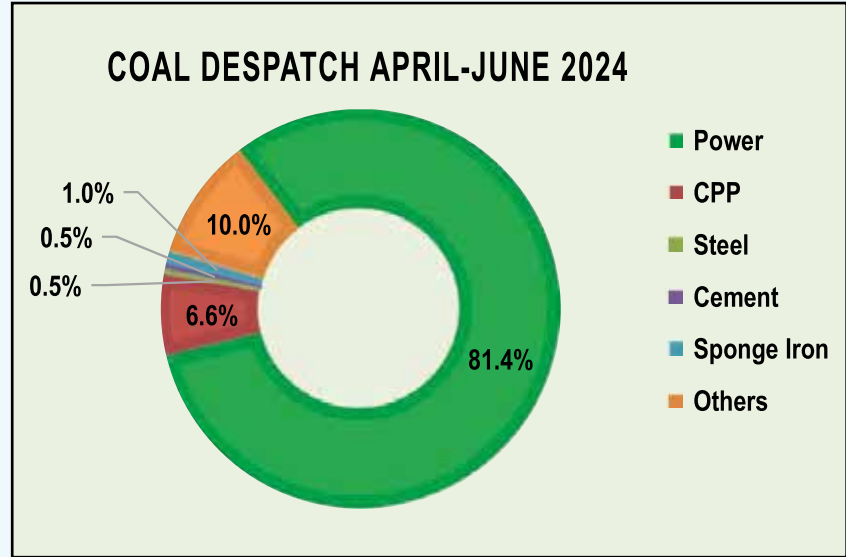

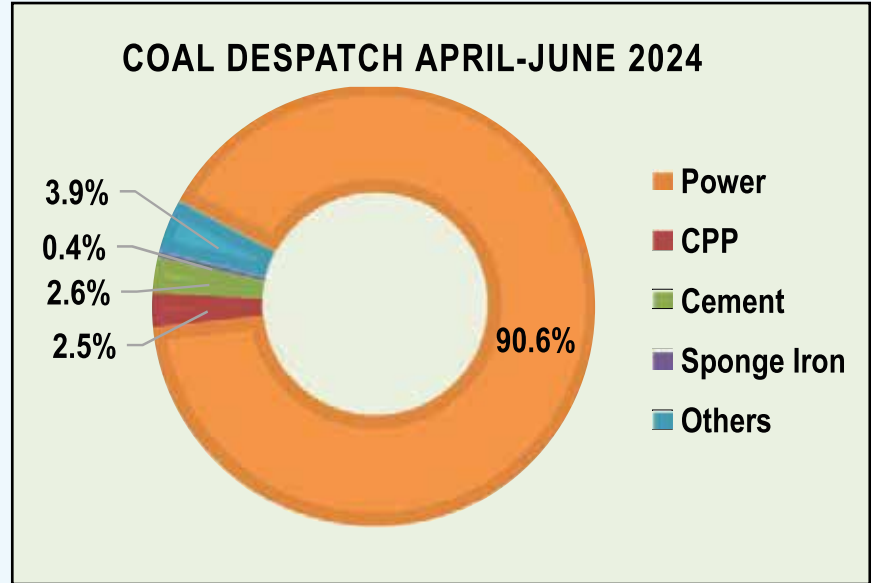

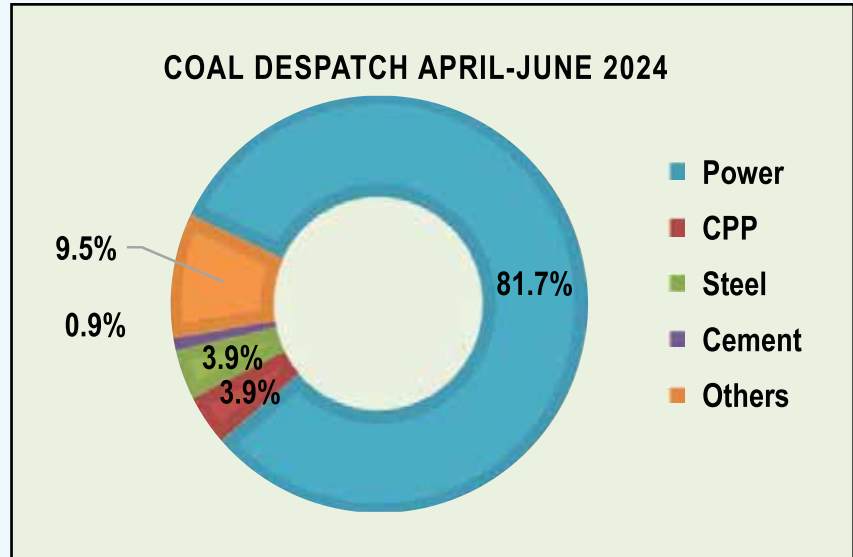

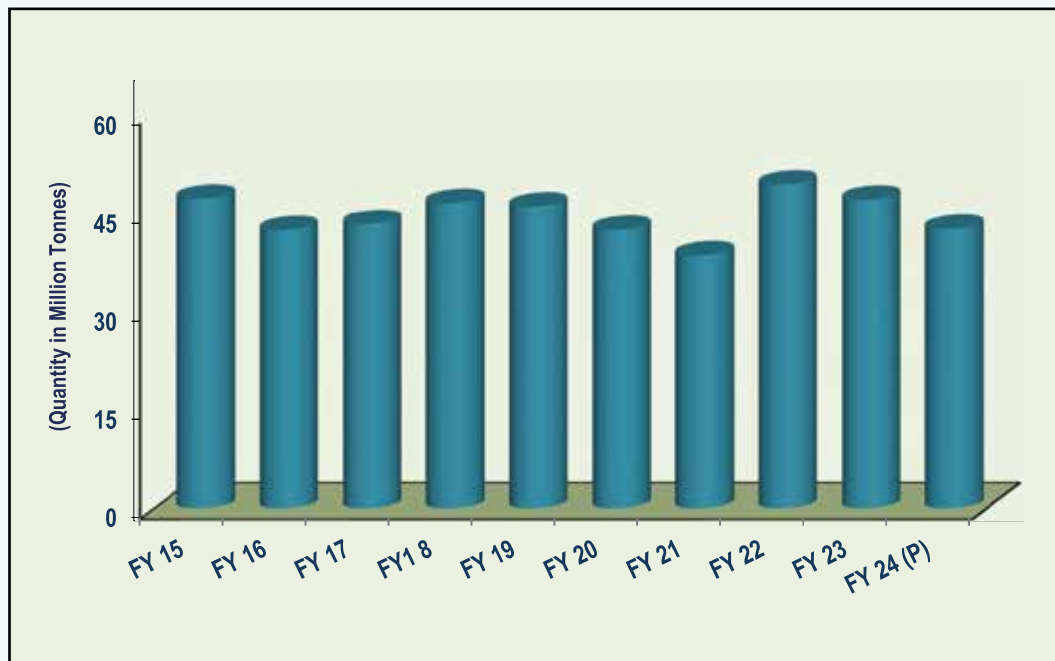

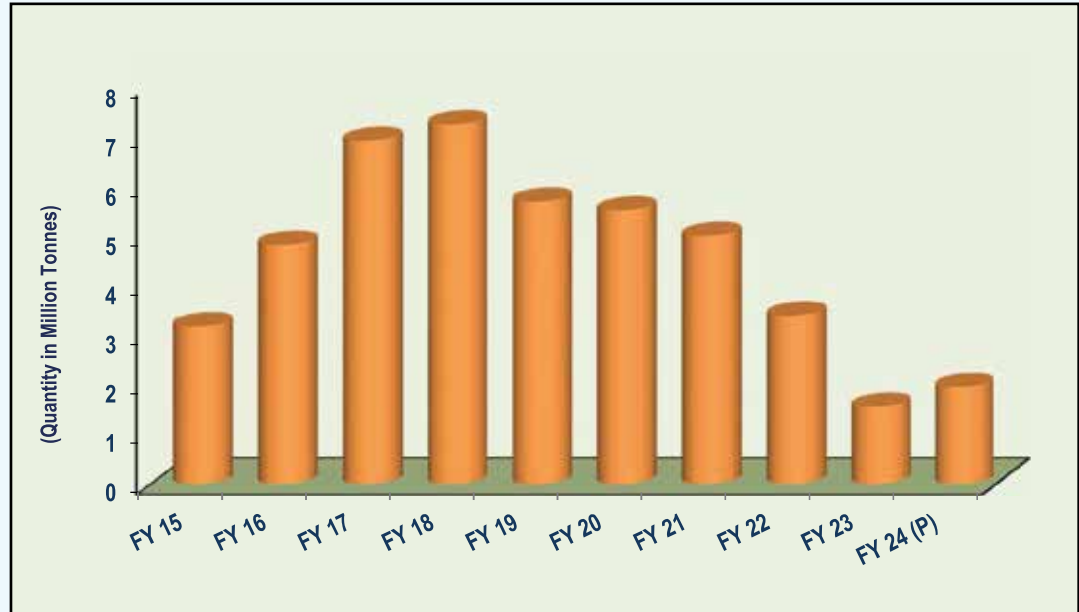

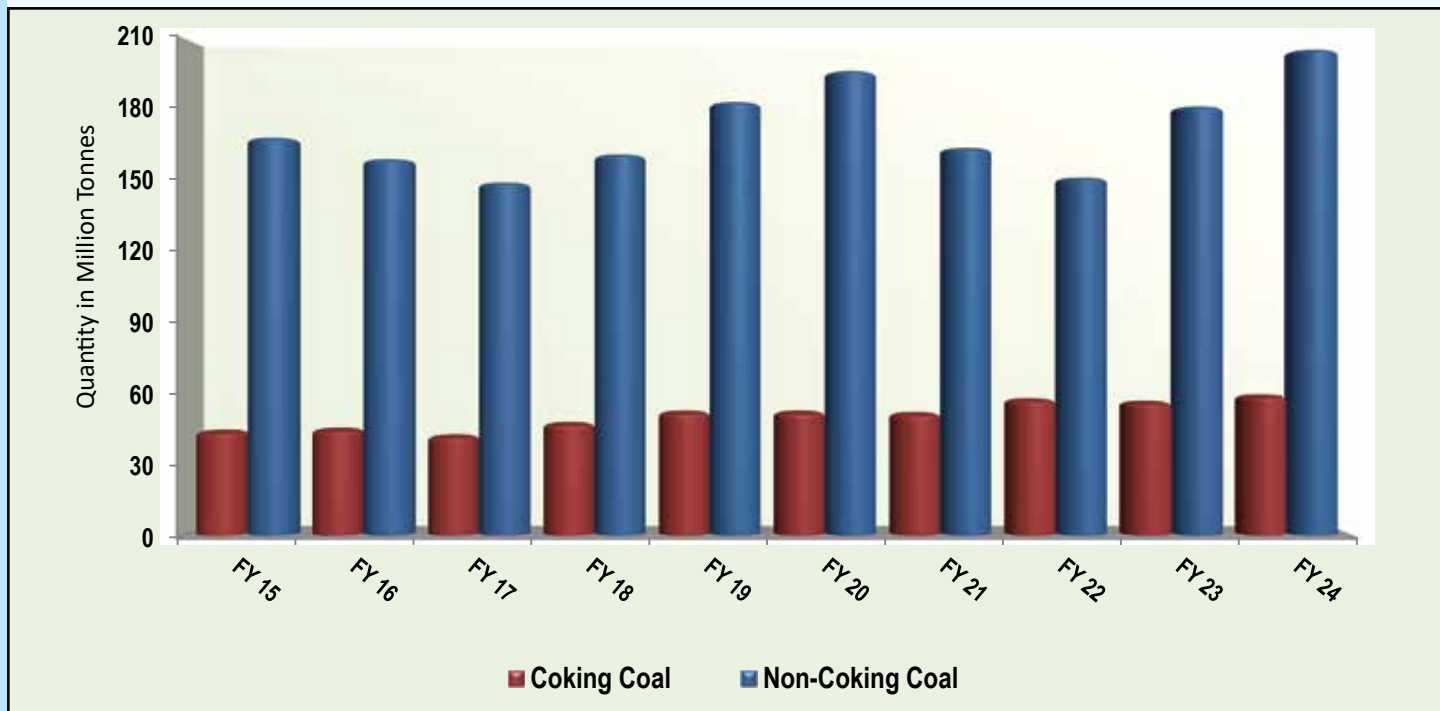

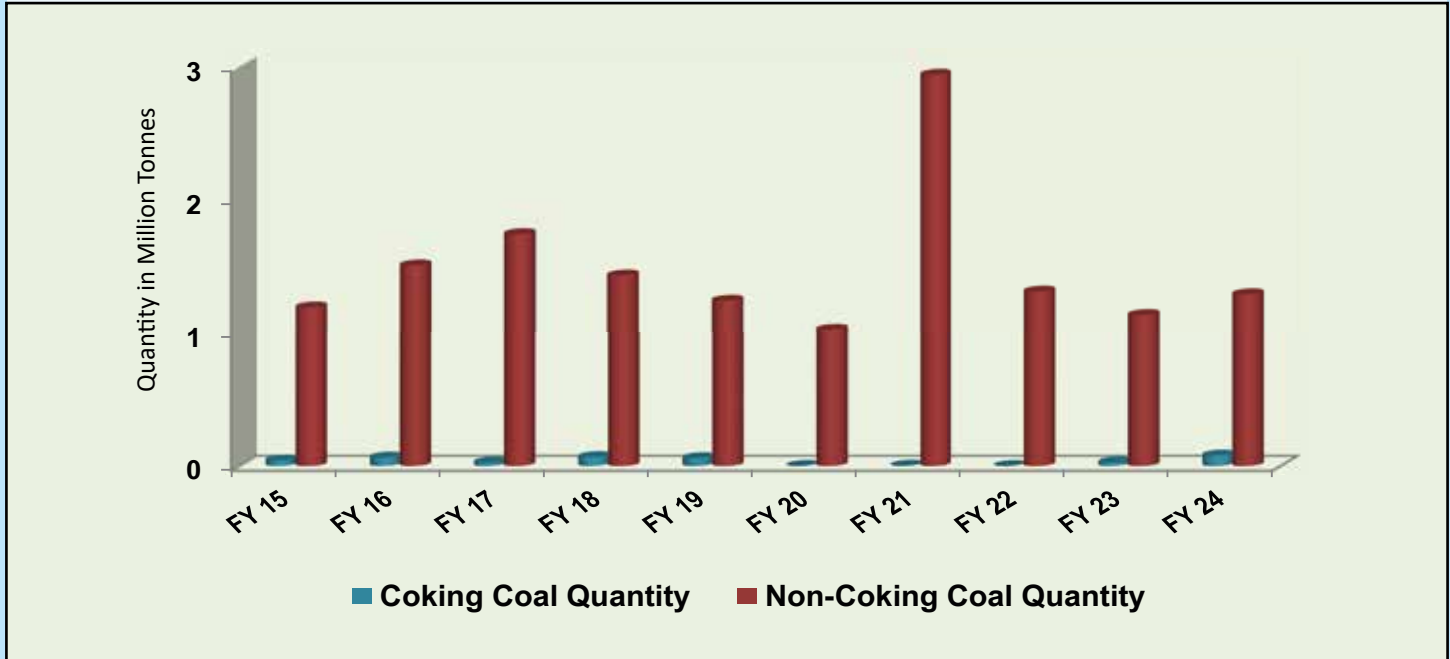

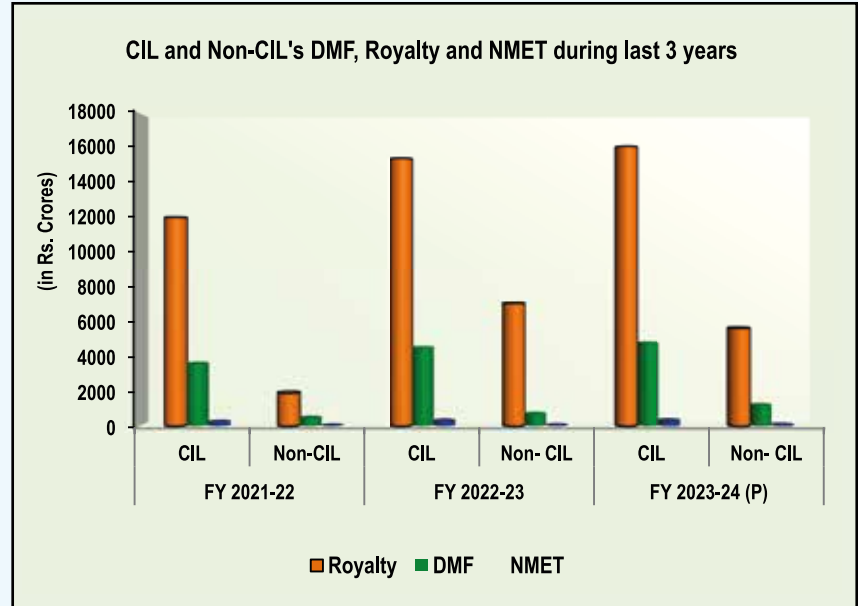

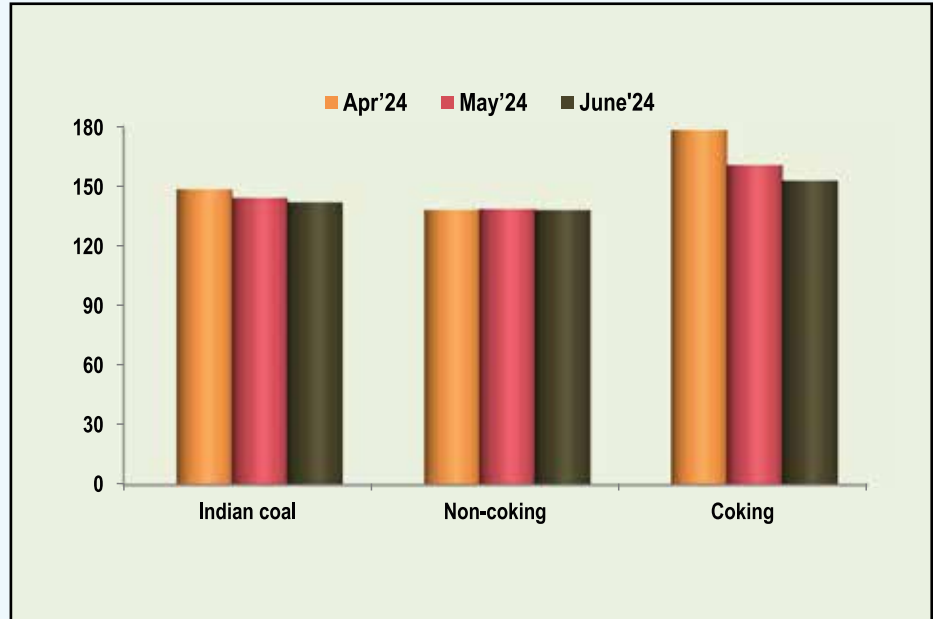
