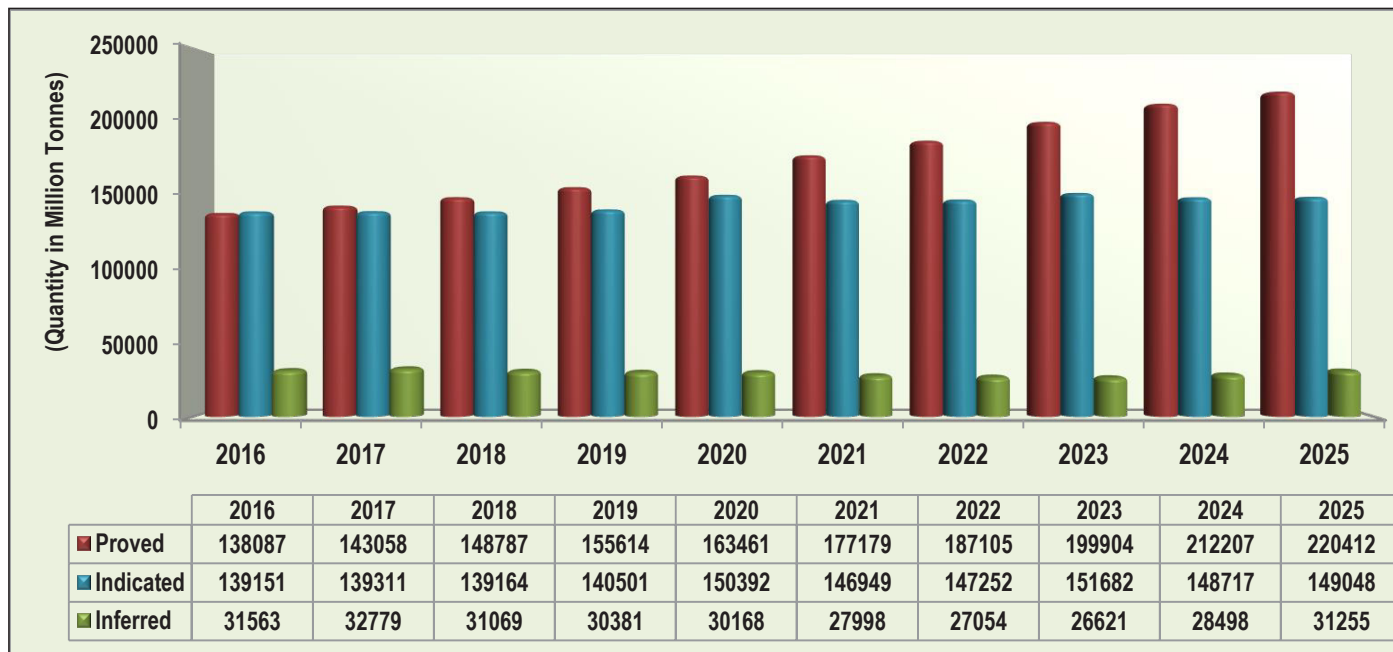

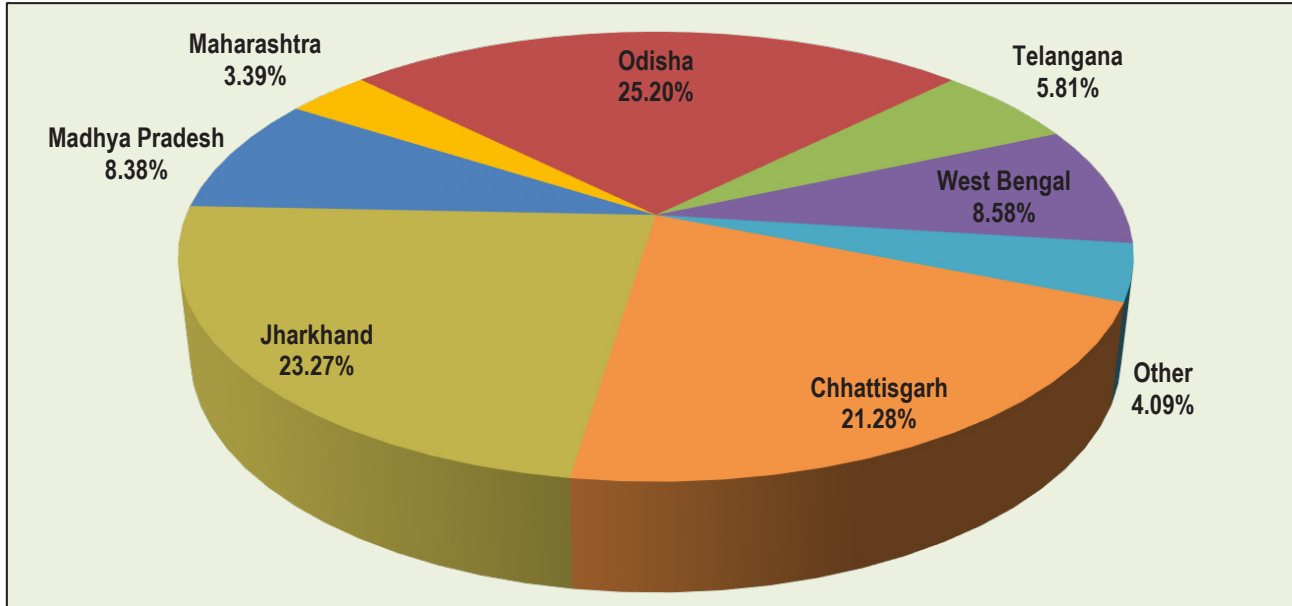

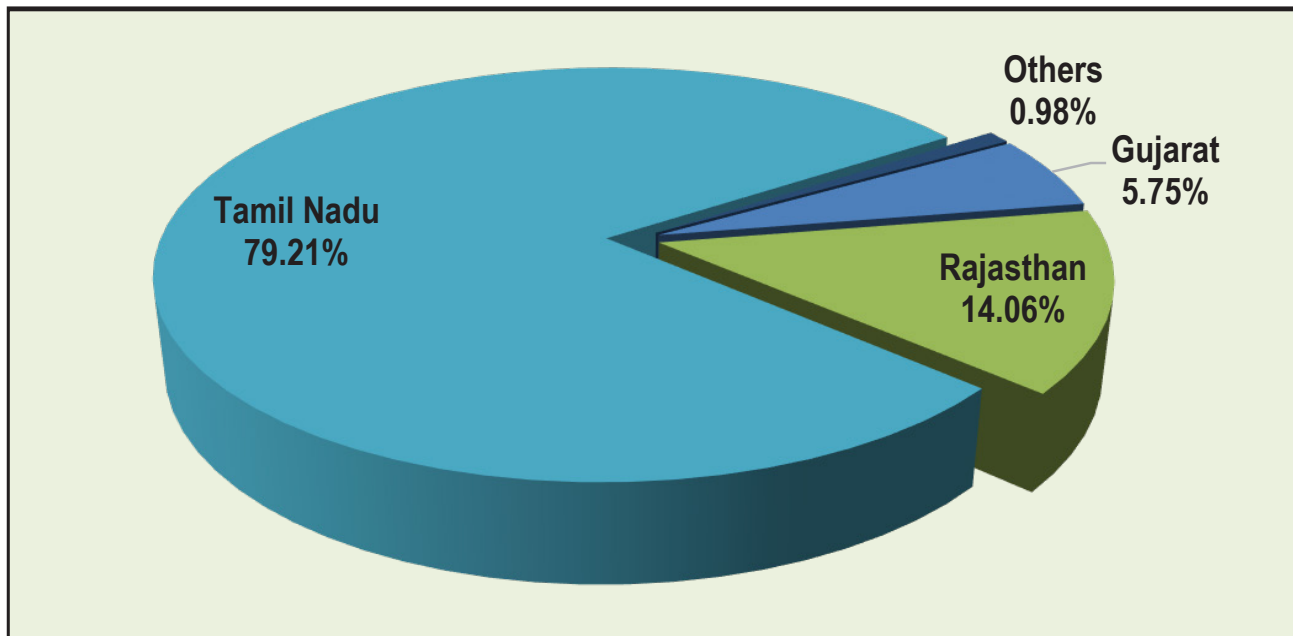

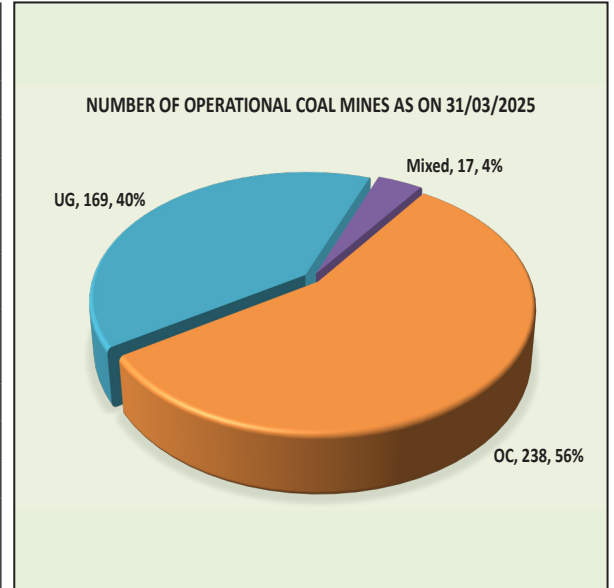

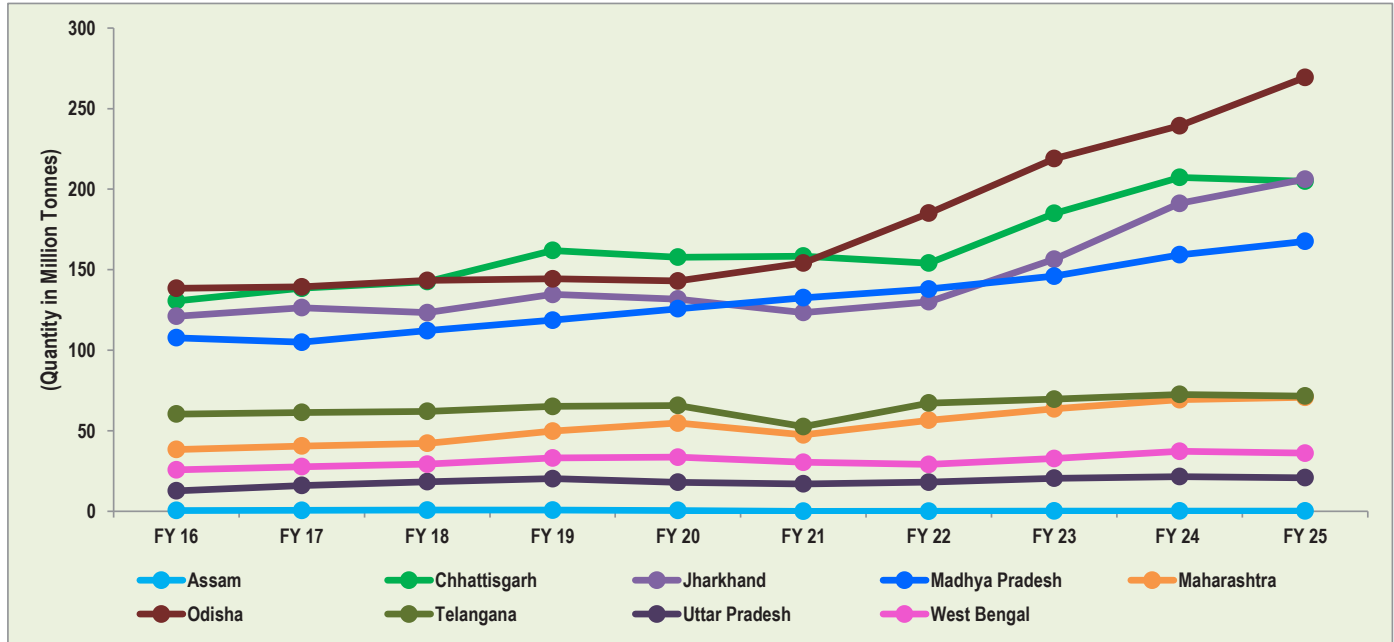

### Chart 4: State Wise Coal Production during Last Ten Years



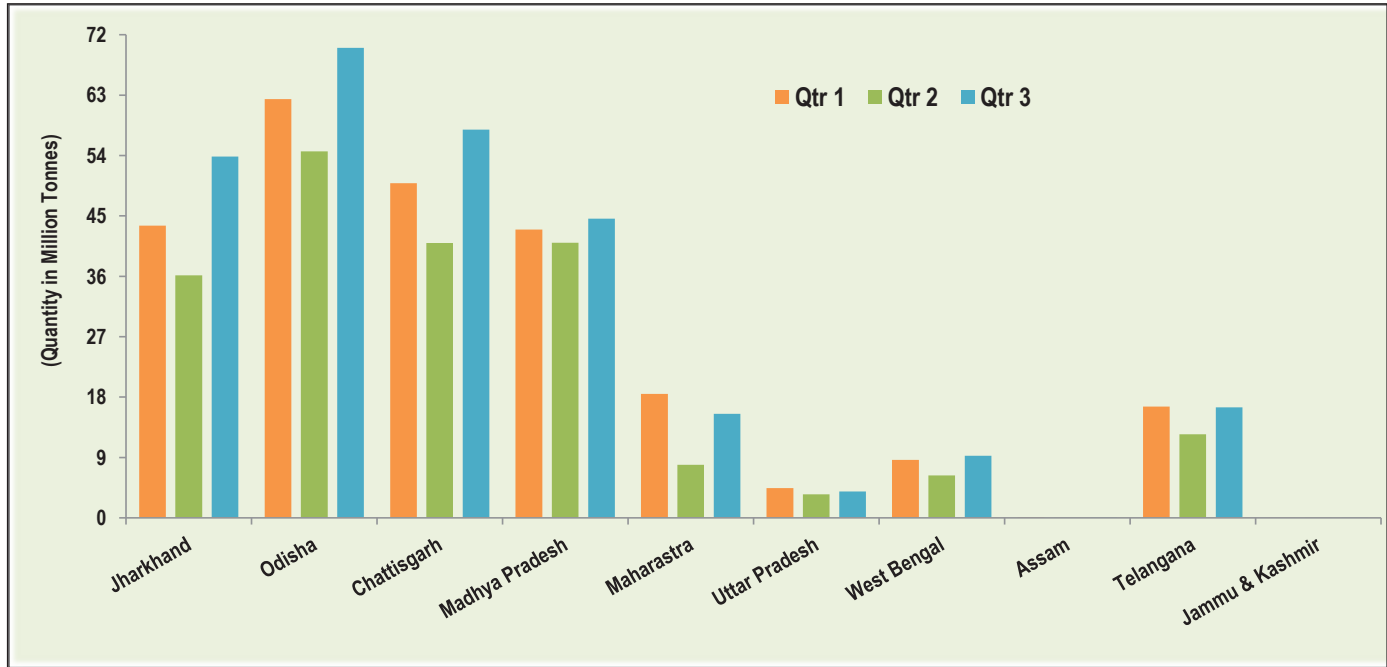

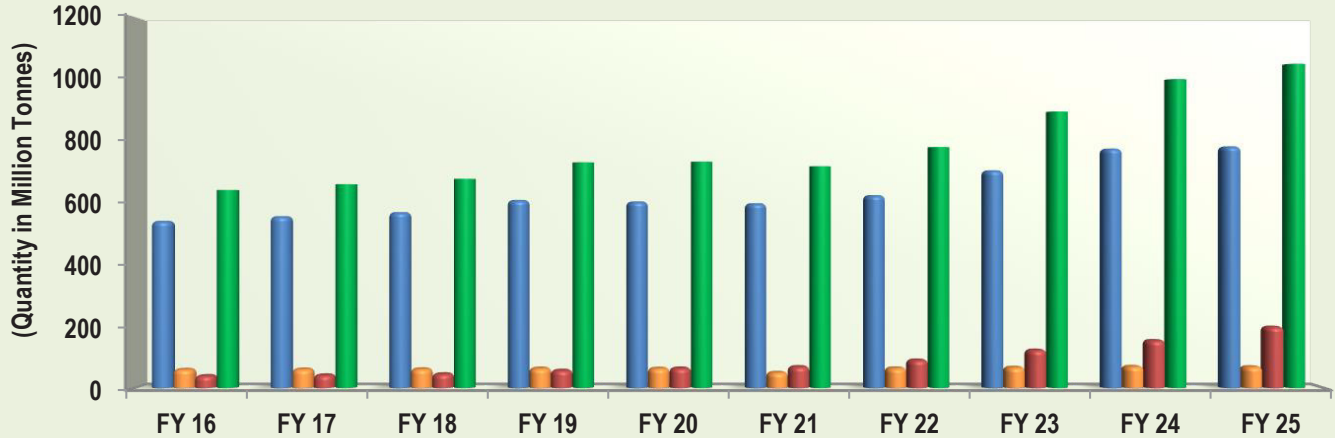

**Chart 6: Coal Production of CIL, SCCL, and Other Companies during FY 2015-16 to FY 2024-25**

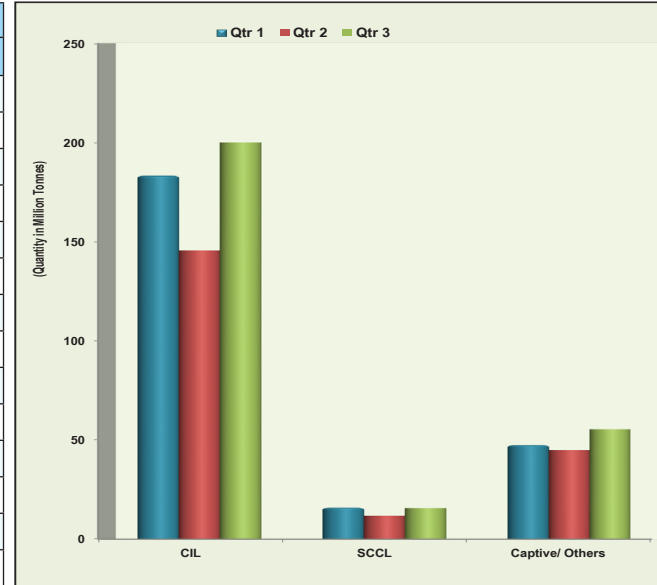

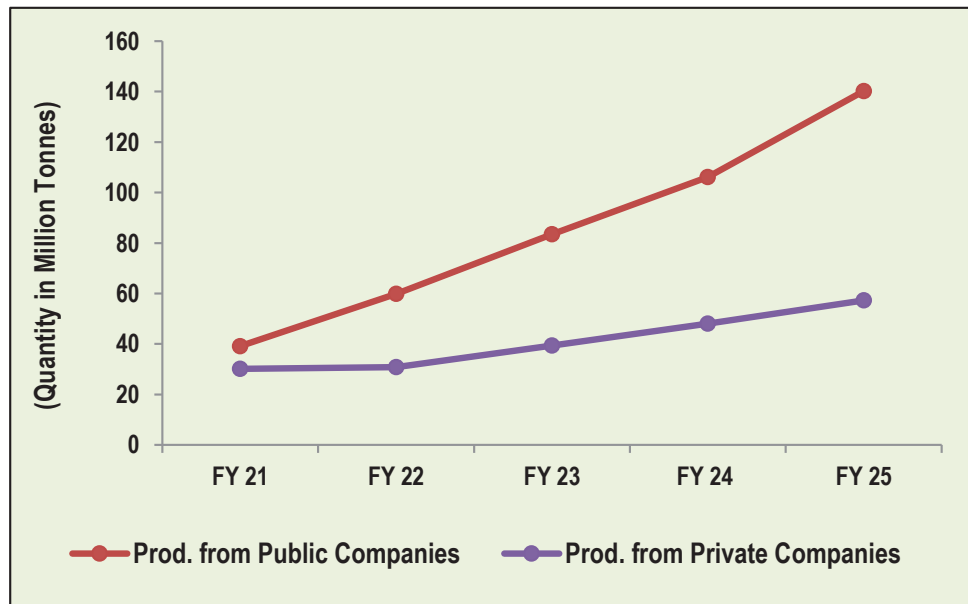

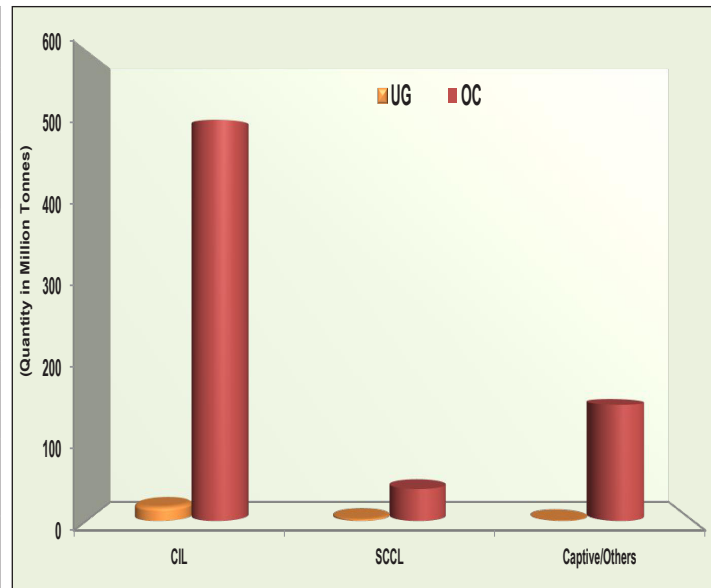

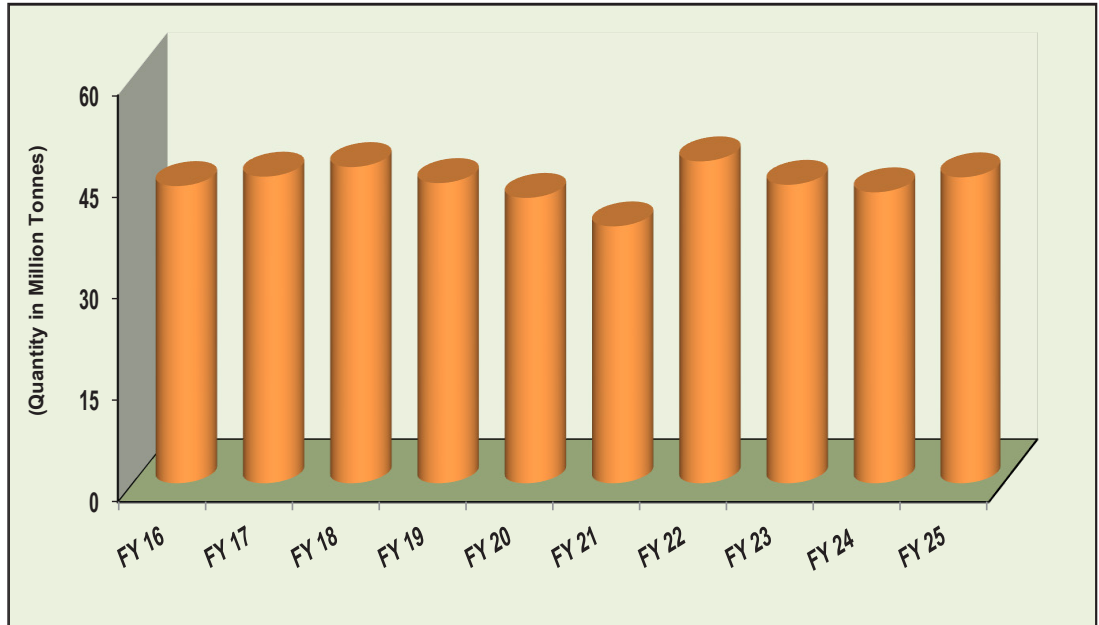

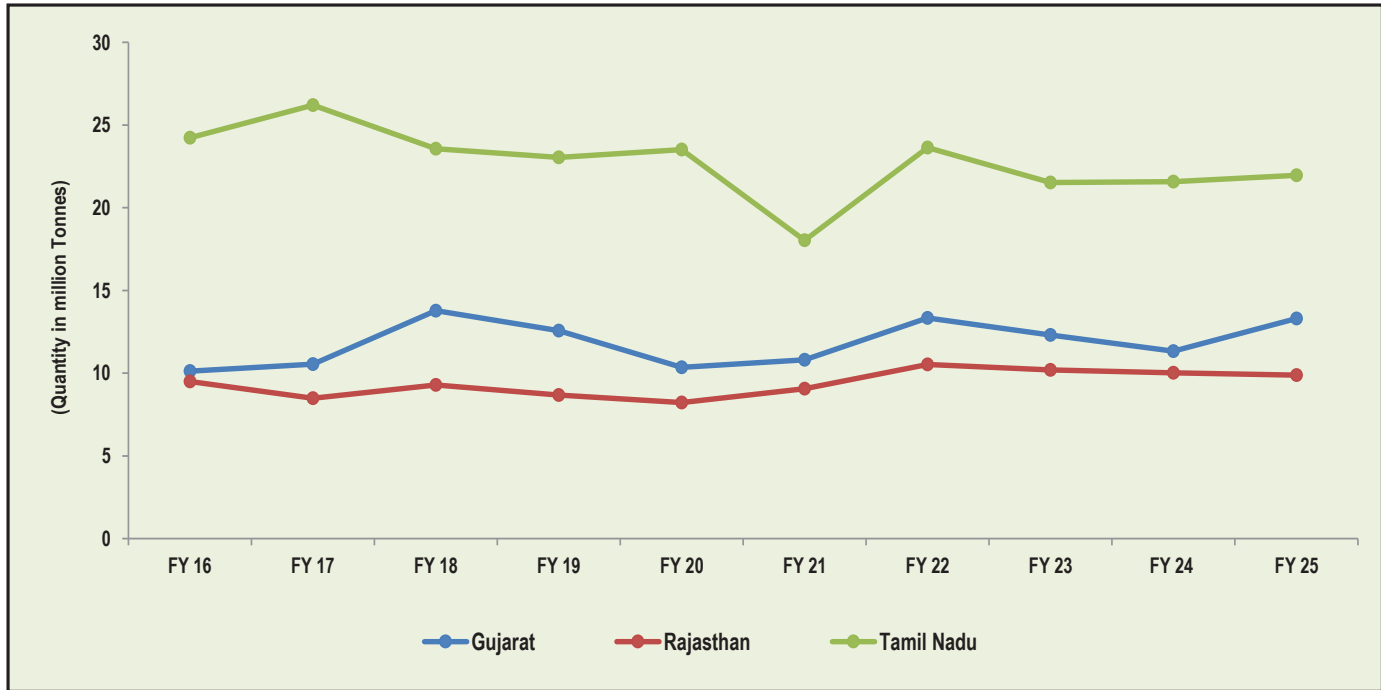

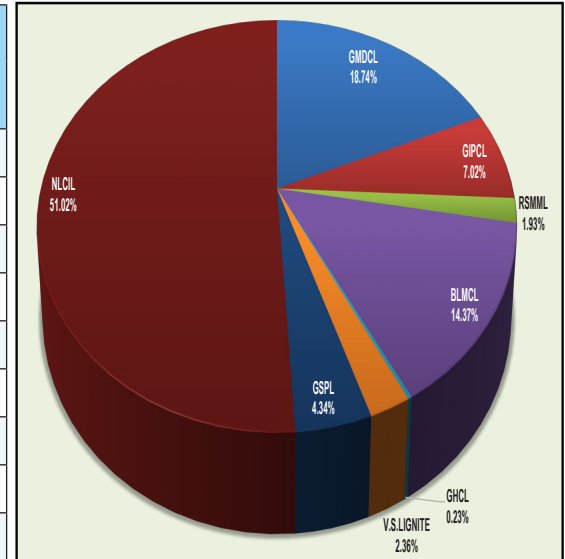
### Chart 7: State Wise Lignite Production during Last Ten Years

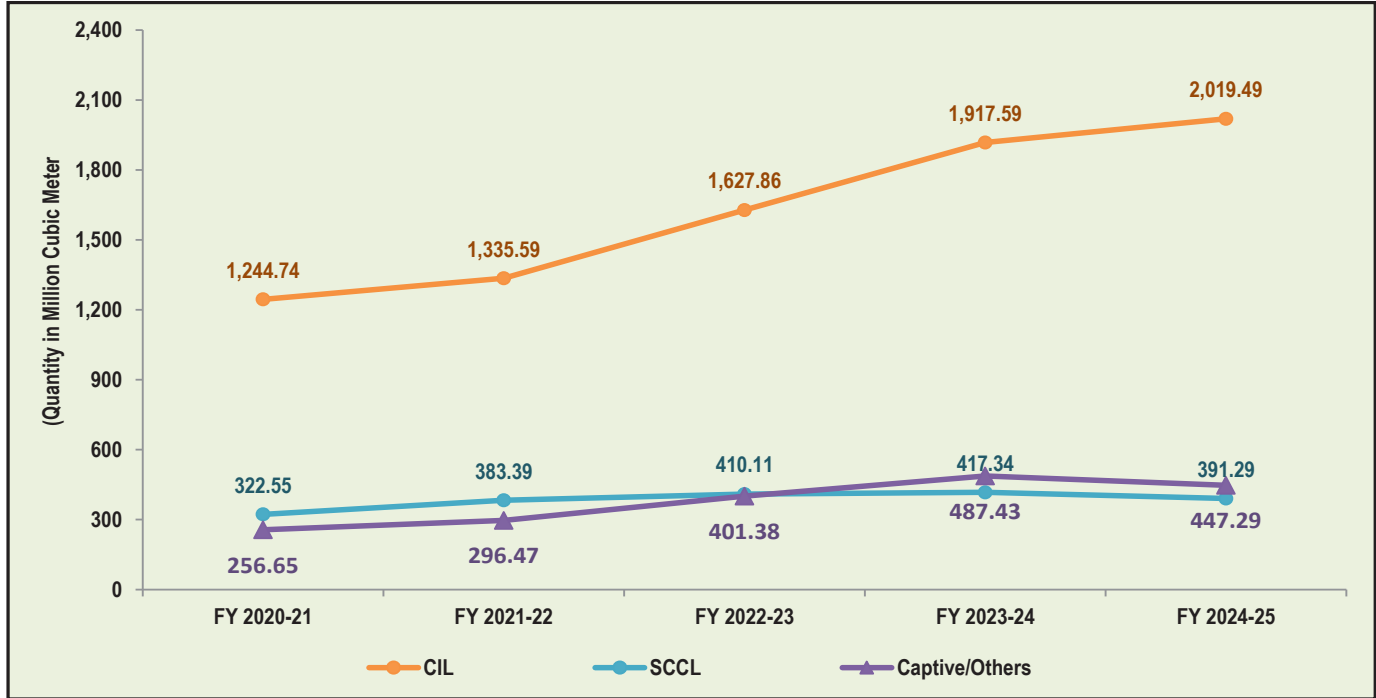

**Chart 8: Company Wise Over Burden Removal during Last Five Years**



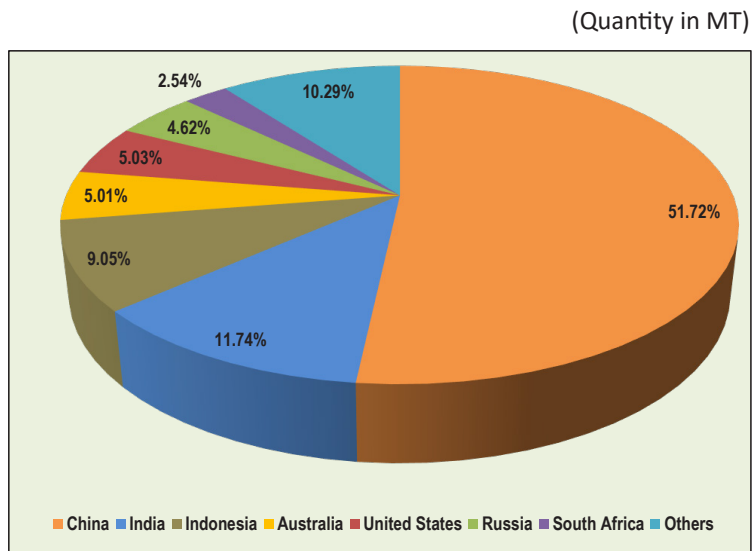

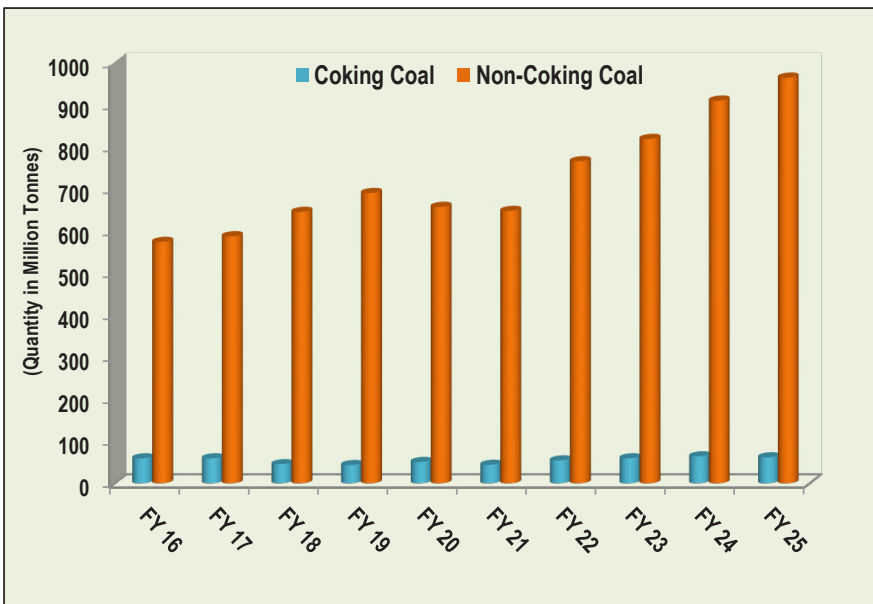

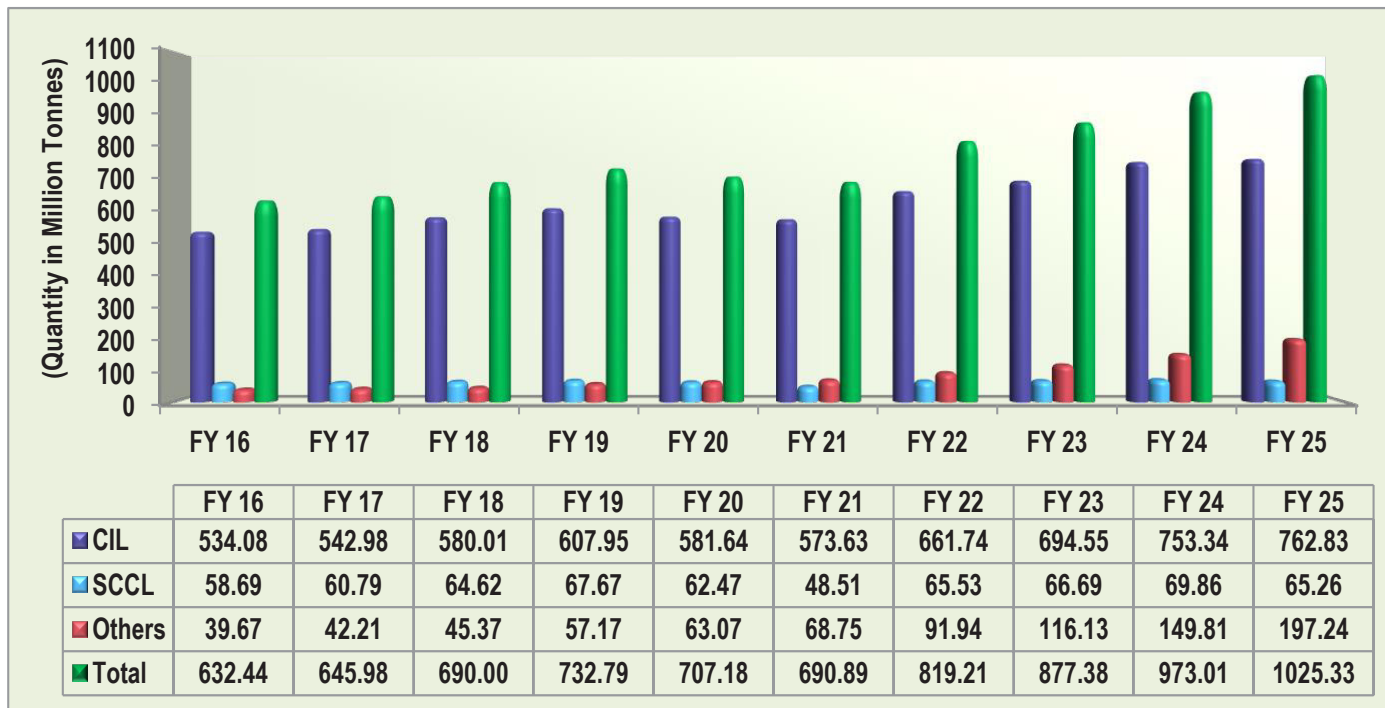

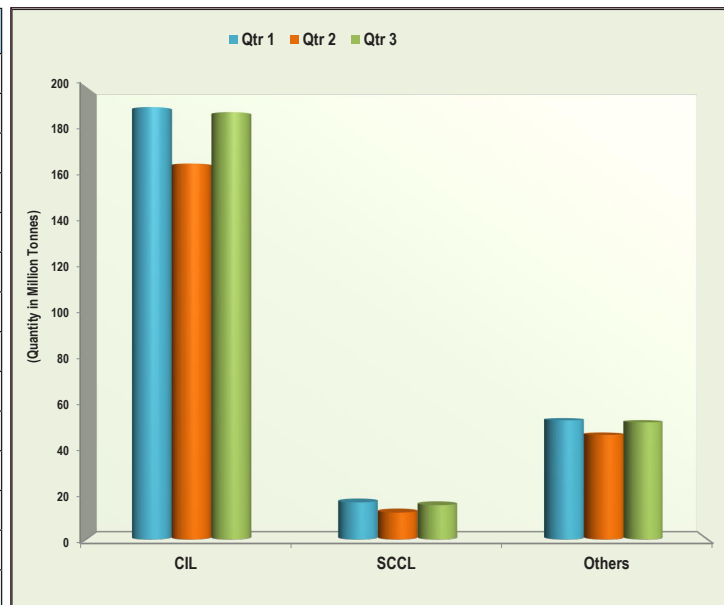
**Chart 9: Coal Despatch of CIL, SCCL, and Others during FY 2015-16 to FY 2024-25**

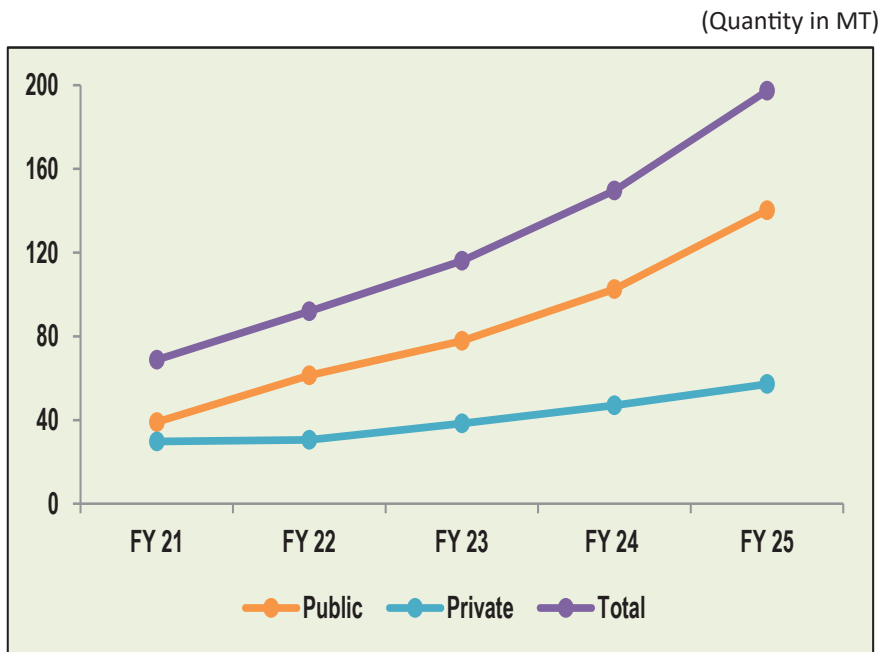

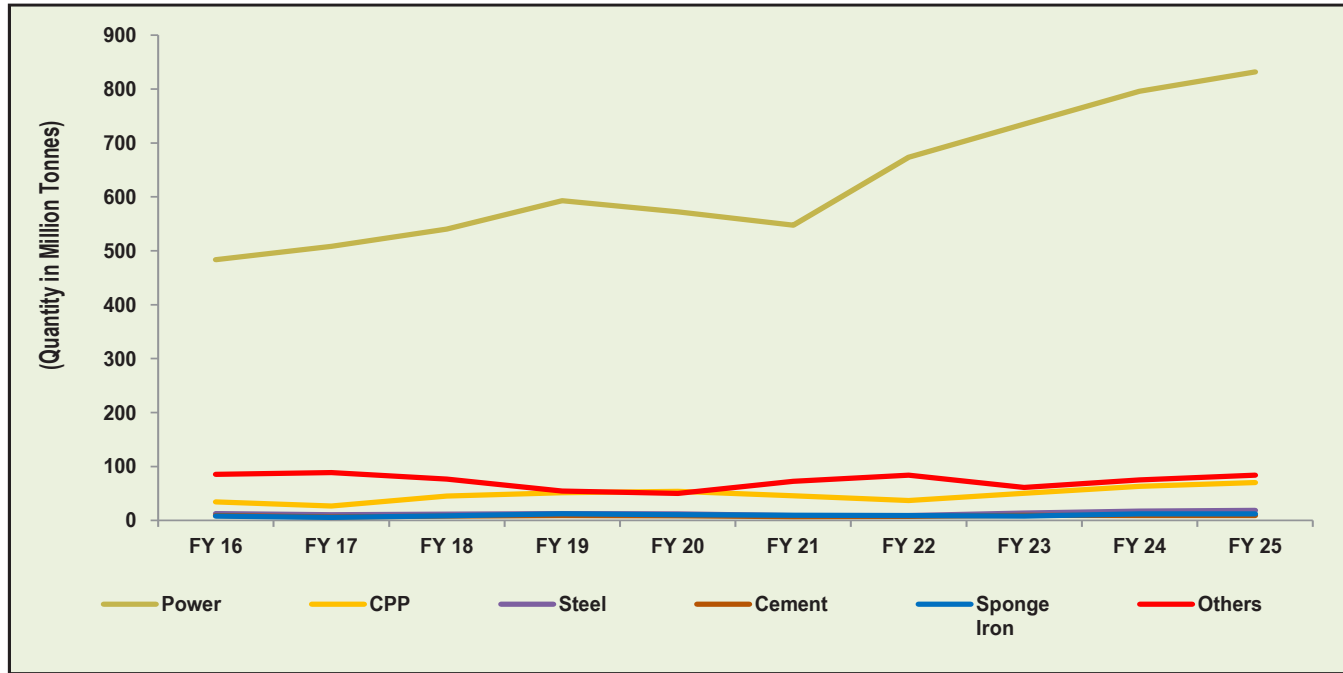

**Chart 10: Year Wise Despatch of Coal to Different Priority Sectors from FY 2015-16 to FY 2024-25**

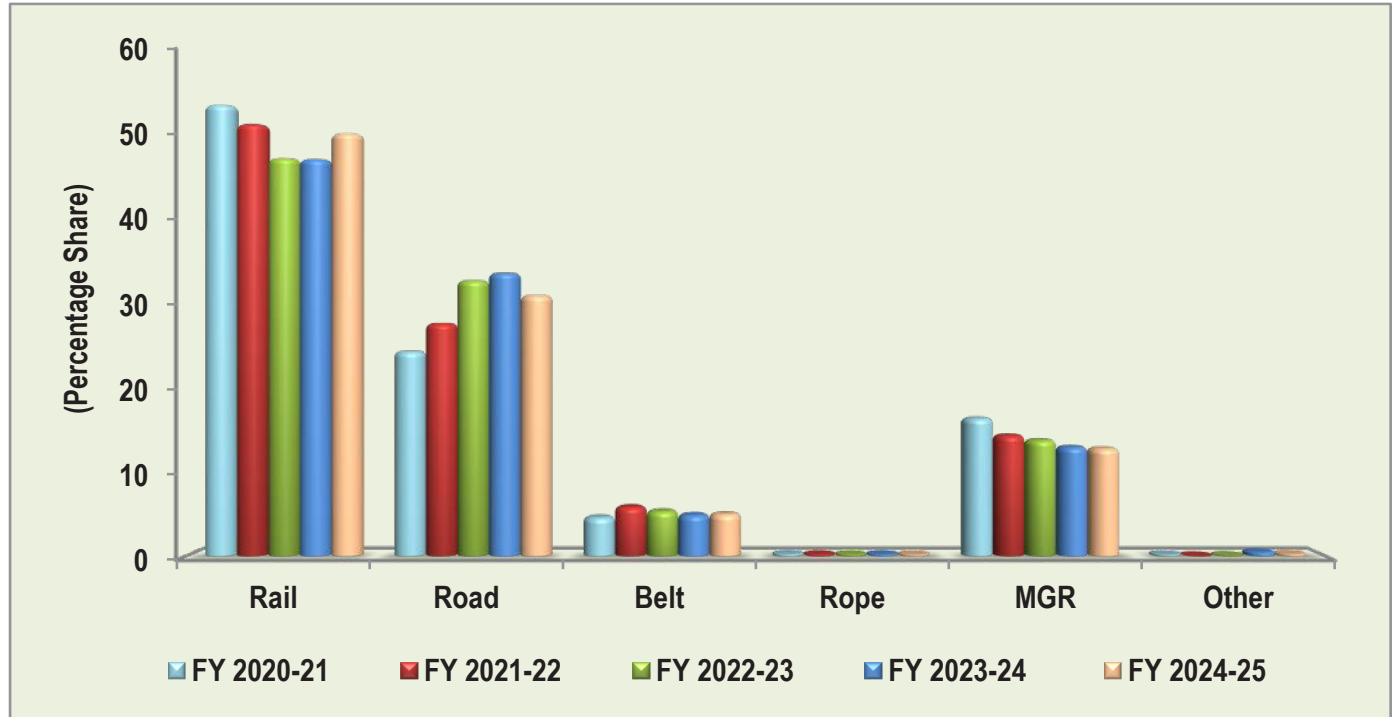

**Chart 11: Mode Wise Despatch of Coal during Last Five Years**

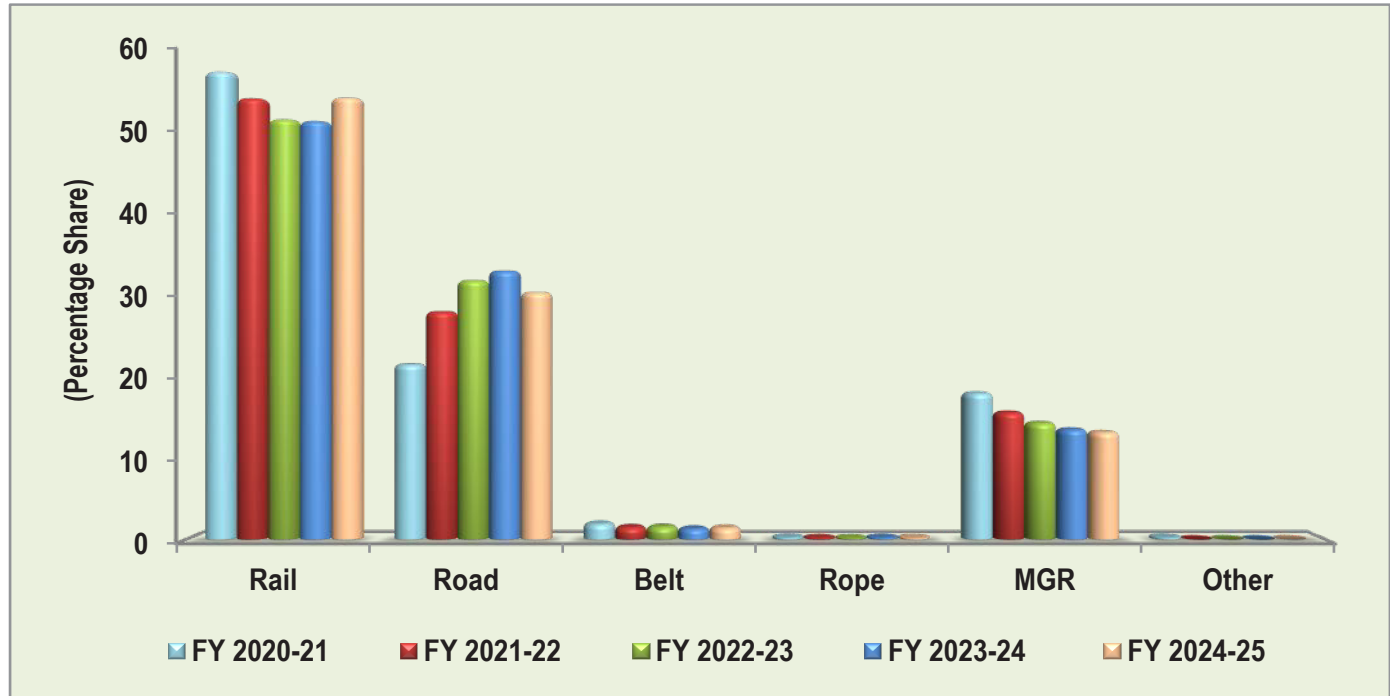

**Chart 12: CIL's Mode Wise Despatch of Coal during Last Five Years**

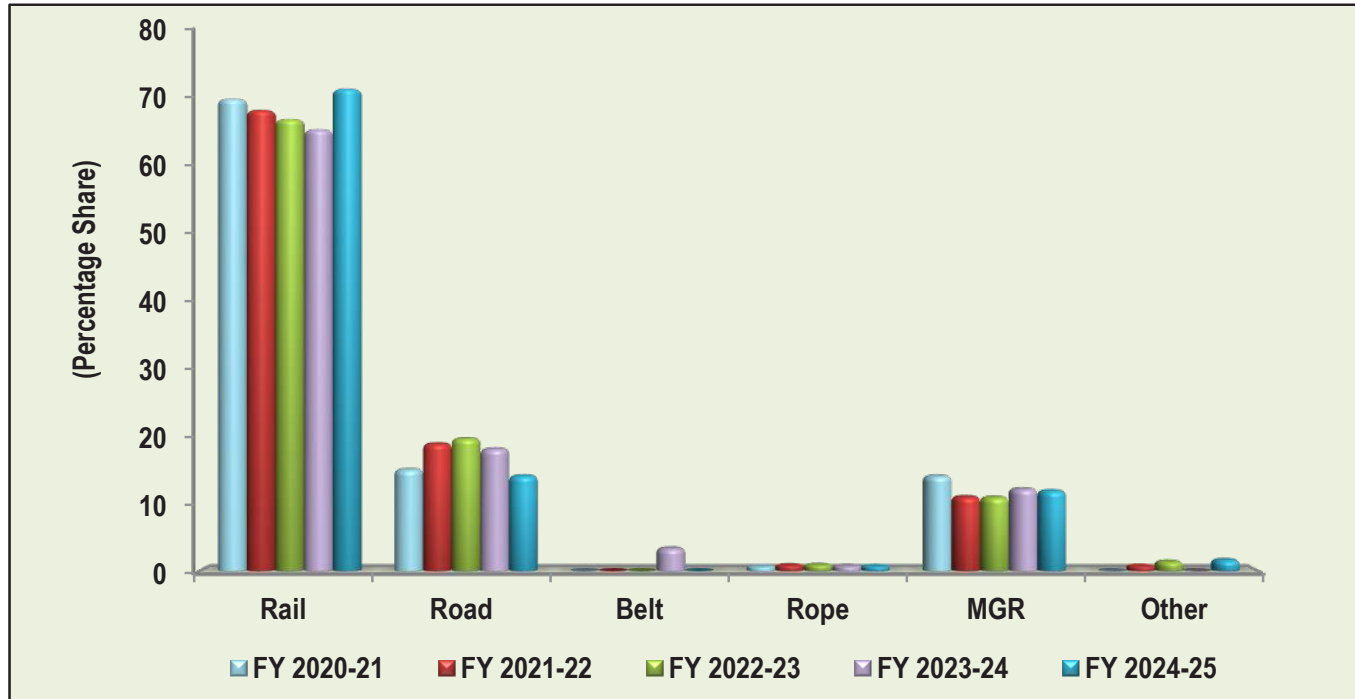

**Chart 13: SCCL's Mode Wise Despatch of Coal during Last Five Years**

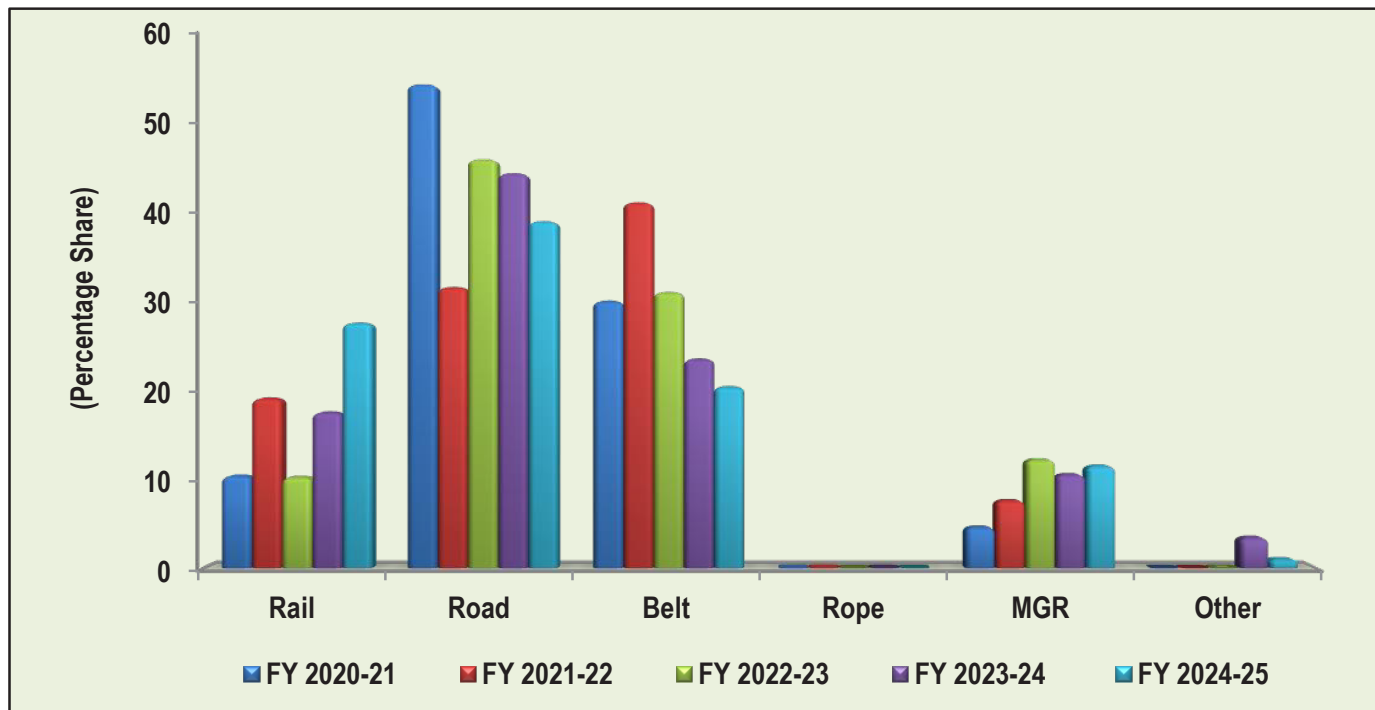

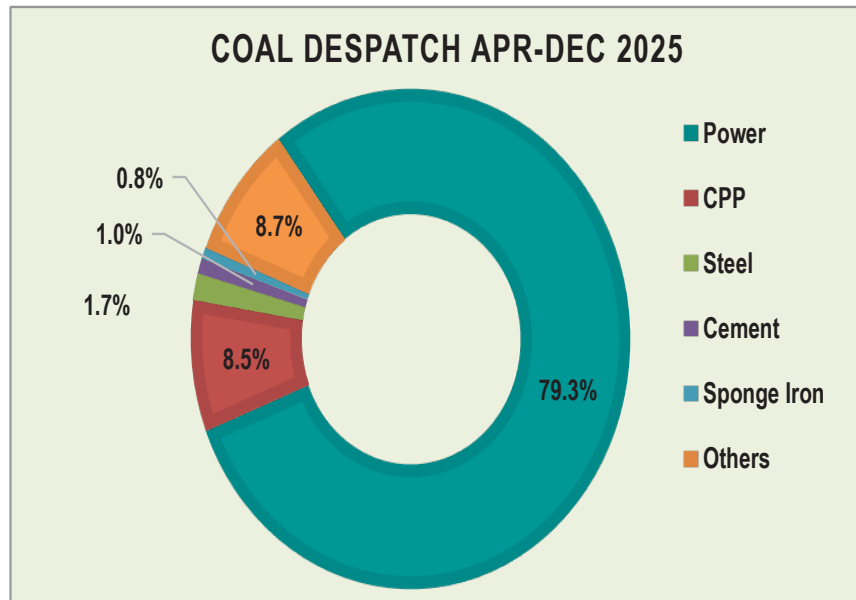
**Chart 14: Other Companies' Mode Wise Despatch of Coal during Last Five Years**

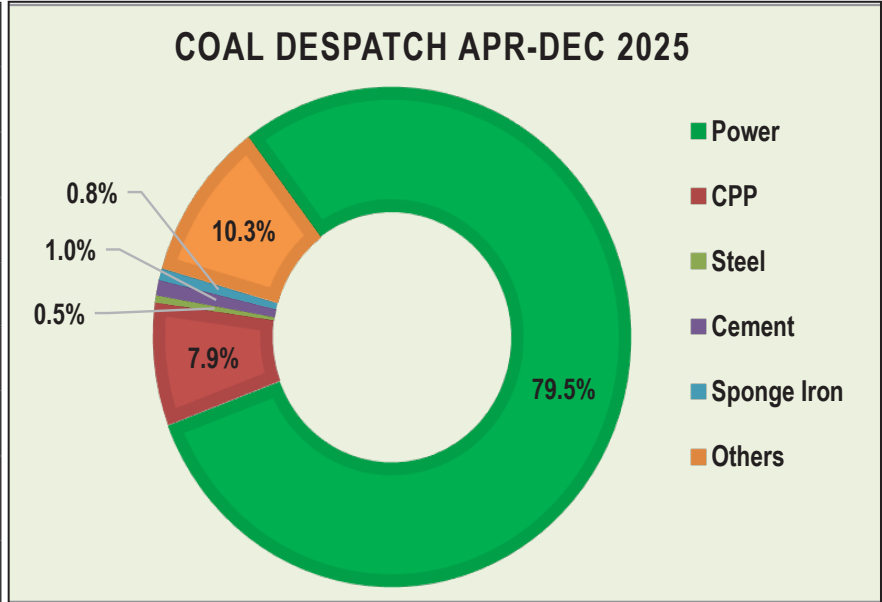

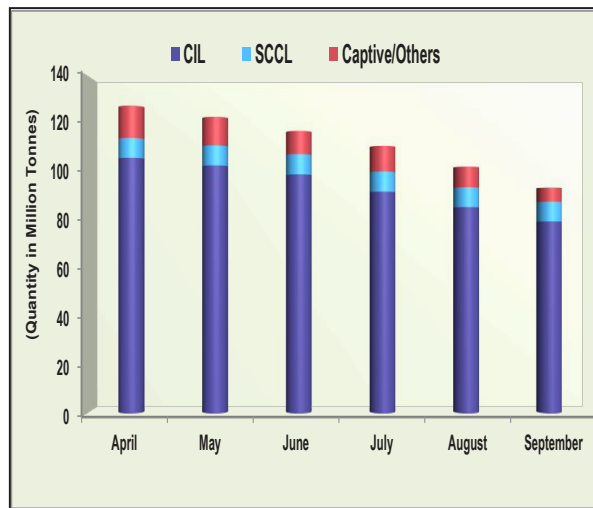

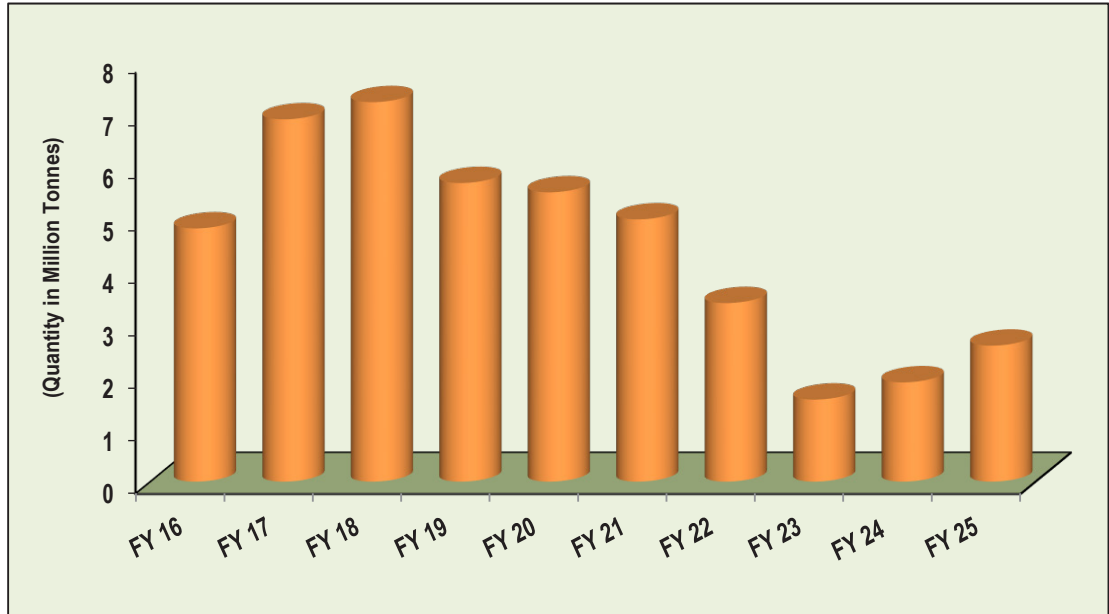

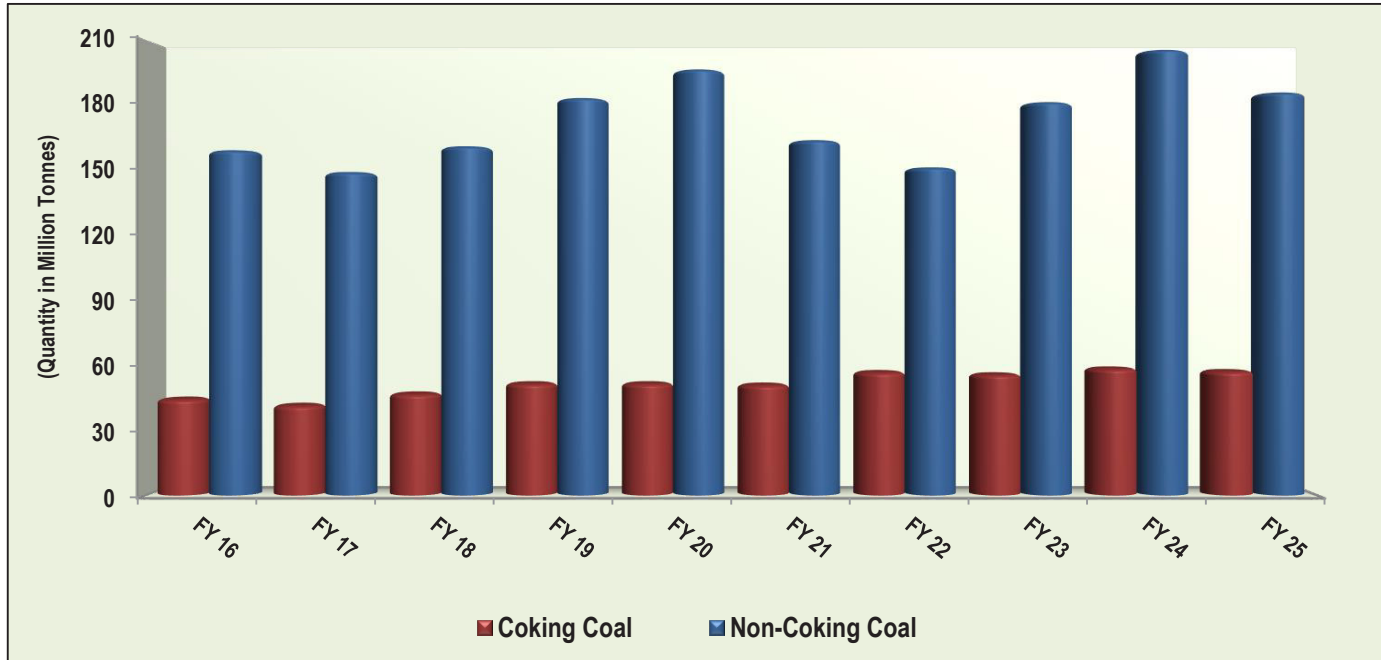

**Chart 15: Year Wise Import of Coal from FY 2015-16 to FY 2024-25**

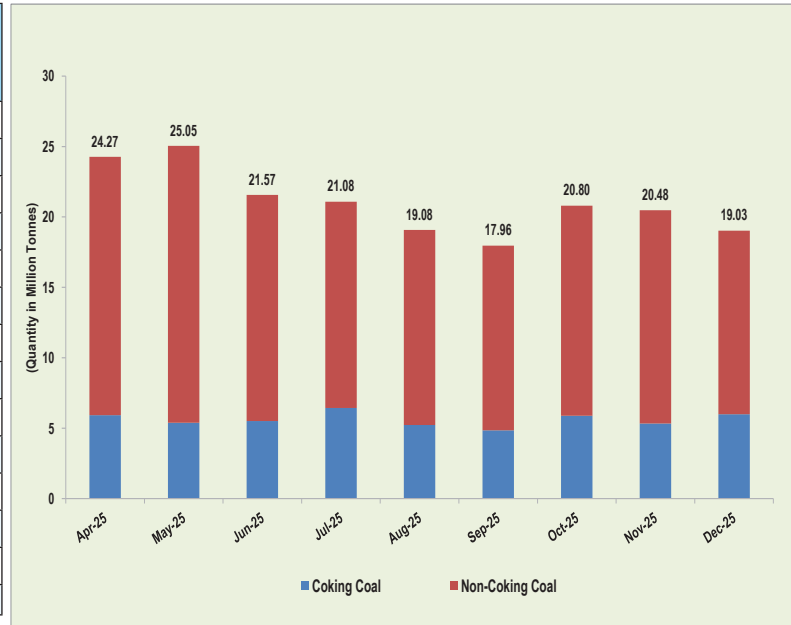

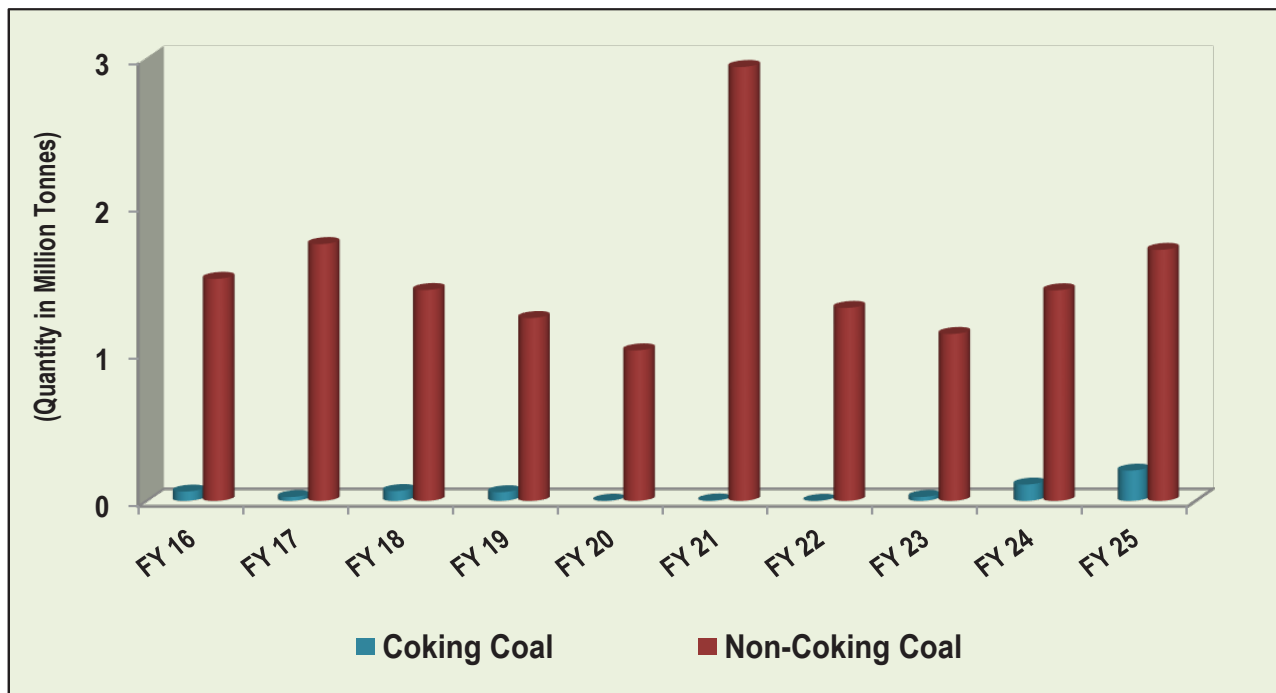

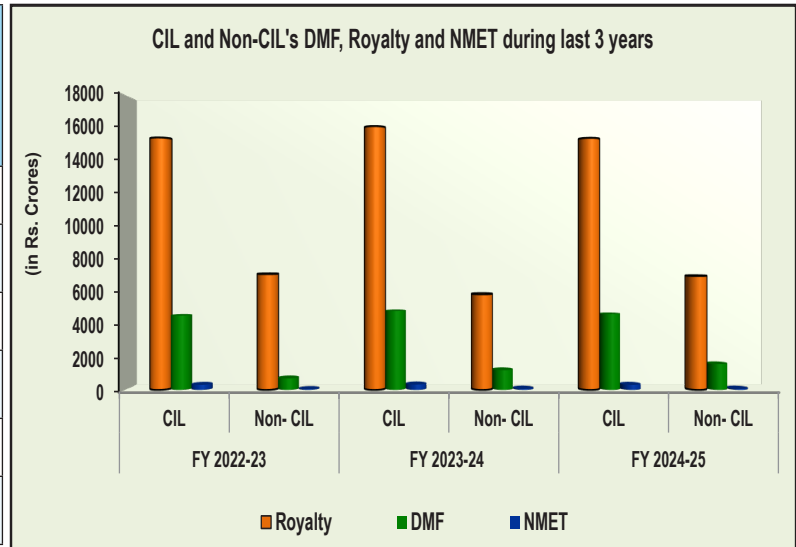

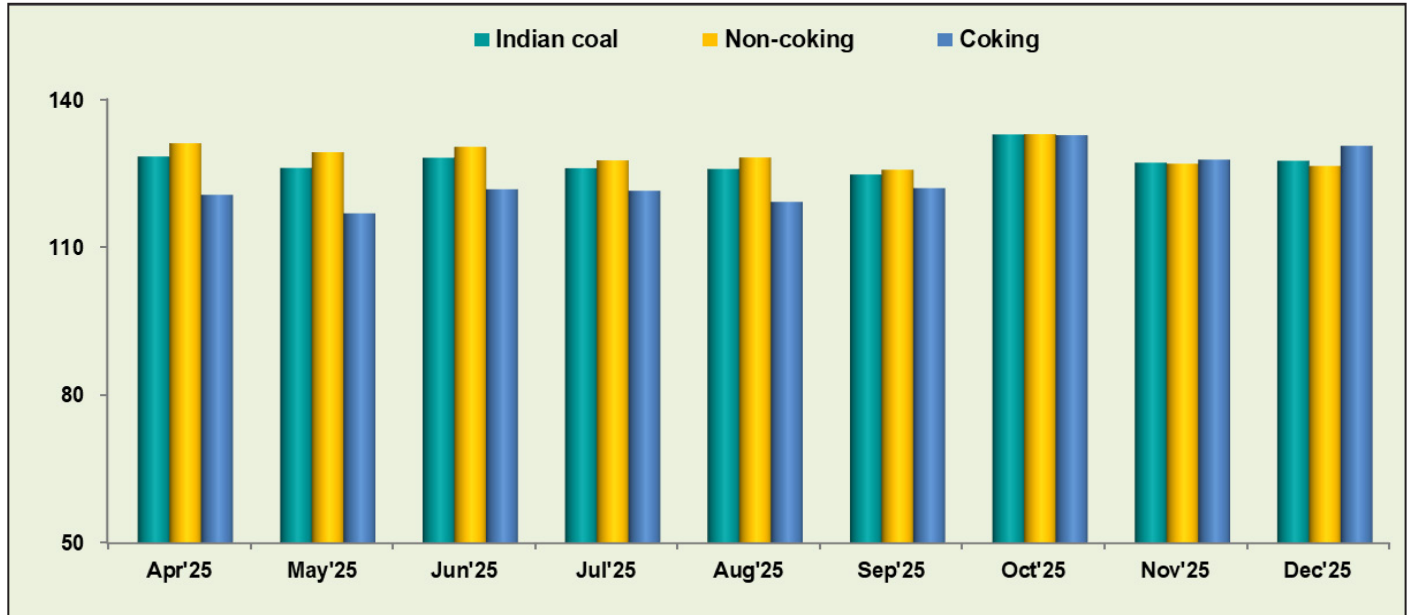

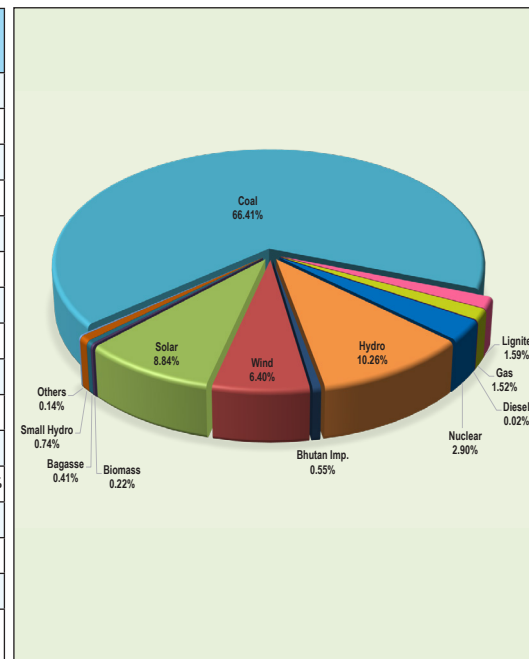
