(e) The Coal Mines (Special Provisions) Second Ordinance, 2014

The Hon'ble Supreme Court, vide its judgment/order dated 25.08.2014 and 24.09.2014, has cancelled the allocation of 204 coal blocks out of 218 coal blocks allocated since 1993.

- 2. In light of the judgment, it was considered expedient in public interest by the Central Government to take immediate action so as to ensure energy security of the country and to minimize any impact on core sectors such as steel, cement and power utilities, which are vital for the development of the nation. As Parliament was not in session and immediate action was required to be taken by the Central Government to implement the said order and to address the above objectives, the Ordinance namely, the Coal Mines Special Provisions Ordinance, 2014 was promulgated on 21.10.2014 under article 123 of the Constitution of India.
- 3. In order to replace the Ordinance, the Coal Mines (Special Provisions) Bill, 2014 with certain modifications, was introduced in the winter session of the Lok Sabha, which was considered and passed by the Lok Sabha on 12.12.2014. However it could not be taken up for consideration and passing in the Rajya Sabha.
- 4. Since Ordinance would cease to operate w.e.f. 05.01.2015, the Coal Mines (Special Provisions) Second Ordinance, 2014 was promulgated on 26.12.2014. On reassembly of Parliament, steps will be taken for withdrawal of the Coal Mines (Special Provisions) Bill, 2014 pending in Rajya Sabha and introduction of a fresh Bill to re-place the Second Ordinance.
- (c) The production of Coal from the allocated captive coal blocks for the Month of December, 2014 is 4.745 Million Tonnes. Total production of coal from captive coal blocks during the year 2013-14 was 39.485 Million Tonnes and the production upto December, 2014 in 2014-15 is 40.080 Million Tonnes. Total 40 captive coal blocks (20 Govt. & 20 Private) have come into production as on November, 2014.
