

**SEALED quotations** are invited from reputed/registered firms for award of Annual Maintenance Contract for the maintenance/repairing of electrical items, fittings & appliances installed in the Shastri Bhawan & its office located at Lok Nayak Bhawan, New Delhi as per details mentioned at Annexure - I on the terms and conditions enumerated in the following paragraphs. Only reputed firms having adequate experience of at least 05 years in the field, in the Government Ministries/Departments/Semi-Government Organizations, including Public Sector Undertaking are requested to submit their rates in the attached proforma duly completed and signed. The prospective firms also furnish a copy of the PAN, Service Tax Registration and "Experience Certificate" from their respective organizations, while submitting their quotations.

2. The sealed cover containing the quotations and supercribed "**Quotations for the maintenance/repairing of various electrical items, fittings & appliances, etc., belonging to Ministry of Coal**" may be dropped in the Tender Box mounted on the wall at garage no.21, Shastri Bhawan, New Delhi. The quotations should reach this Ministry by **1.00 P.M. on or before 21.07.2017 positively**. The quotations received after due date and time those which are not dropped in the tender box, will not be entertained at all. The tender will be opened on the same day at 3.00 P.M.

3. The Quotations should be accompanied with an earnest money of **Rs. 20,000/- (Rs. Twenty thousand only)** in the form of Demand Draft in favour of "Pay & Accounts Officer, Ministry of Coal, New Delhi", without which the quotations will not be considered. The earnest money will be returned after the contract is finalized.

4. The quotations will be opened on the same day **at 3.00 PM at Room No. 321, 'A' Wing, Ministry of Coal, Shastri Bhawan, New Delhi-110 001.** The tendcrers, if they so desire, may depute their representative to be present at the time of opening of tendcrs.

5. The Terms & Conditions of the contract will be as follows:-
- (i) **Period:** One year. The successful firm will be required to start working immediately after award of the contract. The Ministry shall, however, has the right to terminate the contract at any time without assigning any reason thereof. The period of contract can be extended for a fixed period between 1 to 3 years on the same rate and terms & conditions under Rule 150 of GFR, 2017, if the firm so desires.
  - (ii) The firm shall have to attend all complaints on receipt of information from the users directly with the prior approval of Administration Section. The services should be provided on regular basis during office hours and in case of emergency beyond office hours or holidays etc.
  - (iii) The firm will be required to undertake maintenance/repairs of Electrical equipments at Shastri Bhawan & office located at Lok Nayak Bhawan, New Delhi or any other location as decided by competent authority.
  - (iv) For payment purpose, the bills should be submitted month-wise with requisitions-wise along with the work completion report/user certificates.
  - (v) No increase in amount shall be considered at all during the full period of AMC. No other charges like transportation, fare etc. for providing the services will be payable.
  - (vi) Conditional tender will not be entertained. Similarly, quotations received after stipulated date and time will also not be considered under any circumstances.
  - (vii) The firms are also required to prove their competence for undertaking the jobs of providing required services and shall, therefor, furnish their standing and goodwill through attested certificate/documentary proof from at least five [05] Ministries/Departments. The firm shall also indicate their Registration number, Income -Tax number and PAN number.
  - (viii) The successful tenderer will be required to furnish the **security deposit of Rs.20,000/- (Rs. Twenty thousand only)** within ten days from the date of awarding the contract. The security deposit shall be in the form of Fixed Deposit with any of the scheduled Banks & pledged in favour of the undersigned, Ministry of Coal, New Delhi.

The security deposit will be refunded only after the termination of the contract, subject to the satisfactory service/performance during the period of the contract. The security deposit will be forfeited if during the period of the contract, the services of the contracted agency are found to be unsatisfactory.

- (ix) This Ministry can terminate the contract at any time without assigning any reason, if the work of the contractor is found unsatisfactory. In this respect the decision of the Ministry will be final and binding on the contractor. The Ministry reserves the right to reject any quotation in whole or in part without assigning any reason therefor.
- (x) The firms must indicate their GST Registration No., GSTIN No. (GST Identification Number), address of the registered office, phone numbers, etc.
- (xi) The rates may be quoted as per Annexure-I, Taxes (GST) if any, may be specifically and separately indicated in the quotation.

6. All the tenderers are requested to read and understand the terms and conditions of the contract as detailed out in the foregoing paragraphs before sending their quotations, as no change or violation of the aforesaid terms & conditions are permissible once the quotation is accepted by this Ministry.
