I am directed to say that the Ministry of Coal proposes to dispose off the following vehicles on "as is where is basis is":



2. Accordingly, sealed quotations are invited for the disposal of the said vehicle on the terms and conditions mentioned below. In case, you are interested in purchasing the above mentioned vehicles, you may submit your quotations in the enclosed proforma. You are required to quote offer for above vehicles, the particulars of which may be filled in the proforma. The quotations addressed to the undersigned in a sealed cover, should reach to the Ministry of Coal, Room No. 321 'A' Shastri Bhawan, New Delhi-110001 latest **by 31.08.2016 at 1:00 PM**. The cover should be prominently superscribed with "QUOTATIONS FOR PURCHASE OF CONDEMNED VEHICLE". The vehicle will be available in the premises of Shastri Bhawan, New Delhi (between Gate No.2 & 3).

3. The quotations received in time will be opened in Room No. 321 'A' 3rd floor, Shastri Bhawan, New Delhi at 4:00 PM on the same day.


4. The sale will be governed by the following conditions:

- (i) The bidder is required to pay earnest money Rs. 5,000/- for each vehicles.
- (ii) Earnest money is payable by means of Demand Draft in favour of Pay & Accounts Officer, Ministry of Coal, New Delhi.
- (iii) Quotation received without Demand Draft towards earnest money will not be considered as valid and shall not be accepted.

- (iv) The successful bidder will be required to deposit the bid amount by means of Demand Draft in favour of Pay & Accounts Officer, Ministry of Coal, New Delhi-110001 within two working days of the acceptance of bid.
- (v) The earnest money of the successful bidder(s) will be released only after he deposits the sale proceeds. Earnest money will be forfeited if he fails to honour the bid.
- (vi) The delivery of the sold vehicles will be arranged only after production/submission of proof of the residential status (Ration Card/Voter Identity Card in case of individual and Registration Certificate in case of firms etc.)
- (vii) The sold vehicles will be removed by the successful bidder (s) within 48 hours of depositing the money and at their own expenses.
- (viii) The sold vehicles will be disposed off on "as is where is" basis and no guarantee for its worthiness or quality will be given by this Ministry.
- (ix) The successful bidder (s) shall get the vehicles transferred in his own name and at his own cost expeditiously. The office will not be responsible for any lapse on his part in this regard.
- (x) The bidder (s) must ensure that they are not related to any Government official personally or by proxy.
- (xi) The bidder(s) will not be allowed to withdraw their bids, failing which their earnest money will be forfeited.
- (xii) The undersigned reserves the right to accept or reject any/all of the quotations without assigning any reason.




