OFFICE MEMORANDUM

Subject: Directions of the Central Government under Rule 14 of the Coal Blocks Allocation Rules, 2017 made under the Mines and Minerals (Development and Regulation) Act, 1957-Allocation of **Barjora South coal block-reg.**

The undersigned is directed to say that it has been decided with approval of the competent authority for allotment of **Barjora South coal block** in accordance with procedure prescribed in Rule 6 of the Coal Blocks Allocation Rules, 2017 [CBA Rules] to the Government Company or corporation under clause (a) of the proviso to section 11A of the Mines and Minerals (Development and Regulation) Act, 1957 [MMDR Act] read with clause 3(1)(b) of CBA Rules, for the purpose of 'own consumption for generation of electricity through generating station' as per clause 3(1)(c) of CBA Rules and as well as in accordance with the following broad parameters as per clause 3(1)(d) of the CBA Rules:-

- (i) *The existing generation capacity in the State.*
- (ii) *The planned/proposed generation capacity in the State.*
- (iii) *The PRC of coal blocks/mines already allocated to the State.*
- (iv) *Unmet requirement of coal vis-a-vis total thermal generating capacity, both existing and planned.*

2. It has also been decided with approval of the competent authority that CMPDIL will prepare a block dossier for the coal block as specified in rule 4 read with clause 3(1)(e) of the CBA Rules.

3. In pursuance to rule 14 of the CBA Rules and with approval of the competent authority, the Nominated Authority (Ministry of Coal) is hereby directed to conduct the allotment process of Barjora South coal block as per Rule 6 of CBA Rules, including preparation of allotment documents, issue NIA and recommend the preferred allottee after following due process.
