Subject: Transfer of compensation for Land and Mine Infrastructure in respect of Gare Palma IV/5 coal mine to the Commissioner of Payment for further disbursement to the prior allottee i.e M/s Monnet Ispat & Energy Limited.

Sir/Madam,

I am to convey the sanction of the President to the transfer of a sum of **Rs.25,71,84,265/- (Rupees Twenty Five Crore Seventy One Lakhs Eighty Four Thousand Two Hundred Sixty five Only)** to the Coal Controller's Organisation for disbursement to Monnet Ispat & Energy Limited, the prior allottee under the provisions of the Coal Mines (Special Provisions) Act, 2015 by the Coal Controller in his capacity as 'Commissioner of Payments' towards compensation for Land and Mine Infrastructure in respect of Gare Palma IV/5 coal mine.

2. It is stated that the above mentioned amount is the balance amount after adjustment of Rs 6,24,32,623/- on account of 3rd instalment of upfront amount due from M/s. MIEL as Successful Bidder i.r.o. Gare palma IV/7 coal mine under the provisions of Section 16(3) of Coal Mines (Special Provisions) Act, 2015; which is reproduced as under:-

"if the successful bidder or allottee is prior of any of the Schedule I coal mines, then, the compensation payable to such successful bidder or allottee shall be set off or adjusted against the auction sum or the allotment sum payable by such successful bidder or allottee, as the case may be, for the any of the Schedule I coal Mines".

The aforesaid amount may be transferred through RTGS to the account of Coal Controller, Coal Controller's Organisation who has been appointed as 'Commissioner of Payments' under the provisions of Section 15 (1) of the Coal Mines (Special Provisions) Act, 2015 for the purpose of the said Act vide Ministry of Coal's Order No. 22/2/2014-ASO dated 15th July, 2015 (copy enclosed as **Annexure-I**).

4. The expenditure on this account is debitable to the Head **8443.00.117.03.04.00**.
