Subject: Constitution of Inter-Ministerial Committee to advise Nominated Authority set up under the Coal Mines (Special Provisions) Ordinance, 2014 in Policy matters.

The undersigned is directed to state that the Nominated Authority created under **the Coal Mines (Special Provisions) Ordinance, 2014** is required to undertake management and re-allocation of 204 coal blocks cancelled by the Supreme Court. In discharge of its duties, the Nominated Authority is required to consult Central Government on various policy matters. The policy issues, which may come up for consideration and directions of the Central Government, would involve inputs of sectoral Ministries viz. Power, Steel and DIPP as well as concerned regulatory Ministries viz. Finance (DEA), Law & Justice (DLA). Therefore, it has been decided by the competent authority in this Ministry to constitute an Inter-Ministerial Committee (IMC) to deliberate and advise on the issues referred to it, with the following composition:-
