 - i) Persons who got Grade Pay of Rs. 5400/- and more at the time of retirement will be paid Rs. 30,000/- per month.
 - ii) Persons who got Grade Pay less than Rs. 5400/- at the time of retirement will be paid Rs. 25,000/- per month.
- 3. Consultants will be engaged initially for a period of six months which may be extended depending on the requirement.
- 4. Persons who fulfil the eligibility criteria and who are willing to join immediately, may submit their applications in the enclosed format to the Deputy Secretary (Estt), Ministry of Coal, Room No. 304-B Wing, Shastri Bhawan, New Delhi on or before 10th September, 2015.
