Subject: Settlement of claim of M/s UCO Bank (Lead Bank), Secured Creditor of prior allottee against proceeds arising out of Land and Mine Infrastructure/ compensation in respect of Moitra coal mine under section 9 of the CM (SP) Act, 2015.

Sir/Madam,

I am to convey the sanction of the President for transfer of a sum of **Rs**. **23,31,23,753**/- (Rupees Twenty Three crore Thirty One lakh Twenty Three Thousand Seven hundred and Fifty Three only) to M/s UCO Bank (Lead Bank), Secured Creditor of prior allottee towards settlement of claim against proceeds arising out of Land and Mine Infrastructure in respect of Moitra coal mine under section 9 of the Coal Mines (Special Provisions) Act, 2015 ("Act").

2. In accordance with the Act and the Coal Mines (Special Provisions) Rules, 2014 ("Rules"), the Nominated Authority had issued notices dated March 12, 2015, April 22, 2015, September 17, 2015, December 15, 2015 and June 02/03, 2016 inviting claims from Secured Creditors/Government Authorities in respect of Schedule I coal mines.

3. In pursuance of the aforesaid notices, M/s UCO Bank has lodged its claims in respect of Moitra coal mine.

4. It may be mentioned that Nominated Authority on 12.09.2016 had published mine wise provisional list of admissible compensation amount in respect of 35 coal mines, including Moitra coal mine. The Successful Bidder of the mines, M/s JSW Steel Ltd., was informed regarding the same vide an email dated 14.09.2016 and was requested to offer their observation, if any. The Successful Bidder vide email dated 19.09.2016 has raised certain objections to the release of amount of compensation for land and mine infrastructure in favour of the prior allottee of the coal mine, M/s. Jayaswal Neco Industries Ltd./its secured creditors giving details of difficulties faced by them.

5. In order to examine the matter, the Nominated Authority called the Successful Bidder as well as Prior Allottee of the coal mine for a hearing on 25.11.2016. Thereafter, the Nominated Authority has passed a speaking order bearing no. 110/9/2015/NA (Part-I) dated 09.12.2016 (copy enclosed) after due examination of the matter.

6. The amount of compensation for Land and mine infrastructurefor Moitra coal mine has been calculated as **Rs. 25,95,90,113/-** and **NIL**, respectively. In accordance with the speaking order, an amount of Rs. 1,30,67,200 (compensation for disputed land) and Rs. 1,33,99,160 ('incremental compensation' on such disputed land) is required to be withheld. Remaining compensation for any other land vested as well as mine infrastructure, if any, is to be released after settlement of admissible claims in accordance with the provisions of the Act. Accordingly, out of total compensation, Rs. 23,31,23,753/- can be released at present.

8. The accepted claim of M/s UCO Bank against the said mine is Rs. 53,55,17,070/- whereas amount of compensation for release at present is Rs. 23,31,23,753.00/-. Accordingly, Rs. 23,31,23,753.00/- has been decided for release in favour of M/s UCO Bank.

9. The aforesaid amount of **Rs. 23,31,23,753.00/-** may be transferred through RTGS to the account of M/s UCO Bank details of which are as under:
