AGENDA FOR 32ND MEETING OF INTER-MINISTERIAL GROUP [IMG] TO BE HELD ON 30.09.2015

The issue of deduction / release of bank guarantee (BG) submitted by the prior allocatees of 50 coal blocks is being reviewed by the IMG/Government. BG calculation details in respect of 11 coal blocks have been received from the Coal Controller Organisation (CCO). BG has been calculated by the CCO by taking the following factors into consideration :

- (a) Conditions of allocation letter.
- (b) Delay attributable to Government or Government agencies (whether Centre or State) and delay on the part of prior allottee(s).
- (c) Delay attributable to prior allottee(s) has been proportionately calculated i.e. 10% deduction for delay of every 3 months against the weightage/marks given for the respective milestone.

BG calculation details prepared by the CCO will be placed for consideration of the IMG in the 32nd meeting for making recommendations to the Government.

2. In addition, based on the recommendations of the IMG in its 31st meeting and its acceptance by the Government, vide letter dated 04.08.2015, Ministry of Coal withdrew the show cause notice dated 16.01.2015 issued to the prior allottees of Radhikapur (East) coal block and communicated that the deduction/forfeiture of the bank guarantees shall be made as already ordered by the Ministry of Coal vide its order dated 23.11.2012. One of the prior allottees of Radhikapur (East) coal block, viz. M/s. Tata Sponge Iron Ltd., challenged Ministry of Coal's above-mentioned letter dated 04.08.2015 before Hon'ble Delhi High Court wherein the Hon'ble Court vide order dated 12.08.2015 *inter alia* directed the Government to pass a fresh order regarding deduction / release of BG after affording an opportunity to the petitioner within 8 weeks from the date of order. In compliance with Hon'ble Delhi High Court's order dated 12.08.2015, M/s. Tata Sponge Iron Ltd. will be granted an opportunity of making presentation before the IMG.
