
**Subject: Cancellation of allocation of Kudanali-Luburi Coal Block allocated jointly to M/s. NTPC Limited and M/s. Jammu Kashmir State Power Development Corporation Ltd. under the MMDR Act, 1957 - reg.**

Sir,

I am directed to refer to NTPC Ltd.'s letter No. Nil dated 30.01.2019 and Power Development Department, Government of Jammu & Kashmir's letter No.PDD/IV/162/2006-Part-II dated 06.06.2019 on the above mentioned subject and to inform that these requests have been considered in the Ministry of Coal and it has been decided, with the approval of Competent Authority in Ministry of Coal, to cancel the allocation of Kudanali-Luburi coal block allocated jointly to M/s. NTPC Limited and M/s. Jammu Kashmir State Power Development Corporation Ltd. (JKSPDC) vide this Ministry's allocation letter No.13016/26/2004-CA-I/CA-III(Pt.)(Vol.II) dated 31.03.2015 under MMDR Act.

There is no provision under MMDR Act, 1957 and Rules made there under to allocate a fresh coal block in lieu of a cancelled coal block. NTPC Ltd./JKSPDC may apply afresh for allocation of coal block as and when a public notice is issued by the Ministry of Coal/Nominated Authority for allocation of coal blocks under MMDR Act.
