### Request for Proposal

#### “Invitation of Proposal for selection of Transaction Advisor”

In exercise of the powers conferred by section 6 (2) of the Coal Mines (Special Provisions) Act, 2015 (CMSP Act) and in accordance with the Rule 6 of Coal Mines (Special Provisions), Rules, 2014, as well as Rule 14 of the Coal Blocks Allocation Rules, 2017 framed under the Mines and Mineral (Development and Regulation) Act, 1957(MMDR Act), the Nominated Authority on behalf of the Government of India had published RFP on 23.05.2018 for selection of Transaction Advisor who shall provide the services to the Nominated Authority and the Central Government for assisting in allotment and auction of coal mines and coal blocks under the CMSP Act and MMDR Act respectively.

Based on the views received during Pre- Proposal Conference on 04.06.2018, the original RFP has been revised and published again. The start date for downloading of the Revised RFP is 08.06.2018.

Accordingly, proposals are invited as per the Revised RFP in supersession to the original RFP in digital format only from eligible companies for short listing of Qualified Applicants and selection of Transaction Advisor.
