Sir / Madam,

I am directed to refer the subject mentioned above and to say that a sanction letter dated 13th March, 2020 was issued in the previous Financial year 2019-20 to Cash Section to release the payment of an amount of Rs.13,84,60,413/- in favour of Commissioner of Payment for further disbursal to the prior allottees. The same was left unattended due to certain unavoidable circumstances and unfortunate death of the then DDO due to COVID-19.

2. As the payment could not made to the allottees, a case was filed by an allottee of Brahampur Coal Mine in which, Hon'ble Court directed to expeditiously release the cost (Rs.4,92,52,145/-) of GR to prior allottee. Accordingly, another sanctioned letter dated 26.10.2020 was issued in the current financial year against which the payment of Rs.13,84,60,413/- has been made to Commissioner of payments vide URT No.203030003909 dated 28.10.2020 for further disbursal of the same.

3. Accordingly, it is to be clarified that the Sanction letter dated 26.10.2020 has been issued in supersession of Sanction Letter dated 13.3.2020.
