ORDER

Subject: Determination of compensation for land and mine infrastructure payable to the prior allottees of Rajhara North Central & Eastern Coal Mine, viz. M/s Mukund Limited and Vini Iron & Steel Udyog Limited in terms of the Coal Mines (Special Provisions) Act, 2015 and Judgment dated March 09, 2017 passed by Hon'ble High Court of Delhi – Reg.

Rajhara North Central & Eastern Coal Mine was previously allotted to M/S Mukund Limited and Vini Iron & Steel Udyog Limited. After cancellation, the said mine was allotted to M/s. Fairmine Carbons Pvt. Ltd on March 03,2021. The compensation for Cost of Geological Report ("GR") and Cost of Consents ("CC") have been released to the prior allottee vide sanction letter dated May 10, 2021 (Copy of letter attached), i.e. mentioned below in tabular form marked as 'A':-

The above compensation of GR and CC cost are in addition to and are separate from compensation of land and mine infrastructure as provided under Section 16 of the Act.

- 2. Vide letter reference no MoC/Rajhara/2021/003 dated 26th May 2021, M/s Mukund Limited and Vini Iron & Steel Udyog Limited submitted its revised claim for land and mine infrastructure. In the said letter prior allottee mentioned that no land acquisition has been made by them and assets of coal block showed zero figure.
- 3. The details of mine infrastructure were forwarded to Central Mine Planning and Design Institute Ltd. (CMPDIL) for classification and CMPDIL has not classified any item mentioned by prior allottee as 'Mine infrastructure' and thereafter O/o Chief Advisor (Cost) re-valued compensation, keeping in view of statutory auditor's certificate of the quarter ending 31.03.2015 and has submitted its Report No.8808 dated July 29, 2021 for the amount of Rs. NIL/- (copy of report enclosed).
- 4. So far as claim of prior allottee is concerned, it is entitled to get compensation for land and mine infrastructure up till March 03, 2021 i.e. when Rajhara North Central & Eastern Coal Mine was vested to M/s. Fairmine Carbons Pvt. Ltd. However, in view of above paragraph 3, the claim of compensation by M/s Mukund Limited and Vini Iron & Steel Udyog Limited regarding land and mine infrastructure pertaining to Rajhara North Central & Eastern Coal Mine is determined as NIL/-.
- 5. The above final determination of compensation for land and mine infrastructure in relation to Rajhara North Central & Eastern Coal Mine is being made. However, in case any objection is raised by prior allottee- M/s Mukund Limited and Vini Iron & Steel Udyog Limited or by present allottee of the coal mine i.e. M/s. Fairmine Carbons Pvt. Ltd an opportunity of hearing is given as per OM dated November 16, 2018, the same would be examined and a further determination would be made, if required. M/s Mukund Limited and Vini Iron & Steel Udyog Limited and M/s. Fairmine Carbons Pvt. Ltd. are hereby called upon to present their comments/ objection if any on the above determination on August 13,2021 at 15:00.
- 6. In accordance with Section 27 of the Act and the judgment dated March 09, 2017, it is open to M/s Mukund Limited and Vini Iron & Steel Udyog Limited and M/s. Fairmine Carbons Pvt. Ltd. to raise disputes with regard to the quantum of compensation before the Tribunal constituted under the Coal Bearing Areas (Acquisition and Development) Act, 1957.
