Sir,

Please refer to the letter of even number dated 30.06.2020 issued by Ministry of Coal wherein extension was granted for one year till 30.06.2021 with the approval of Department of Expenditure, Ministry of Finance. In this regard please refer to the letters of even number dated 27.04.2021 and 07.07.2021 of the Ministry in reply to which comments provided by you were forwarded to Department of Expenditure, Ministry of Finance for concurrence of the extension beyond 30.06.2021 for two years. DoE accordingly agreed with the extension for the tenure of the Special Tribunal with effect from 01.07.2021 to 30.06.2023 for the Special Tribunal along with the supporting staff (Stenographer – 01, Junior Clerk – 01 [filled up post]). Accordingly, the approval of the competent authority is conveyed to the extension of tenure beyond 30.06.2021 **for a period of two years with effect from 01.07.2021 to 30.06.2023** of the Special Tribunal, Nagpur constituted temporarily under Section 14 (2) of CBA (A&D) Act, 1957.

The matter as regards the three other posts [One Junior Clerk, One Driver (deemed abolished posts against which the appointments made were invalidated by the letter of even number dated 09.03.2021) and the post of One Peon (vacant after removal)] is being dealt with in consultation with Department of Legal Affairs, Ministry of Law & Justice.

3. The expenditure involved is to be borne/paid by the Coal India Limited or its subsidiary concerned under the delegated powers as notified by the Ministry of Coal in 2017 under CBA (A&D) Act, 1957, without referring the matter to the Ministry of Coal for any verification/check.
