

In pursuance of Order dated January 04, 2022 tentatively determining the disbursal of compensation to prior allottee of Jogeshwar and Khas Jogeshwar coal mine, both prior allottee, M/s Jharkhand State Mineral Development Corporation Limited (JSMC Ltd.) and present allottee, M/s South West Pinnacle Exploration Limited (SWPE Ltd.) were called upon January 11, 2022 at 11:00 a.m. to present their comments/objection, if any, on the determination made by the Nominated Authority.

Accordingly, both prior allottee, M/s Jharkhand State Mineral Development Corporation Limited (JSMC Ltd.) and present allottee, M/s South West Pinnacle Exploration Limited (SWPE Ltd.) attended the meeting on January 11, 2022 and accepted the claim of compensation of Cost of Geological Report ("GR"), Cost of Consents ("CC"), land and Mine infrastructure as determined by the Nominated Authority vide order dated January 04, 2022, which is reiterated as under:-
