Subject: E-Payment of Rs. 88,82,89,346/- in compliance of court order dated 11.04.2022 in WP 5940/2022 before High court of Delhi in respect of Tokisud North coal mine.

Sir/Madam,

Vide order dated 16.03.2022 the Nominated Authority had determined a sum of Rs.88,82,89,346/- payable to M/s. GVK Power (Goindwal Sahib) Limited in lieu of compensation towards land and mine infrastructure in respect of Tokisud Coal Mine. However, the said order was challenged by the secured creditors of M/s. GVK, i.e., IDBI Bank in WP No. 5940/2022 before High Court of Delhi. The High Court, vide its order dated 11.04.2022 has directed that the said amount be deposited in an interest bearing account opened and maintained by the Registrar General of the Court.

2. In compliance of the directions received in order dated 11.04.2022, the Registrar General of High Court of Delhi was requested to provide the account details wherein the amount is to be deposited vide letter dated 13.04.2022. In response to the said letter, the Registrar General, vide e-mail dated 20.04.2022 has shared the account details
