<u>Monthly Summary for the Cabinet for the month of August, 2023 in respect of</u> <u>Ministry of Coal</u>

Principal Activities

The core objectives of the Ministry of Coal are to augment coal production by adopting state-of-theart clean-coal technologies; enhancing exploration efforts with thrust on increasing proven coal resources and developing necessary infrastructure for prompt evacuation of coal for securing its availability to meet the demand of different sectors of the economy in an eco-friendly and sustainable manner.

Important achievements

Steps taken for sustained production of coal:

- (i) A meeting was taken by Empowered Committee of Secretaries (ECoS) on 03.08.2023 for certain matters pertaining to auction methodology and associated matters, issue in operationalization of blocks allocated for sale of coal.
- (ii) Vesting order was issued for 1 mine (Namchik Namphuk) on 17.08.2023 by the Additional secretary & Nominated Authority.
- (iii) Production in August, 2023 from mines allocated under CM (SP) Act, 2015 is 9.8653 MT.
- (iv) Revenue in August, 2023 from mines allocated under CM (SP) Act, 2015 is Rs. 343.72 Crores.
- (v) Directions have been issued for declaration of successful bidder and issuance of Vesting Order in respect of 01 coal mines, namely North Dhadu (Western Part) auctioned for sale of coal under the provisions of CMSP Act, 2015.
- (vi) Total production of coal from the allocated captive coal blocks for the month of August, 2023 is 10.566 MT (Provisional), out of which, aggregate coal production of those coal blocks which have not been cancelled by the Hon'ble Supreme Court viz. Pakri Barwadih (1.321 MT), Tasra (0.053 MT) and Moher & Moher Amlori Extn. (1.324 MT) is 2.698 MT (Provisional)

Report on Progress: Details of progress in coal production, dispatch, e-auction of Coal viz-a viz target for the month of **August**, **2023** is given below-

- Overall domestic coal production in the month of August, 2023 was **68.37 MT** as against **58.09 MT** in the month of August, 2022, registering a growth of about **17.70%**. It includes coal production of **52.31 MT** by CIL, **5.02 MT** by SCCL and **11.04 MT** by Captive & Other mines.
- Overall domestic coal dispatch in the month of August, 2023 was **75.11 MT** as against **63.21 MT** in the month of August, 2022, registering a growth of about **18.83%**. It includes dispatch of **59.01 MT** by CIL, **5.36 MT** by SCCL and **10.74 MT** by Captive & other mines.
- Overall domestic coal supply to Power Sector in the month of August, 2023 by CIL and SCCL was **51.93 MT** as against **46.92 MT** in August, 2022.

• The outstanding dues payable by Power Sector to CIL and SCCL as on **31.08.2023** are ₹ **15,655.26 crore** and ₹ **6168.54 crore** respectively (Provisional).

Promotional Drilling: The programme for Promotional (Regional)/NMET drilling comprising 2.00 lakh meters (coal -1.95 lakh metres and lignite -0.05 lakh metres) was drawn up in Annual Plan 2023-24 of CMPDI. The programme is under execution by MECL, DGMs of Nagaland & Assam and CMPDI.

As against this, the achievement of drilling upto August 2023 is 0.50 lakh metre, against the target of 0.70 lakh metre, which is 71% of the target.

Overall Progress of Detailed Drilling in 2023-24: For 2023-24, annual plan target of 7.50 lakh metre of drilling (Departmental: 3.80 lakh metre, Outsourcing: 3.70 lakh metre) has been kept. As against this, 3.07 lakh metre of drilling has been carried out upto August 2023 against the target of 2.84 lakh metre, which is 108% of the target.

Coal Mines Pension Scheme (CMPS), 1998: It has been decided to provide life time pension to disabled children of CMPF pensioners by amending paragraph 13 of Coal Mines Pension Scheme (CMPS), 1998.
