@ A provision of ₹ 450 crores kept at BE 2023-24 for Central Sector Scheme of Exploration of Coal & Lignite has been reduced to ₹ 430 crores at RE 2023-24 and it will be met through NMET funds (through recovery).

During the financial year 2022-23; ₹ 497.09 crores was utilized against the allocation of ₹ 547.88 crore at RE. The un-utilized amount in financial year 2022-23 was mainly due to mandatory provisions for the North-East Region under Central Sector Schemes.

The utilization of funds during the financial year 2023-24 was ₹ 433.17 crores (upto December, 2023) against the allocation of ₹ 619.04 crores at RE stage.

For FY 2024-25, the allocation has been kept at ₹ 922.55 crores at BE. Out of which, ₹ 843.50 crores is allocated

for Central Sector Schemes, Rs. 10.11 crore is allocated for Government contribution towards Coal Mines Pension Scheme (CMPFO), and the remaining amount of ₹ 68.94 crores is allocated for Secretariat (MOC), Nominated Authority, Coal Controller Organization.
