FINAL ORDER

Subject: The Coal Mines (Special Provision) Act, 2015 and the Hon'ble High Court of Delhi judgment dated March 09, 2017- Valuation of compensation towards Cost of Geological Report (GR), Cost of Consents (CC), Land & Mine Infrastructure payable to M/s Gujarat State Electricity Corporation Limited (prior allottee-2) in respect of Gare Palma Sector-I Coal Mine.

In pursuance to Provisional Order dated February 26, 2024, both, prior allottee, M/s Gujarat State Electricity Corporation Limited (M/s GSECL) and successful allottee, M/s Jindal Power Limited (JPL) were called upon February 29, 2024 at 04:00 PM to present their views/objections, if any, on the determination made by the Nominated Authority.

- 2. Further, the meeting was rescheduled to February 29, 2024 at 03:00 P.M. Accordingly, both, prior allottee, M/s Gujarat State Electricity Corporation Limited (M/s GSECL) and present allottee, M/s Jindal Power Limited (JPL) attended the meeting (the list of attendees is enclosed as Annexure-1).
- 3. Subsequently, M/s GSECL (prior allottee) and M/s JPL (successful allottee) accepted the provisional compensation of Cost of Geological Report ("GR"), Cost of Consents ("CC"), land and Mine infrastructure as determined by the Nominated Authority vide order dated February 26, 2024, which is reiterated as under:-

- 4. In view of above, it is decided that valuation of compensation for Cost of Geological Report, Cost of Consents, Land and Mine Infrastructure stands settled as mentioned above.
- 5. Furthermore, based on the above determination, the remaining amount of ₹ 42,83,50,014/[₹ 1,10,41,75,654.40/- (fixed amount deposited by M/s JPL excluding CMPDIL expenses) minus

- ₹ 67,58,25,640/- (compensation amount to M/s GSECL)] will be returned to the successful allottee (M/s JPL).
- 6. In accordance with Section 27 of the Act and the judgment dated 09.03.2017, it is open to M/s. GSECL and M/s. JPL to raise disputes with regard to the quantum of compensation before the Tribunal constituted under the Coal Bearing Areas (Acquisition and Development) Act, 1957.
