FINAL COMPENSATION ORDER

Subject: The Coal Mines (Special Provisions) Act, 2015 and Hon'ble High Court of Delhi, Judgment dated March 09, 2017– Valuation of Compensation for payment to prior allottee M/s Jharkhand State Mineral Development Corporation Limited - Reg, for Patal East (Eastern Part) coal mine.

In accordance with the Provisional Compensation Order dated June 03, 2024, M/s Jharkhand State Mineral Development Corporation Limited (JSMDC) and M/s RCR Steel Works Private Limited (RCR) were requested to present their comments or objections, if any, regarding the compensation amount determined by the Nominated Authority, on June 07, 2024, at 16:00.

- 2. Both allottees attended the meeting on June 07, 2024 (the list of participants is at Annexure-I) and accepted the compensation as determined in the provisional compensation order by the Nominated Authority. Furthermore, M/s JSMDC and M/s RCR have provided their written acceptance of the aforementioned Provisional Compensation Order covering the cost of the Geological Report, Consents, Land, and Mine Infrastructure via letters dated June 05, 2024 and June 04, 2024, respectively. They have also requested the Nominated Authority to disburse the compensation at the earliest.
- 3. In light of the above, the compensation determined in the provisional order dated June 03, 2024, stands final, and the directions of the provisional order are as follows:

A. The prior allottee, M/s JSMDC, is entitled to Rs 9,98,56,196.45/- for the cost of the Geological Report, while the compensation for Consents, Land, and Mine Infrastructure is determined as NIL.

- B. The successful allottee, M/s RCR, is entitled to a refund of the excess amount of Rs 10,44,43,803.55/- deposited for the fixed cost of the Geological Report, Consents, Land, and Mine Infrastructure.
- 4. In accordance with Section 27 of the Act and the judgment dated March 09, 2017, M/s JSMDC and M/s RCR may raise disputes regarding the quantum of compensation before the Tribunal constituted under the Coal Bearing Areas (Acquisition and Development) Act, 1957.
