**FINAL COMPENSATION ORDER -1**

**Subject:** The Coal Mines (Special Provisions) Act, 2015 and Hon'ble High Court of Delhi, Judgment dated March 09, 2017- Valuation of Compensation payable to prior allottee, M/s MJSJ Coal Limited pertaining to Cost of Geological Reports (GR), Cost of Consent (CC), Mine Infrastructure in respect of Utkal A coal mine.

In pursuance to the Provisional Compensation Order dated July 08, 2024, both the prior allottee, M/s MJSJ Coal Limited and Successful Allottee, M/s Mahanadi Coalfields Limited (MCL) were called on July 12, 2024 at 4.00 PM, to present their comments / objections, if any, on the determination made by Nominated Authority.

2. It is pertinent to mention that, prior to cancellation of the coal blocks by the Hon'ble Supreme Court of India, Utkal A coal mine was allotted to M/s Mahanadi Coalfields Limited, M/s JSW Steel Limited, M/s Jindal Thermal Power Company Limited (now JSW Energy Limited), M/s Jindal Stainless Steel Limited, and M/s Shyam DRI Limited (now Shyam Metalics and Energy Limited) vide Allotment Order dated 29.11.2005. Subsequently, these allottees established M/s MJSJ Coal Limited through a Joint Venture Agreement executed on 12.11.2007, which is existing as on date.

3. Accordingly, both prior allottee, MJSJ Coal Limited and Successful allottee, M/s MCL attended the meeting on July 12, 2024 and accepted the compensation of Cost of Geological Report ("GR"), Cost of Consents ("CC"), and Mine infrastructure determined by the Nominated Authority in Provisional Compensation Order dated July 08, 2024.

4. In view of the above, compensation towards Cost of Geological Report ("GR"), Cost of Consents ("CC"), and Mine infrastructure in respect of Utkal A coal mine stands final and settled as mentioned in below table 'A'



5. However, in case of compensation claims pertaining to the Utkal A coal mine, land has been notified under the Coal Bearing Areas (Acquisition and Development) Act, is under consideration of Nominated Authority (MoC). The determination of compensation for the land will be finalised in due course of time and a separate order will be issued.

6. In accordance with section 27 of the Act and the judgement dated 09.03.2017, it is open to prior allottee, MJSJ Coal Limited and Successful allottee, M/s MCL to raise disputes with regard to the quantum of compensation before the Tribunal constituted under the Coal Bearing area (Acquisition and Development) Act 1957.
