The words and expressions beginning with capital letters and defined in this RFP shall, unless the context otherwise requires, have the meaning hereinafter respectively assigned to them:

- 1.1.1 "Agreement" shall mean the agreement entered into between the Ministry of Coal and the Institution selected under this RFP;

2 Introduction

- 2.1.1 The Ministry of Coal is considering "Evaluation study of the Central Sector Schemes for their continuation beyond 2025-26" for which an Institution would be selected by the Ministry of coal under the instant RFP.
- 2.1.2 Accordingly, this RFP is being issued by the Ministry of Coal for selecting Institution for Evaluation study of the Central Sector Schemes for their continuation beyond 2025-26 and matters incidental thereto as indicated in Scope of Work at clause 3.

2.2 The Act and the Rules

2.2.1 Applicants are encouraged to familiarize themselves with the Acts, the Rules, the directions issued by central Government, and other documents related with three Schemes mentioned at Clause-3.

2.3 Request for Proposals

2.3.1 The Ministry of Coal invites proposals from interested institutions (the "**Proposals**") for vetting of Central Sector Schemes of MoC and who shall provide the services to the Ministry of Coal as described in the Scope of Work in Clause 3.

2.3.2 Due diligence by Applicants

Applicants are encouraged to inform themselves fully about the Scope of Work and before submitting the Proposal by sending written queries only through email to Ministry of coal, and attending a Pre-Proposal Conference on the date and time specified in clause 2.6.

2.4 RFP Document &Validity

- 2.4.1 The RFP can be downloaded freely from the <u>official website of Ministry of Coal and through GeM portal</u>. The Proposal shall be valid for a period of not less than 90 days from the Proposal Due Date (the "PDD") i.e, date of opening of bid as defined at clause 5.4.
- 2.4.2 This RFP comprises the Disclaimer set forth hereinabove, the contents as listed below and will additionally include any Addendum / Amendment issued in accordance with Clause 4.10:

2.5 Brief Description of the Selection Process

- 2.5.1 Applicants will have to submit two separate envelopes- Envelope A containing the technical proposal and Envelope B containing financial proposal, respectively.
- 2.5.2 In the first stage, only Envelopes- A of all the applicants containing their technical proposals will be opened, and a technical evaluation will be carried out as specified in Clause 6.3.
- 2.5.3 Based on this technical evaluation, a merit list of short-listed applicants shall be prepared as specified in Clause 6.3.

2.5.4 In the second stage, Envelopes B of shortlisted Applicants (Clause 6.3.3) shall be opened and a financial evaluation will be done to identify the successful bidder on a lowest quote basis.

3 Scope of Work

- **3.1.1** The terms of reference for Central Sector Schemes for evaluation study for continuation beyond the year 2025-26 may be as follows: -
 - I. To assess the strengths and weaknesses of the schemes (details of the schemes to be provided by MoC): whether the set rules and procedures of planning, monitoring and evaluation, and administration need any review to meet the objectives of the schemes.
 - II. Provide recommendations as to how MoC can improve its Strategic Framework and Implementation Plan in the future.
 - III. Assess the performance of the schemes **since inception** and include the same as a separate section. This section should explicitly enumerate/ include the following:
 - a. Assessment of the need for continuation of Schemes beyond the 15th Finance Commission period from 2021-22 to 2025-26 to 16th Finance Commission period.
 - b. Evaluation of output-outcome indicator reports, which shall be provided by the Ministry (A sample copy of the output outcome report is at Annexure-A)
 - IV. Submission of draft reports and presentation of the same at MoC.
 - V. Submission of final evaluation report in a specific format (enclosed at Annexure-B) within 03 (three) months from the date of agreement and presentation of the same at MoC. The report should explicitly enumerate/include the following:

A. "Exploration and Detailed Drilling"

Regional exploration

- i. Block-wise status of exploration carried out (in terms of meterage) with central assistance, including completed, ongoing, and proposed blocks.
- ii. Block-wise expenditure incurred on exploration of blocks (including completed, ongoing, and proposed blocks).

- iii. Block-wise status of preparation of Geological Report (GR), cost of GR, and amount realized to GoI.
- iv. Study the existing methodology for estimation of GR preparation cost and suggest improvements.

B. Research and Development (R&D)

Evaluation of all R&D projects - completed and ongoing

- i. Objective, approved cost and period, amount incurred/released, and present status of all projects.
- ii. Outcomes of the completed projects.
- iii. Number of pilot projects carried out after successful completion of R&D projects, giving details of each such project.
- iv. Adoption/ application of the research outcome of such pilot projects in the field/ commercial utilization.
- v. IPR (Intellectual Property Right) filed, if any, including details thereof.
- vi. Suggestions for improving the R&D Scheme.

C. Conservation and Safety and Infrastructure Development in Coal Mines

Evaluation of this scheme needs to cover the following:

1. **Infrastructure development projects**: Project-wise evaluation of all completed and ongoing projects.

2. Safety:

- i. Year-wise and Mine-wise details of safety activities funded under the scheme since inception, and their evaluation.
- ii Suggestions for the inclusion of other safety-related activities in the Scheme

3. Jharia and Raniganj Master Plan under EMSC Scheme

- i. Year-wise work done by various agencies under the Master Plan of Jharia and Raniganj Coalfields, and its assessment
- ii. Suggestions for improving the implementation of the Master Plan for Jharia and Raniganj Coalfields with reference to the following aspects:
 - a. Dealing with Fire
 - b. Subsidence and rehabilitation
 - c. Diversion of surface infrastructure

4 Instructions to Applicants

4.1 General

- 4.1.1 Notwithstanding anything to the contrary contained in this RFP, in the event of a conflict, the relevant provisions of the Agreement shall have overriding effect.
- 4.1.2 Applicants are required to submit ₹ 1,60,000 (Rupees One Lakh Sixty Thousand Only) as Earnest Money Deposit (EMD) in the form of Demand Draft of any nationalized scheduled bank payable at Delhi and drawn in favour of Pay & Accounts officer, Ministry of Coal. EMD is to be submitted along with the Proposal. Save and except as provided in this RFP, the EMD of unsuccessful Applicants will be returned by Ministry of Coal, without any interest, as promptly as possible on issuance of Letter of Award to the Successful Applicant or when the selection process is cancelled by the Ministry of Coal. Centrally funded/ Government autonomous/apex Institutions are exempted from submission of EMD.
- 4.1.3 The Successful Applicant's EMD will be returned, without any interest, upon issuance of Letter of Award and furnishing of the Performance Guarantee in accordance with the provisions thereof. <u>However, EMD may be adjusted as part of performance Guarantee by the successful bidder.</u>
- 4.1.4 The EMD shall be forfeited as damages without prejudice to any other right or remedy that may be available to the Ministry of Coal under the RFP and/ or under the Agreement, or otherwise, under, *inter alia*, the following conditions:
 - a) If an Applicant engages in a Corrupt Practice, Fraudulent Practice, Coercive Practice, Undesirable Practice or Restrictive Practice as specified in the Agreement;
 - b) If an Applicant withdraws its Proposal during the period of Proposal Validity as specified in this RFP or as extended by mutual consent of the Applicant(s) and the Ministry of Coal;
 - c) In the case of Successful Applicant, if it fails to furnish the Performance Guarantee within the time limit prescribed in the letter of Award.
- 4.1.5 Detailed description of the objectives, scope of services, Deliverables and other requirements are specified in this RFP. In case an applicant possesses the requisite experience and capabilities, it may participate in the Selection Process in response to this invitation. The manner in which the Proposal is required to be submitted, evaluated and accepted is explained in this RFP. The Proposal and all communications in relation to or concerning the RFP and the Proposal are required to be in the English language.
- 4.1.6 The documents including this RFP and all attached documents, provided by the Ministry of Coal are and shall remain or become the properties of the Ministry of Coal and are transmitted to the Applicants solely for the purpose of preparation and the submission of a Proposal in accordance herewith. Applicants are required to treat all such information as strictly confidential and shall not use it for any purpose other than for preparation and submission of their Proposal. The provisions of this clause shall also apply *mutatis mutandis* to Proposal and

- all other documents submitted by the Applicants in relation to the Proposal, and the Ministry of Coal will not return to the Applicants any Proposal, document or any information provided along therewith.
- 4.1.7 Any award or Agreement pursuant to this RFP shall be subject to the terms hereof and any documents issued pursuant to the Act, the Rules, this RFP or any other document referred herein.
- 4.1.8 Applicants shall submit its Proposal in the form and manner specified in this Section of the RFP. All the bids i.e. technical and financial will only be received on GeM Portal. The Technical proposal shall be submitted in the form at Annexure-I and the Financial Proposal shall be submitted in the form at Annexure-II. Upon selection, the Applicant shall be required to enter into an Agreement with the Ministry of Coal.

4.2 Key Personnel

4.2.1 The Institutions shall have a dedicated team for the works mentioned in the Scope of Work (Clause 3) which shall consist of the following key personnel (the "Key Personnel") who shall discharge their respective responsibilities as specified below:

4.2.2 In addition to the aforesaid Key Personnel, the team working on these Schemes may be assisted by adequate number of support staff.

4.3 Conditions of Eligibility of Applicants

4.3.1 Applicants must read carefully the minimum conditions of eligibility (the "Conditions of Eligibility") provided herein. Proposals of only those Applicants

who satisfy the Conditions of Eligibility will be considered for evaluation.

- 4.3.2 To be eligible for evaluation of its Proposal, the Applicant shall fulfil the following:
 - a) The applicant should be a recognized academic and/or research institution engaged in geology/ mining subjects.
 - b) The applicant should have successfully completed at least 3 (three) R&D projects/ consultancy projects related to scope of work (Clause-3A and/or 3B and/or 3C) during last 3 (three) year period preceding the date of opening of tender (PDD).
 - c) Average Annual financial turnover of the applicant from consultancy/professional fee during the last 3 (three) financial years preceding PDD should be at least Rs. 6 (six) Lakhs.
 - d) The applicant shall have its team in place on the date of opening of tender in terms of Para-4.2.1.
- 4.3.3 In support of the above eligibility criteria, the Applicant shall enclose with its Proposal the following:
 - e) Documentary evidence in support of applicant being a recognized academic and/or research institution engaged in geology/mining subjects.
 - (i) Certificate(s) from its Statutory Auditors stating its turnover from consultancy/professional fee for the last 3 financial years preceding the PDD. In the event that the Applicant does not have a statutory auditor, it shall provide the requisite certificate(s) from the firm of Chartered Accountants that ordinarily audits the annual accounts of the Applicant;
 - (ii) Documentary evidences in regard to its eligibility in terms of Clause 4.3.2 (b).
 - (iii) Names of key personnel and details of their professional qualifications as specified in 4.2.1 and in the format at Annexure-I.
- 4.3.4 Any entity which has been barred by the Central Government, any State Government, a statutory authority or a public sector undertaking, as the case may be, from participating in any project, and the bar subsists as on the date of the Proposal, would not be eligible to participate.
- 4.3.5 An Applicant should have, during the last 3 years, neither failed to perform on any agreement, as evidenced by imposition of a penalty by an arbitral or judicial authority or a judicial pronouncement or arbitration award against the Applicant, nor been expelled from any project or agreement nor have had any agreement terminated for breach by such Applicant. The applicant shall mention the Ministry of Coal regarding any ongoing disputes pending before any authority relating to non-performance or breach of any agreement or expulsion from any project any project of the applicant or its associates in the letter comprising the Technical Proposal as per Annexure I.

4.3.6 While submitting a Proposal, the Applicant should attach clearly marked and referenced continuation sheets in the event that the space provided in the specified forms in the Appendices is insufficient. Alternatively, Applicants may format the specified forms making due provision for incorporation of the requested information.

4.4 Conflict of Interest

- 4.4.1 An Applicant shall not have a conflict of interest that may affect the Selection Process or the Services (the "Conflict of Interest"). Any Applicant found to have a Conflict of Interest shall be disqualified. In the event of disqualification, the Ministry of Coal shall forfeit and appropriate the Performance Guarantee, without prejudice to any other right or remedy that may be available to the Ministry of Coal hereunder or otherwise.
- 4.4.2 The Ministry of Coal requires that the Institution provides professional, objective, and impartial advice and at all times hold the Ministry of Coal's interests paramount, avoid conflicts with other assignments or its own interests, and act without any consideration for future work. The Institution should not have any ongoing assignment or shall not accept or engage in any assignment that would be in conflict with the schemes mentioned under the RFP or that may place it in a position of not being able to carry out the assignment in the best interests of the Ministry of Coal.
- 4.4.3 The institution shall give a declaration that it complies and shall continue to comply the provisions of Clause 4.4 during the execution of present assignment.
- 4.4.4 Decision of Ministry of Coal with regard to compliance or otherwise of this clause shall be final.

4.5 Number of Proposals

4.5.1 No Applicant shall submit more than one Application. An Applicant applying individually shall not be entitled to submit another application either individually or as an associate, as the case may be.

4.6 Cost of Submitting Proposal

4.6.1 The Applicants shall be responsible for all of the costs associated with the preparation of their Proposals and their participation in the Selection Process including visits to Ministry of Coal etc. The Ministry of coal will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Selection Process.

4.7 Acknowledgement by Applicant

4.7.1 It shall be deemed that by submitting the Proposal, the Applicant has:

- (i) made a complete and careful examination of the RFP;
- (ii) received all relevant information requested from the Ministry of coal;
- (iii) accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of the Ministry of Coal.
- (iv) satisfied itself about all matters, things and information necessary and required for submitting an informed Application and performance of all of its obligations thereunder;
- (v) acknowledged that it does not have a Conflict of Interest; and
- (vi) agreed to be bound by the undertaking provided by it under and in terms hereof.

4.8 Right to reject any or all Proposals

- 4.8.1 Notwithstanding anything contained in this RFP, the Ministry of Coal reserves the right to accept or reject any Proposal and to annul the Selection Process and reject all Proposals, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons therefor.
- 4.8.2 Without prejudice to the generality of Clause 4.8.1, the Ministry of Coal reserves the right to reject any Proposal if:
 - (i) at any time, a material misrepresentation is made or discovered, or
 - (ii) the Applicant does not provide, within the time specified by the Ministry of Coal, the supplemental information sought by the Ministry of Coal for evaluation of the Proposal.
- 4.8.3 Misrepresentation/ improper response by the Applicant may lead to the disqualification of the Applicant. If such disqualification / rejection occurs after the Proposals have been opened and the highest ranking Applicant gets disqualified / rejected, then the Ministry of Coal reserves the right to consider the next best Applicant as per Clause 7.3.2, or take any other measure as may be deemed fit in the sole discretion of the Ministry of Coal, including annulment of the Selection Process.

4.9 **Oueries and Clarifications**

- 4.9.1 Any queries or request for additional information concerning this RFP may be sent only by e-mail to the Ministry of Coal at hittar.singh85@nic.in/soccnt-moc@gov.in in the format specified in Annexure IV (Format for seeking clarifications regarding the RFP). The email should clearly bear the following subject line: "Queries/Request for Additional Information: For Selection of Institution for "Evaluation study of the Central Sector Schemes for their continuation beyond 2025-26"."
- 4.9.2 Each query should contain complete details of facts, information and Applicable Law germane to the query and also the particulars of the person posing the query. The Ministry of Coal reserves the right to not answer any query, including

- any query which is incomplete or anonymous.
- 4.9.3 The queries should be emailed to the address mentioned at Clause-2.7.1 in .doc, .docx, .xls, .xlsx format, on or before 4 PM on the date specified in Clause 2.6 for receiving queries.
- 4.9.4 The Ministry of Coal reserves the right not to respond to any question or provide any clarification, in its sole discretion, and nothing in this Clause 4.9 shall be taken or read as compelling or requiring the Ministry of Coal to respond to any question or to provide any clarification. The Ministry of Coal may publish the queries and its responses thereto on the website of Ministry of Coal, without identifying the source of queries.
- 4.9.5 The Ministry of Coal may also on its own motion, if deemed necessary, issue interpretations and clarifications to all Applicants. All clarifications and interpretations issued by the Ministry of Coal shall be deemed to be part of the RFP. Provided however that, any non-written clarifications and information provided by the Ministry of Coal, its employees or representatives in any manner whatsoever shall not in any way or manner be binding on the Ministry of Coal.
- 4.9.6 The Ministry of Coal shall not entertain any query or clarification from Applicants who fail to meet the Eligibility Condition mentioned at Para-4.3.2 (a).
- 4.9.7 Save and except as provided in this RFP, the Ministry of Coal shall not entertain any correspondence with any Applicant in relation to acceptance or rejection of any proposal.

4.10 Amendment of RFP

- 4.10.1 At any time prior to the deadline for submission of Proposal, the Ministry of Coal may, for any reason, whether at its own initiative or in response to clarifications requested by an Applicant, modify the RFP document by the issuance of Addendum/ Amendment and posting it on the Website of Ministry of Coal and by conveying the same to the prospective Applicants (who have purchased the RFP document) by e-mail.
- 4.10.2 The amendments will also be posted on the Website of Ministry of Coal along with the revised RFP containing the amendments and will be binding on all Applicants.
- 4.10.3 The Authority may, in its sole discretion, extend the PDD.

5 Preparation and Submission of Proposal

5.1 Two Bid submission

- 5.1.1 The Applicant shall provide all the information sought under this RFP. The Authority would evaluate only those Proposals that are received in the specified forms and complete in all respects.
 - **5.1.2 Technical and Financial Bids** can only be submitted on GeM portal as per schedule at Para-2.6.1. No other mode of bid submission will be accepted/entertained.

5.2 Technical Bid/Proposal

5.2.1 Applicants shall submit the technical proposal in the formats at Annexure-I (the

"Technical Proposal").

- 5.2.2 While submitting the Technical Proposal, the Applicant shall, in particular, ensure that:
 - i) EMD is enclosed. Centrally funded/ Government autonomous/apex Institutions are exempted from submission of EMD.
 - ii) All forms are submitted in the prescribed formats and signed by the prescribed signatories;
 - iii) Authorization letter from the head of the Institution;
 - iv) All documents mentioned at Para-4.3 in support of eligibility.
 - v) CVs of all Key Personnel have been included
 - vi) the CVs have been recently signed and dated, in blue ink by the respective Personnel and countersigned by the Applicant. Photocopy or unsigned / countersigned CVs shall be rejected;
- 5.2.3 Failure to comply with the requirements spelt out in this clause 5.2 shall make the Proposal liable to be rejected.
- 5.2.4 If an individual Key Personnel makes a false averment regarding his qualification, experience or other particulars, the Applicant shall be liable to be debarred for any future assignment of the Ministry of Coal for a period of 3 (three) years. The award of this Consultancy to the Applicant may also be liable to cancellation in such an event.
- 5.2.5 The Technical Proposal shall not include any financial information relating to the Financial Proposal.

- 5.2.6 The Ministry of Coal reserves the right to verify all statements, information and documents, submitted by the Applicant in response to the RFP. Any such verification or the lack of such verification by the Authority to undertake such verification shall not relieve the Applicant of its obligations or liabilities hereunder nor will it affect any rights of the Authority thereunder.
- 5.2.7 In case it is found during the evaluation or at any time before signing of the Agreement or after its execution and during the period of subsistence thereof, that one or more of the eligibility conditions have not been met by the Applicant or the Applicant has made material misrepresentation or has given any materially incorrect or false information, the Applicant shall be disqualified forthwith if not yet appointed as the Institution either by issue of the LOA or entering into of the Agreement, and if the Selected Applicant has already been issued the LOA or has entered into the Agreement, as the case may be, the same shall, notwithstanding anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing by the Ministry of Coal without the Ministry of Coal being liable in any manner whatsoever to the Selected Applicant or Institution, as the case may be. In such an event, the Ministry of Coal shall forfeit the Performance Guarantee, without prejudice to any other right or remedy that may be available to the Ministry of Coal.

5.3 Financial Proposal

- 5.3.1 Applicants shall submit the financial proposal in the format at Annexure -II (the "Financial Proposal") clearly indicating the total cost of the proposal in both figures and words, in Indian Rupees, and signed by the Applicant's Authorised Representative. The applicant shall bid on per scheme basis. In the event of any difference between figures and words, the amount indicated in words shall prevail.
- 5.3.2 While submitting the Financial Proposal, the Applicant shall ensure the following:
 - a) All the cost associated with the tendered job shall be included in the Financial Proposal. The amount indicated in the Financial Proposal shall be without any condition attached or subject to any assumption, and shall be final and binding. In case any assumption or condition is indicated in the Financial Proposal, it shall be considered non-eligible and liable to be rejected.
 - b) The Financial Proposal shall take into account all expenses relating to the Scope of Work. For the avoidance of doubt, it is clarified that Financial Proposal shall be excluding GST. Further, all payments shall be subject to deduction of taxes at source as per Applicable Laws.
 - c) Costs shall be expressed in INR.

5.4 Proposal Due Date (PDD) and Extension

- 5.4.1 The proposals should be submitted before Proposal Due Date (PDD).
- 5.4.2 The Ministry of Coal may, in its sole discretion, extend the Proposal Due Date by

issuing an Addendum and/or Corrigendum in accordance with clause 4.10 uniformly accessible for all Applicants.

5.5 Late Proposals

5.5.1 Proposals received by the Ministry of Coal after the specified time (Clause 2.6.1) shall not be eligible for consideration and shall be summarily rejected.

5.6 Modification/ substitution/ withdrawal of Proposals

- 5.6.1 Modification/substitution/ withdrawal of Proposals will be as per the terms and condition of GeM portal.
- 5.6.2 Any alteration / modification in the Proposal or additional information or material supplied subsequent to the PDD, unless the same has been expressly sought for by the Ministry of Coal, shall be disregarded.

5.7 Performance Guarantee

5.7.1 An amount equal to 05% (Five per cent) of the financial proposal of the selected Institution shall be the Performance Guarantee, which may be forfeited by the Ministry of Coal in accordance with the provisions of the Agreement.

6 Evaluation Process

6.1 Evaluation of Proposals

- 6.1.1 The Committee constituted for the purpose shall open the Proposals at stipulated time mentioned on the PDD (clause 2.6.1), in the office of <u>Under Secretary, CCNT, Ministry of Coal, Shastri Bhawan, Dr. Rajendra Prasad Road, New Delhi 110001</u> and in the presence of the Applicants who choose to attend. The "Technical Proposal" shall be opened first. The "Financial Proposal" shall be opened at a later date.
- 6.1.2 The Ministry of Coal reserves the right to reject any Proposal which is not eligible and no request for alteration, modification, substitution or withdrawal shall be entertained by the Ministry of Coal in respect of such Proposals.
- 6.1.3 Selection shall be entirely at the discretion of the Ministry of Coal. Applicants shall be deemed to have understood and agreed that the Ministry of Coal shall not be required to provide any explanation or justification in respect of any aspect of the Selection Process or Selection.
- 6.1.4 Any information contained in the Proposal shall not in any way be construed as

binding on the Ministry of Coal, its agents, successors or assigns, but shall be binding against the Applicant if the Consultancy is subsequently awarded to it.

6.2 Clarifications

- 6.2.1 To facilitate evaluation of Proposals, the Ministry of Coal may, at its sole discretion, seek clarifications from any Applicant regarding its Proposal. Such clarification(s) shall be provided within the time specified by the Ministry of Coal for this purpose. Any request for clarification(s) and all clarification(s) in response thereto shall be in writing.
- 6.2.2 If an Applicant does not provide clarifications sought under clause 6.2 above within the specified time, its Proposal shall be liable to be rejected. In case the Proposal is not rejected, the Ministry of Coal may proceed to evaluate the Proposal by construing the particulars requiring clarification to the best of its understanding, and the Applicant shall be barred from subsequently questioning such interpretation of the Ministry of Coal.

6.3 Evaluation of Technical Proposals

- 6.3.1 In the first stage, the Technical Proposal will be evaluated based on the eligibility conditions as specified in clause 4.3. A Proposal shall be considered eligible only if it meets the eligibility conditions as specified in Clause-4.3 and all details as required in Clause-5.2.2 are submitted.
- 6.3.2 Based on the credentials submitted by the applicants, following scoring criteria shall be adopted for technical evaluation:

- 6.3.3 After the technical evaluation and assigning of marks, as above, the Ministry of Coal shall prepare a merit list of technically qualified applicants. Financial bids of Applicants having score of 60 and above in technical evaluation shall be opened for financial evaluation.
- 6.3.4 Date and time of opening of financial proposal shall be communicated to the shortlisted bidders.
- 6.3.5 The Ministry of Coal will not entertain any query or clarification from Applicants who fail to qualify at any stage of the Selection Process.

6.4 Evaluation of Financial Proposal

- 6.4.1 In the second stage, the financial evaluation will be carried out as per this clause. The opening of Financial Proposals shall be done in presence of respective representatives of Applicants who choose to be present. The Financial Proposal of only shortlisted Applicants, as per Clause 6.3.3 above, shall be opened.
- 6.4.2 The Ministry of Coal will determine whether the Financial Proposals are complete, qualified and unconditional. The cost indicated in the Financial Proposal shall be deemed as final and reflecting the total cost of services. Omissions, if any, in costing any item shall not entitle the Institution to be compensated and the liability to fulfill its obligations as per the TOR within the total quoted price shall be that of the Institution.
- 6.4.3 The applicants shall necessarily bid for each scheme mentioned in Clause 3A, 3B and 3C, failing which the bid shall be rejected.
- 6.4.5 For financial evaluation, total sum of the bids for the 3 schemes shall be considered and the Lowest Financial Proposal (L1) shall be selected for award of the contract.
- 6.4.5 It is clarified that the individual bid quoted for each scheme shall be considered only for the purposes of determining the fee amount to be released in terms of Clause 7.4.3.

7 Appointment of Institution

7.1 Letter of Award

- 7.1.1 After selection, a Letter of Award (the "LOA") shall be issued, in duplicate, by the Ministry of Coal to the Selected Applicant along with demand for submission of amount pertaining to Performance Guarantee. The Selected Applicant shall, within seven (07) days of the receipt of the LOA:
 - a. Sign and return the duplicate copy of the LOA in acknowledgement thereof
 - b. Deposit the Performance guarantee. The successful bidder may adjust the EMD amount as part of performance guarantee.
- 7.1.2 In the event of failure to do the above within the stipulated date, the Ministry of

Coal may, unless it consents to extension of time for submission thereof, cancel the LOA and forfeit the EMD.

7.2 Execution of Agreement

7.2.1 Within 3 days after acknowledgement of the LOA and submission of Performance guarantee as aforesaid by the Selected Applicant, it shall execute the Agreement providing the terms and conditions of engagement of the Institution in the format as may be specified by Ministry of Coal. The Selected Applicant shall not be entitled to seek any deviation in the Agreement. The terms and conditions of the Agreement shall be binding on the Institution.

7.3 Commencement of Services

- 7.3.1 The Institution shall commence the Services within seven days of the date of the Agreement, or such other date as may be specified by the Ministry of Coal. If the Institution fails to either sign the Agreement as specified in clause 7.2 or commence the assignment as specified herein, the LOA or the Agreement, as the case may be, may be cancelled /terminated along with forfeiture of EMD/Performance Guarantee.
- 7.3.2 Thereafter, Ministry of Coal may counter offer the job to the second ranked Applicant on L1 price. If the second ranked applicant agrees, the entire procedure of Clause-7.1, 7.2 and 7.3 shall be followed.

7.4 Fee for providing Services to the Institution

- 7.4.1 The Goods and Services Tax as applicable shall be payable by the Ministry of Coal / Central Government on the total fee. Remaining all other taxes shall have to be borne by the Institution.
- 7.4.2 TDS as applicable shall be deducted on gross amount of the fee as per rules.
- 7.4.3 The fee shall be released as per following schedule (in pursuance to Clause 3.1.1):

7.4.4 Non-adherence of intermediate timelines (as specified above in Clause 7.4.4) will lead to forfeiture of Performance Guarantee unless such delay is not due to the fault of selected applicant and the same is accepted by the Competent Authority. However, the completion time for the awarded job in any case shall remain firm i.e. 3 (three) months from the date of agreement.

7.5 Proprietary data

7.5.1 Subject to the provisions of this RFP, all documents and other information provided by the Ministry of Coal or submitted by an Applicant to the Ministry of Coal shall remain or become the property of the Ministry of Coal. Applicants and the Institution, as the case may be, are to treat all information as strictly confidential. The Ministry of Coal will not return any Proposal or any information related thereto. All information collected, analysed, processed or in whatever manner provided by the Institution to the Ministry of Coal in relation to the Consultancy shall be the property of the Ministry of Coal.

5.1 Thematic assessment should focus on Accountability, Transparency, Employment generation (direct / indirect), Climate change and sustainability, Role of TSP (Tribal Sub-Plan)/ SCSP (Scheduled Caste Sub Plan), Use of IT, Behavioral change in stakeholder/beneficiary, R&D, Role, functions, involvement / support of State govts.

Cross cutting themes can be assessed both through secondary data as well as primary. While conducting meta-analysis of existing reports, the evaluator should actively review the crosscutting themes. The primary data for cross cutting themes will be elicited through specific questions and responses during the key informant interviews and beneficiary surveys.
