**Minutes of Meeting taken by Secretary (Coal) to review activities for
Special Campaign 5.0 on 1st October, 2025**

The review meeting for Special Campaign 5.0 was convened on 1st October 2025 at 12:00 PM under the Chairmanship of the Secretary (Coal). The meeting was attended by CMDs of CPSEs, CCO & CMPFO, along with Senior Officers and Nodal Officers for SC 5.0 (list of participants enclosed).

2. Agenda items discussed during the meeting are as under:

1. Review of targets for Special Campaign 5.0
2. Comparison of achievements of Special Campaign 4.0 against the targets set for SC 5.0
3. Discussion on the Daily Activity Schedule
4. Review of various formats for SC 5.0
5. Exploration of new ideas and initiatives for SC 5.0

3. A detailed presentation (**copy enclosed**) covering the agenda points was made, following which the following directives were issued:

- i. All CPSEs, CCO, and CMPFO were advised to maximise scrap disposal, as current target is lagging behind the achievements of the previous year for some of the subsidiaries.
- ii. CPSEs, CCO, and CMPFO should share best practices from their respective domains by 20.10.2025.
- iii. New ideas and initiatives for implementation during SC 5.0 should be actively explored and submitted to the Ministry of Coal for consideration.
- iv. High-quality photographic documentation (before and after images from the same location, angle, and geo-coordinates) is to be shared by all CPSEs, CCO, and CMPFO in the designated drive.
- v. All Nodal Officers must ensure strict compliance with directives issued by the Cabinet Secretary, DARPG, and Ministry of Coal, to ensure successful implementation of Special Campaign 5.0.
- vi. All CPSEs, CCO, and CMPFO to update the completed daily activities during the Preparatory and Implementation Phases of SC 5.0 in the daily schedule spreadsheet, marking them in green within the shared drive.

4. Secretary (Coal) emphasized the importance of the campaign and urged all participants to actively engage and contribute to the successful execution of Special Campaign 5.0 and secure a higher rank this year.

The meeting ended with vote of Thanks to the Chair.

- Adhere to record management systems as contained in CSMOP, GFR and Public Record Act 1993.
- Ensure overall cleanliness of government offices with special focus on space management.
- Assess the volume of redundant materials to be disposed and dispose them.

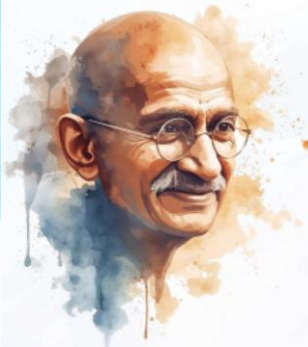



(2) No Court shall take cognizance of any offence punishable under subsection (1) except on a report in writing of the facts constituting such offence made by an Inspector with the previous sanction of such authority as may be specified in this behalf by the Central Government. (3) No Court inferior to that of a Presidency Magistrate or a Magistrate of the first class shall try any offence punishable under sub-section (1). **The present CMPF Act is being amended and the corresponding provision is decriminalised. Only after repeated contravention deterrent punishment is proposed.
