Work on remaining portion is progressing but delayed due to protests from villagers demanding higher compensation and formal recognition of Raiyati status for encroachers.</li> <li>CCL informed that issue regarding illegal structures has been resolved in 4 out of 7 villages and for the balance 3 villages, measurements have been taken but not being signed by structure owners who are claiming for compensation of the land also.</li> <li>CCL has paid 95% of the total compensation for Raiyati land and 5% balance is in respect of 19.95 acres of land where local villagers are demanding compensation for land.</li> <li>Work is not progressing in a stretch of 2.29 km affecting two block sections (Pathalgada-Ichak Khurd-Simaria)</li> <li>Additional Secretary (Coal) advised all agencies to closely coordinate to resolve issues of land acquisition, compensation and tendering.</li> </ul>
